THERE ARE INDICATIONS THAT EXCELLENT EXPLOITATION MOST AREAS HAVING BENEFICIAL EFFECT IN THAT HIGH INTEREST CREATED AMONG PEOPLE IS ENCOURAGING AND/OR CAUSING SOME GOVERNMENTS ADOPT STRONG PRO VENEZUELA POSITION IN OAS. VIEW THIS, SUGGEST ADDER ACTIVITIES CONCENTRATE PRIMARILY (BUT NOT EXCLUSIVELY) THIS ASPECT, I.E. EFFORTS DEMONSTRATE TO LOCAL GOVERNMENTS THAT PUBLIC OPINION IS IN FAVOR VENEZUELAN POSITION OF TAKING FIRM STAND AGAINST CASTRO. EMPHASIZE THAT CURRENT ISSUE BEFORE OAS RAISED BY SISTER REPUBLIC, VICTIM OF SOVIET AND CHICOM SUPPORTED AGGRESSOR; IMPLICATION BEING THAT ODYCKE PLAYING NO MORE THAN SUPPORTING ROLE.

2. CONTINUE USE "NO COEXISTENCE WITH CASTRO" THEME. CONSIDER HAVING LABOR, STUDENT, OTHER ORGS SEND TELEGRAMS TO LOCAL GOVTS AND OAS IN SUPPORT VENEZ POSITION: FOLLOW UP BY PUBLICIZING TELEGRAMS IN PRESS. VIA MEDIA SPECULATE WHAT STEPS LOCAL GOVT MIGHT FAVOR IN SUPPORT VENEZ, INCLUDING
