1. SENSITIVE SYMPATHIZER SOURCE INDICATES THAT ON 3 OCTOBER WILLEM OLTMANS MADE APPOINTMENT MEET WITH CUBAN AMBASSADOR, THE HAGUE. OLTMANS STATED HE GOING "TO AMERICA ON 18TH" AND THAT HE " IS INDEED PREPARED TO GO AT THE BEGINNING OF NOVEMBER AS ARRANGED".

2. DURING DISCUSSION, OLTMANS SAID HE ALSO HAD VISIT SCHEDULED WITH RUSSIAN AMBASSADOR ROMANOV FOR 3 OCTOBER AND WANTED COMBINE TWO VISITS FOR SAME DAY. OLTMANS WAS TOLD AN ATTEMPT BY CUBAN AMBASSADOR TO SCHEDULE MEET WITH HIM DURING WEEK 25 SEPTEMBER HAD BEEN UNSUCCESSFUL BECAUSE OLTMANS COULD NOT BE REACHED. OLTMANS STATED HE HAD BEEN IN SOVIET UNION THEN.

3. ABOVE EVIDENCE OF OLTMAN'S CONTINUING CLOSE CONTACT WITH CUEAN AND SOVIET DIPLOMATS AND HIS RECENT TRAVEL TO THE USSR AND APPARENT CURRENT TRAVEL TO CUBA
