- c. Further leguiries in Mexico by our efficials there revealed that Micoian DAMASCUS had been present to leave Mexico in October 1966 solely because of the expiration of his tourist card, which had been once extended. A oxican Records fail to show that he returned to Mexico, ellewing his entry toto the United States at Brownsville, Texas, Irom Matamoras, Tamasilpas on 24 October 1960. Upon arrival in Mexico on 22 June 1960, he indicated that the purpose of his visit was to attend the wedding of his sister, Asstante, Identified in proceding paragraph, bowever, as of 21 Jess 1961, there was so record of Assatasie DALLALCUS aka DAMASCUU is official Mexican Files, and there was as you so identification of the individual she was alleged to have been acheduled to marry. From the same source it was learned that for the period 22 June through 6 september 1760, the caly address itsied in official indices for Nicelas DaldASCUS is c/c Justo SLERRA, Reforms 95-407, Leance City, which is the law office maintained by Justo MERRA Casasua, former Connector of the Maxison Embassy in Washington, D.C., and who to further identified in the decuments cited in paragraph 1. c. through h. above. Investigation efforts abroad by this Agency are continuing, however, and any further information developed will be forwarded as soon as available.

In light of the escape route used by the two NSA defectors, transitting Mexico and presumably Cube enroute to he USSH, your particular situation is invited to the information concerning the contacts and views of Justo SIERAA Casesse furnished in the reports cited in paragraph i. e., f., and g. above. It is noted Justo blank Cassage Le identical with the senor Des Justo SILRAA. First Secretary at the Embessy of Mexico, mentioned in Bereau Reports cited in paragraph h. above as a contact of Boris A. BAZANISEV, First Secretary of the Seviet Embassy in Washington from 1952-54. It is further noted that Boris KAZANTSEV, after returning to Messow in 1934 and ossuming the post of First Secretary is the Latin American Division of the USSR Ministry of Foreign Affairs, was next assigned from 1955 to 1957 as First Secretary and subsequently Counselor of the Soviet Embassy is Montes City, and that as of 1760 be was assigned to the Seviet Embassy in Havana, Cuba, in the position of Counselor, departing Havana for bierice, in company of his wife and daughter, on 10 Jene 1761, and then proceeding to Canada on 2 July 1961.

Since the writing of our memorandum of 14 June 1961, (cf. para 1.a. above), the following applementary information has been developed concerning Nicolae Georges DAMASCUS aka DAMASCUS, who is a contest and client of Justo sikith Casassa, mentioned in the communications referenced in paragraphs 1. c. through h. above.
- a. Piceles Georges DAMASCUS reportedly is difficially listed in Egypt ender the name of Nicoles George DAMASCOU, bern 18 March 1711 at Alexandria, the end of George DAMASCOU and Angelika DAMASCOU nee EAVOURAS. He is a Greek national and helds Greek citisenship. From 1947 through 1917, he resided at 57 Metropolis Street in Alexandria. Mappenentatives of this Agency in Alexandria advise that local available records immicate that as of May 1959. Picca, Elizabeth Day, Sydney, Australia, and that he listed his occupation as that of Clork. Our field records indicate that as of May 1959, the United States Constitute in Eydney had some interest in him, and it is suggested that the indices of the Department of States may contain further information concerning this individual.
- b. Assetsie (or Azastasia) George DatichCUS aka
 DAMASCU, eleter of Nicolas DatichCUS, above, was born march 1933,
 place of birth not indicated but presumably Egypt, was identified by figure
 representatives in Alexandria has baving filed application for a United
 States Visa at London, England in July 1956, listing her occupation as

4. The records of this Agency indicate that Boris A. EAZANTSEV is a known Soviet Intelligence Officer, most probably representing Soviet State Security (ECB).
