AMASR/I - Paris Station Aspest

Paris Station involvement with the AMLASH case began in 1962, after AMLASH/1 came to Paris after attending the Helsinki Youth Festival that year. In Helsinki, AMASH/1 was contacted by UNRUSELE/2 (an asset of the Paris Station who attended the Fostival for purposes of disruption) and by other KUBARK assets. It is not clear from our files just when AMASH/I was "restraited" but it appears that he was recruited during or shortly after the Pestival.

In Paris he was in contest with Pater J. KYMINOHAM (probably in alias although I know that AMLASK/I was at KYMINCHAN'S home upon occasion). In 1962 AMLASK/I was given training in explosives by OMMM (I believe) upon request of the Faris Station. He appears to have returned to PERCENT in late 1962. It is not known if other Paris Station personned were in contact with AMASH'I during that period.

AMEASE/I ment arrived in Paris on th September 1963, coming from the Internal tional Games held in Prorto Alegro, Brazil, where he was in contact with TYPIC officers. At this point AMERCAT/1 (now QUEFORT) was in contact with AMLASH/1 in Poris and AMMEP/1 was another come channel (the cas being used principly by Aqs.). The Esalquarters TIPIC officer, ONTRICE (P), arrived in Paris on 3 October 1963 and picked up the contact with amage/I which was being maintained by amproxi/I and axellement. The meetings with AMASKI took place in NYELENEE home as best I remember. These discussions concerned ANLISH/I's plane to assissinate ANTEW and overthrow his regime.

OSTRICE returned to Paris In late October, after discussions at Headquarters on the case. ONTHICH and DAIRNED, who sees thy in Paris at the time, not with AMLASRA in late October or early November. DayMDD's participation was due to AMASE/1 strong - desire to talk with some high-level COTOEE official concerning his plane and to obtain ODME blessing if possible. I as not essen of exactly what happened at these mostings but I received the impression from KIMINHAH that such bleesing was given. MASI/1 returned to PSENEN on 27 Hovember 1969. AMASE/1 next arrived in Paris in late Movember or early December 1964. AM/HIP/1 STOCKHOOD and OMTRICE (tdy from Hoadquarters) and with him in Paris (this time in a safe house of the Station. AMASE/1 left for PERURER from Madrid on 20 February 1965. During this stay in Paris AMASE/1 met the following KUBARE staffers and agents:

Tou will recall that in December 1964 UNINITY'S had a narrows breakdown and AFLASH'I played an important part in convincing UNINITY'S that he should agree to beepitelization. It was in this commotion that CLOADEN and RODAMN met AFLASH'I. CLOADEN subsequently met with AFLASH'I two or three times to received reports for STOCENOOD. These meetings were shreet meetings or in the home of UNINITY'S. During this stay, AFLASH'I traveled to Madrid at least once to meet with AFRICHT'I and AFRANC'I. I am not every of results of these meetings except that AFLASH'I was seeking the physical improvements to carry out his plan to climinate AFIRM.

There was me additional contest with AMASH/I in Paris subsequent to February 1965 but the Station (GLOAINE and MIRLES) did have subsequent contact with USSMPU/5, UNSHAFU/9, AMASH/8 and AMASH/3. You will recall the vit was AMASH/3 who under the "joking" pitch to MIRLES on 6 May 1965. AMASH/2 and MELSH/3 were both source of AMASH/1 plane.
