## CONTACT REPORT

SUBJECT: Recontact of Oliverio A. TONEY Vassilo. (201-283204)

- 1. At 1730 bours, & June 64, the undersigned was advised at his residence that a Mr. TUMEU (Subject) had called the security number given him (351-6161) and left the message that he would like to talk again with Paul Stroud (the undersigned) anytime after 1800 hours, & June.
- 2. Upon arriving at TOMEU's spartment (Apt. 303, 1028 Wahler Place SE, High Point Apartment House, Sashington, D. C.), 1830 hours, 8 June, TOMEU indicated to his two daughters he would like to have some privacy and they and his wife, Caridad, left the spartment.
- 3. TOMES apologized for not having received the name "de VARONA" as that of Ans Gloria de VARONA. He reiterated that, while is hiding to escape capture by the Cuban Government embesquent to his infiltration, he knew only the first names of the persons with whom he came is contact, but then added he knew Ama Gloria de VARONA, is whose house he was hiding, because she was the sister of Carlos de VARONA, one of his infiltration team members. (This Carlos de VARONA may be identical with one Carlos Ended de VARONA may be identical with one Carlos Ended de VARONA Regura, 201-289985; or one Carlos Arturo MARONA Arjona, 201-283209.)
- 4. On several occazione, according to TOMEU, he was scated at the table in Ann's bouse with several other people. One of these individuals, known to TOMEU only as "COCO," was described as the secretary to Jose LLARUKA Gobel. There was not, however, any discussions in which TOMEU recalls LLARUKA or his political sympathies having been discussed. According to TOMEU's recollection it was "COCO" who was associated with LLARUKA, and he was not sware of any relationship between Alexand LLARUKA, and he was not sware of any relationship between Alexand LLARUKA. Although TOMEU had no information as to what finally happened to Caplos de VARONA, his infiltration teem mate, he suggested that if Caplos of Ann were available they may be able to identify "COCC" and provide data on his accessability for contact.

Enelides from automotical Conservation and Sectionalities who would know LLANUTA. TORKU affirmed Osiel was previously with MEBUYO Gutierrez in the Second Front of Escambray. Osiel was under asylum in the Brazilian kmbsasy (sic, Argentine Enbassy?), when TOMEU grined political asylum. When Osiel finally received his safe conduct from the Embassy, he went to Puerto Rico and, TOMEU postulates that Osiel is now again with MEMOTO in either the United States or Puerto Rico.

- G. Two snap shots (to be returned) were provided by TOMIU of himself and six other individuals who were in asylumat the same time. He identified these, in the photograph in which Monsignor Eduardo DOZA Masvidal is seated, as, from left to right: (Manuel VILLAMANAN, Oliverio TOMEU, Wils DIAZ (believed to be in US), Public RUIZ (US), Jorge Del VALLE (Mex?), and Quiel GONZALEZ (US or Puerto Rico?).
- 7. Upon completing the debriefing, Strond and TOMEU "exchanged small talk" for a while until TOMEU finally stated that he still wished there was something more he could do to help free Cuba, and asked "What do you think I should do?" Strond replied that no person could really make that type of decision for another individual, and countered by asking TOMEU what alternatives he had in mind, other than remaining in the VS Army as a career military officer.
- TOWEU replied that, of course, he was once an agriculturalist, but that there were few job opportunities in which be could apply his past experience. His sister had also asked him if he felt he and his family would want to live with her in Spain or Mexico, but he didn't think too much of this idea. He then stated that he had been asked by Manuel ARTIME to take a job as an instructor. Without indicating any association of even awareness of ARTIME's activities, or of ARTIME's contact with TOMEU (as indicated in TOMEU's 201), TOSIEU was asked what he thought of ARTIME's proposition. TONEY stated that he would no longer follow any man as an individual or as a leader, because a man's ideals, outlook, and objectives change with time. For example, the people of Cuba followed Fidel because of the ideals he advocated. When **Fidel** took over, his accomplishments gradually became quitur different from the ideals he had espoused. TOMEU continued by saying he would "no longer follow a man, One could only trust his ideals or an organization which followed those ideals, since a good organization would be less likely of being controlled by a single man." When saked for an example of the type of organization he had in mind, TOMBU replied he was most favorably inclined towards the ideals and goals of the JURE. (The JURE or JRC is an organization greated by Manolo RAY Rivero around a nucleus of former 26 July Movement leaders. It should, perhaps, be noted here that in an informal exchange with Mrs. Donald WEBSTER, TOMEU's supervisor at the Defense Language Institute, Anacostiz Haval Annex, 4 June 64, Mrs. WEBSTER volunteered the information that "all of the other 'Brigade students here' have told me they think very highly of TOMEU, and that he is a very brave man, because he and his family were very wealthy in Cuba and he gave it all up to go into exile and light the Castro Regime."
