AS OF MARCH 66 SUBJ WAS REPORTED TO HAVE TWO CHILDREN (SEX UNKNOWN) BY HIS WIFE DAISY (LNU). HOWEVER NOTE DAISY IS ENGLISH TRANSLATION OF FLOWER "MARGARITA", SO WAS POSSIBLY NICKNAME OF MARGARITA ARENAL.
