in Santiago. Sturgis was in touch w/ Jim
Wooler

(Jack Stewart, ^{possibly} Jim Knowles) were in
Havana.

Has info re Miami people, possibly incl.
some Cubans & Americans & poss incl. some
people of past CIA contact, are planning to
go to Venezuela and to assass. Henry Kissinger &
the Pres. of Venez. on Kissinger's forthcoming trip there.
Dr. de Cardenas - Latin Am. Anti Comm.
League may be involved.
