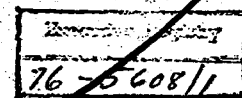

1. This proposes a course of action to undertake with the Select Committee.

2. Discussion

a. In looking to the road ahead, which may well eventually prove bumpy for reasons beyond our control, it is absolutely imperative that we fortify ourselves with the Committee so that they have the most positive attitude towards our desire to be cooperative. The simplest way to do this is to put ourselves in their shoes, anticipating what we can do for them to ease their work.

b. Whatever merits there are to a passive course (waiting for specific requests), it is much less likely to create the positive attitude which can be of such significance in the long run.

c. Although we can't anticipate the Committee's complete line of inquiry, certain lines can be, and if we do, and facilitate their work as a result, we will have earned their respect and proved our willingness to cooperate. More importantly, we will have created a climate conducive to their objective viewing of problems which will eventually arise. Finally, and practically, any other approach will only feed their apprehension over our real willingness to cooperate.



It is requested that the Working Group established under the chairmanship of Scott Breckinridge, Deputy Inspector General, seek to satisfy on an expeditious basis the requirement set forth in paragraph 3 above.

From 3: While we should try to be forward leaning, it is realistic to expect that we will probably be largely reactive. For instance, a briefing that may anticipate interests incorrectly could be injurious and not helpful; our offer should be to provide a briefing that meets their perceived initial requirements for an introduction. We will design it to their specifications.

The OLC should also press for management arrangements essential to making things go smoothly. Space and people should be arranged on a priority basis; registry, reading room, administrative space. Space should be arranged for the House investigators to read the files as occurred with the Senate.



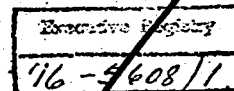


