Dear Mr. Weberman:

This is in response to your requests set forth in your letters, dated 21 August 1977 and 5 September 1977, as well as one which is undated, but postmarked 29 September 1977 and received on 11 October 1977 in this office.

Enclosed, Tab A, please ^(per your request) find a copy of segregable portions of a purchase order for a copy of your book, Soup D'Etat In America. The only deletion involved was an internal Agency marking which was excised under the exemption provisions of subsection (b)(3) of the Freedom of Information Act. The applicability of that exemption was explained to you in our earlier correspondence. The book, together with an index card, are in the Historical Intelligence Collection ^{section} of the CIA Library. Please note that these items hardly qualify as "records" within the purview of the Freedom of Information ~~Act~~ Act. The above determination was made by Mr. Harry C. Eisenbeiss, Director of Central Reference Service.

Enclosed also, Tab B, is a copy of Document No. 997-930. It is a duplicate of Document No. 733-316-A which had previously been released to you with certain portions deleted. The deleted sections in both documents are withheld on the basis of exemptions (b)(1), (b)(2) and (b)(3) of the Freedom of Information Act, ~~section~~. The applicability of these exemptions has also been explained to you in previous correspondence.

As you are aware, Document No. 6-3 was disseminated on 10 October 1963 only to the Department of State, the Federal Bureau of Investigation and the Department of Navy. Document 6-3 represents the Agency record of the electrical dissemination which was made to the above agencies on the above date.

~~Regarding your repeated request for a copy of a glossy photo of Lydmullia~~
~~Prusakova, we should refer you to our letter of 25 July 1977 wherein we advised~~
~~you that we have no copies of photos of Lydmullia Frussakova, so identified,~~
in the files which have been reviewed. If you have received a xerox photo
of her from this Agency, please send us the number of this document in order
that we might determine, or at least try to determine, the cause of ~~your~~ ^{your} con-
fusion.

Concerning your query about "DBF 25 May 1960", we can only advise you that
xxxx DBF's included in the Index we compiled also include our own Document No.
~~xxxxxx as well as the DBF No. Please note~~
that the "No." is missing from the DBF you ~~xxx~~ have listed. We can not cross-
reference a DBF by date alone.

Per your request we have added your name to the list of requesters who will
be ~~xxxxxx~~ notified at the time that we have completed the review of the documents
related to the so-called Garrison Investigation.

Before we can process your requests concerning William Pawley and Carlos Fri
Socarras we will need further identifying information concerning them, ^{and if} ~~as well~~
~~deceased,~~
as a notarized affidavit from their next of kin authorizing this Agency to release
information concerning them to you.

We also acknowledge the receipt of your request ^{for} ~~xxxxxx~~ ^{copies of} documents in
201-219762, and will be in touch with you on this matter in a separate letter.

Finally, your request concerning "Daniel L. Carswell" ^(whom you suggest) ~~who~~ may be identical
with "Bruce N. Carswell", has been reviewed carefully. It is our determination
that any documents which might exist ~~xxx~~ which would be responsive to your
request and which reveal any CIA connection with or interest in matters relating
to ~~xxxxxx~~ his imprisonment "by Fidel Castro for bugging ChicomEmb / Havana
Sept. 14, 1960" and, indeed, any data that might reveal the existence of any such
records would be duly classified under criteria set forth in Executive Order 11652.

Accordingly, and pursuant to the authority of exemption (b)(1) of the FOIA, this is to advise that this Agency will not grant access to any ~~additional~~ records that may exist which might be responsive to your request. By this answer, we are neither denying nor confirming that any such records exist.

It has been determined further that the fact of the existence or non-existence of such ~~additional~~ records, if any, would relate to information pertaining to intelligence sources and methods which the Director of Central Intelligence has the responsibility to protect from unauthorized disclosure in accordance with section 102(d)(3) of the National Security Act of 1947 and section 6 of the Central Intelligence Agency Act of 1949. Accordingly, such ~~additional~~ records, if any, are denied pursuant to exemption (b)(3) of the Freedom of Information Act.

The above determination was made by Mr. David S. Brandwein, Office of Technical Services.

As specified in the Freedom of Information Act, I am advising you of your right to appeal the above decisions by addressing your appeal to the CIA Information Review Committee, via the undersigned.


A recent review of my CIA files on George DeMorchenschildt reveals I am missing 997-930. Could you please send me a copy along with a bill?

I am still waiting for a response regarding the sensitive subject of DANIEL L. CARSWELL, the high CIA official I have determined is identical with the "third" tramp who was picked-up as a suspect in the Kennedy killing. A prompt response would be appreciated in order that I may formulate my response to your denial.

Thank-you for your letter of 18 Aug 77 and the attached document. Why go to the trouble of deleting this document when the Warren Commission records contain a verbatim transcription with no deletions. By making these deletions you are only calling attention to the fact that Oswald identified himself to Ivan Ibedenov(phonetic), the Soviet Guard who happened to be on the CIA's payroll. It was your deletion of the word "himself" that slipped me off to this.

I have one question about this new version of "6-3". Dissemination was to Navy, State and FBI. Why did USSS get a copy?

1. Reference is made to your 08 Jul 77 re; CIA traces on my book Coup D'Etat in America. I would like to obtain a copy of the purchase order for the book so I can determine which component found it of interest and how they ordered it. There at least has to be a purchase order.
2. Reference is made to your letter of 25 Jul 77. Re; DBF 25 May 1960-could you at least tell me which document it corresponds to on the Disposition Index? Re; Unidentified man - Bernard Fensterwald was shown a photo without the cropping- could I be extended the same courtesey? This fact comes from a document you supplied me with which I would be happy to send you back a xerox of upon request. Re; LYDMULLIA PRUSAKOVA - you sent me a xerox of a photo of her- could I get a glossy photo from you?
3. Plse put me on the list of requesters who will receive BANNISTER, SHAW, ED COLLINS and GARRISON material.
4. In regard to the disposition index- what I find significant is not that the word "assassination" is used but that the word "plans" and "activities" since the killing was supposed to be a relatively spontaneous thing. Thank-you for answering my enquiries about it.

Under the provisions of FOI/PA I would like to apply for all files, records, photos, fingerprints etc. of DANIEL L CARSWELL born 1938 EAST CHESTER, N. J. Imprisoned by Fidel Castro for bugging Chicom Emb / Havana Sept. 14, 1960 Released from Castro prison April 23, 1963 -identified as CIA agent in numerous press dispatches following his release.

Because of CARSWELL activities from 1963-1968 this man is destined for a place in history. I am of the opinion CARSWELL was present in Dealey Plaza in 1963 and in Memphis in 1968. This is based on comparison between photos of Carswell and the so-called "Third Tramp" who resembles Oswald to some degree and also fits the sketch of Martin Luther King's assassin drawn in Mexico by Police artist Sergio Jubert.

So far I have received very little in the way of documents I requested and have just gotten documents CIA was ready to release. Since these documents were extremely interesting I have not sued CIA for the documents which have been denied me. This will not be the case with the CARSWELL file. I plan to exhaust every legal means of obtaining this file - including a lawsuit, Yippie demonstrations to free this information etc. As far as I am concerned this is the "smoking gun" which links CIA with the JFK assassination. If you withhold this information from me you are only continuing to cover-up illegal domestic CIA activities.

Mr. Savage and Mr. Wilson:

I am still awaiting an answer to my letter regarding information on DANIEL L. CARSWELL. Your co-operation in this matter would be made public should Mr. Carswell, if he is still alive, be brought to justice for his roles in the Martin Luther King and JFK assassinations.

"Daniel L. Carswell" may be identical with BRUCE N. CARSWELL who was Assistant Army Attache, Warsaw, Poland 1957 to July 1960, approximately months before "Daniel Carswell" was arrested in Havana. Upon his release newspaper headlines read-"CIA Agent Slips Through" and he is mentioned in several of Ross and Wises books.

I intend to enlist Dick Gregory in my attempt to obtain this information from you along with James Earl Ray, who I will visit with shortly. My deadline is November 22, 1977.

Under the Provisions of the FOIA/PA I would like to obtain copies of 101-219782. See enclosed document. This lady was receiving payments from the CIA via the American Embassy in Moscow around the same time Oswald


