Until Ray furnished this information to William Bradford Hule, an Alabama author, even the Federal Bureau of Investigation, which had more than 3,000 agents investigating the case, had been unable to put together a complete account of Ray's movements.

-In a long handwritten memorandum that he furnished to Mr. Hule through his former attorney, Arthur J. Hanes, Ray said that when he escaped from the Missouri State Penitentlary on April 23, 1967, he began walking toward Kansas City, about 150 miles from the state prison in Jefferson City.
