

**INTERNATIONAL AVIATION**

Aviation Subcmte (House Public Works) will hold hearings on US policy (or lack of it) regarding bilateral aviation agreements such as Bermuda II **US-UK aviation pact**; whether there could be amendments to the FAA **ACANCELED** CAB decisions on international air transportation; & whether there is a need to amend the Fair Competitive Practices Act. Chmn Anderson (Cal) August dates TBA

**Note:**

In view of the priorities for the subcmte (notice & deregulation legislation on the floor; and markup of the terrorism bill in subcmte) and the short time remaining in this session, it is very unlikely that there is time for the inquiry.

**HEALTH CARE**

Environment & Atmosphere Subcmte (House Science) and Health Subcmte (House Commerce) will co-sponsor a national conference exploring causes of and solutions to health care costs. 345 CHOB Aug 15

**AIR TRAFFIC DELAYS**

**TRADE PROTECTIONISM**

Intl Trade Subcmte (House Banking) will continue oversight hearings examining "new protectionism" in world trade and its implications for US trade policy. Subcmte will explore tariff barriers, government subsidization of exports, "predatory financing" arrangements and cartelization of industries. Chmn Neal (SC) Aug Date TBA

**MARTIN LUTHER KING, Jr**

King Subcmte (House Assassinations) will continue hearings investigating the assassination of Martin Luther King, Jr. Chmn Fauntroy (DC) (open) Aug 14-18; Nov 9, 10, 13-17, 20, 21, 22, 25-29

**Agenda:**

These public hearings will concern Dr. King's activities in Memphis in 1968, his assassination and the involvement, if any, of James Earl Ray in the assassination. An effort will be made to secure the testimony of Ray in public session.

Dec 12-14: The Full Cmte will meet in public session to discuss and resolve the issues presented during the hearings.

**\*DEPT OF ENERGY OVERSIGHT**

These include: purchasing oil for the strategic petroleum reserve, procedures for contracting, practices for enforcing oil pricing regulations, and the proposal to life price controls on gasoline. **ANTIDUMPING ACT ENFORCEMENT**

Trade Subcmte (House Ways and Means) will hold oversight hearings on the administration of the Antidumping Act with emphasis on the Treasury Department's efforts to assess and collect dumping duties, the new Commodity Tax Value approach for assessing dumping duties, and the Department's efforts to eliminate its backlog of dumping cases. ## ANTICIPATED HOUSE COMMITTEE ACTION

**\*NEW \$1 COIN**

House Banking is expected to markup HR12728 changing the size of and the inscription on the one dollar coin. Rep Fauntroy's (DC) Subcmte has recommended Susan B. Anthony for the face on the coin. Chmn Reuss (Wis) Date TBA before the Aug recess.

**\*ENERGY COMMERCIALIZATION**

Energy Subcmte (House Commerce) plans oversight hearings on commercialization in federal energy programs—development of new economical and energy-saving technologies. Chmn Dingell (Mich) Late Aug or Sept Dates TBA.

**Agenda:**

The hearings are planned to cover three general market areas: (1) comprehensive or large-scale industrial facilities such as coal liquefaction; (2) intermediate programs such as fluidized bed combustion and cogeneration; (3) the small-scale industrial market such as petrochemicals.
