✓ 1. (Secret - PLC) LIAISON Met with Gary Cornwell, Deputy Staff Chief, House Select Committee on Assassinations, concerning questions raised with him yesterday on the letter from Professor G. Robert Blakey, Chief Counsel and Director, House Select Committee on Assassinations, dated 6 January 1978. Cornwell had a draft of a letter from Mr. Blakey to me clarifying the items in the 6 January 1978 letter. A number of changes were agreed upon and the letter will be finalized.

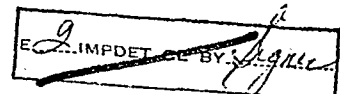
2. (Secret - PLC) LIAISON Received a call from Rita Argenta, secretary to Bill Hogan, House Armed Services Committee staff, who advised that Chairman Melvin Price authorized transfer of the Committee's Watergate material which the Agency has been holding, to the House Permanent Select Committee on Intelligence. Ms. Argenta requested that we offer the material to the House Select Committee and if they refuse to accept it, Hogan would transfer the material to Archives. I said I would check and let her know. I subsequently called Thomas Latimer, Staff Director, House Permanent Select Committee on Intelligence, and offered the material. He said he would check with the Chairman and get back to me.

3. (Unclassified - PLC) LIAISON Called Tim Ingram, staff of the House Government Operations Subcommittee on Government Information and Individual Rights, and discussed the meeting, together with Gary Brenneman, OGC, scheduled for 10:00 a.m. on Thursday, 12 January, in Ingram's office. Ingram asked that Brenneman discuss in general terms the Agency's policy in the handling of notification to Justice Department of cases involving espionage or other crimes affecting the national security. He does not have in mind any specific case that he wants discussed. Brenneman was advised. Ingram requested that the briefing with George Clarke, OGC, to discuss the Agency's policy for the conduct of security investigations in view of the court decision on the Weissman case be put off until 24 January at 10:00 in his office. Clarke was advised. A representative from OS will also be present.



REFERENCE: HSCA Letter, 6 January 1978, OLC 78-0070

1. HSCA Reference Request Items 29 and 30: With the exception of the "Helms Holdings" (XAAZ-27163, 17 November 1967), which are available in one envelope (shown to Mr. Berk on 30 May 1978), internal documents and materials of Messrs. James Angleton and Raymond Rocca as well as correspondence or records of communication involving them in reference to the Kennedy assassination or to the subsequent investigation, and all correspondence or records of communication between each of these people and the Warren Commission, are scattered throughout the official Oswald file and ancillary files.

2. To pull together copies of all material, etc., prepared and signed by Messrs. Angleton and Rocca requires the physical examination of each document in the Oswald file to determine its originator and then making a copy of each pertinent document.

3. To accomplish this task, one or more of the HSCA staff members should examine the Oswald file and clip those documents from which they wish copies made for their research. We will then print and assemble the files for their use in Headquarters.

4. HSCA Reference Request Item 31: Although six documents relating to former Director of Central Intelligence Allen W. Dulles were shown to Mr. Berk on 26 May 1978, there might be additional material in the Oswald file which would surface during an examination by the HSCA staff of the Oswald file.

1. (U/AIUO) Action Requested: None; for information only.

2. (U/AIUO) Background: Reference is made to the attached House Select Committee on Assassinations (HSCA) Priority List dated 9 June 1978 (OLC 78-2100). The HSCA has asked that certain items, identified in HSCA requests forwarded to the Agency since January 1978, be afforded priority handling. Of the 21 requests and approximately 130 items addressed in the Priority List, a review of previous Office of Security responses indicated the need for a reply on some items previously held in abeyance. Those items were 29-31 of the 6 January letter, item 2 of the 5 April letter, item 2 of the 23 March letter, item 3 of the 27 February letter, and item 4 of the 19 April letter.

3. (C) Your Office was telephonically advised on 20 June 1978 of the following results of Office of Security records search and review pertaining to the above cited items:

a. 6 January letter (item 29-31) - Material is available for review regarding Richard Helms, James Angleton, and Ray Rocca. The material on Helms and Rocca (memorandum dated 26 September 1977) can be found in the Edward Jay Epstein file previously made available for HSCA review. Additional material on Mr. Rocca (memorandum dated 1 July 1975) is included in the above material on Mr. Angleton. A review of Mr. Allen Dulles' file disclosed only a memorandum for the Inspector General from the Director of Security
