Dear Sir:

I write to request a copy of all files in the Federal Bureau of Investigation indexed or maintained under my name and all documents returnable by a search for documents containing my name, including Reports, Memos, Letters, Surveillance Reports, Wiretap Reports, etc. regarding the following incidents, activities, operations, etc.:

- 1. Clandestine activities involving revolution against the Cuban regime of President Fulgencio Batista.
- 2. Incident involving Lee Harvey Oswald at the Cuban Consulate at Monterey Park, Los Angeles County, California in January, 1959.
- 3. Activities with Fidel Castro: Cuban Rebel Army and Rebel Air Force from 1958 to 1960.
- 4. Activities with Major William Alexander Morgan, Cuban Rebel Army, from 1959 to 1960 with specific reference to anti-Trujillo (Dominican Republic) operations during the summer of 1959 and the S.S. Le Coubre steamship explosion in February, 1960 at Havana harbor.
- 5. Incident with Major Fidel Castro Ruz and Vice Premier of the U.S.S.R. Anastas Mikoyan at San Julian Air Base, Cuba in 1960.
- 6. Incident regarding U.S.A.F. C-54 eircraft with U.S. military personnel on board that illegally landed at San Julian Air Base. Cuba in 1960.
- 7. Reports given to U.S. Central Intelligence Agency at Los Angeles, California from 1960 to 1961, in reference to intelligence on Cuban Rebel Army and Rebel Air Force including:
 - a) markings of Cuban aircraft, operational capabilities and locations, missions, etc.



reports regarding anti-communist or anti-Castro leanings of Cuban, Nicaraguan, and other nationals within the Cuban Rebel Armed Forces including Major Morgan, Major J. Carreras, Major H. Sori Marin et al., Captain W. Figueroa, Captain Martin Klein, Captain J. Sotolongo, Captain Claudio Medina, Captain G. Blazquez, Captain Achiles Chinea et al., with specific reference to Captain Alfaro Galo (implicated by Invasion Brigade 2506 pilot M. Zuniga at Miami, 15 April 1961) and Captain Pedro Ulloa (Killed In Action at Playa Giron-Bay of Pigs, 17 April 1961).

8. Operations with Cuban exile (anti-Castro) group headed by Dr.
Aureliano Sanchez Arango that included employees of Howard R.
Hughes (Hughes Tool Company), including C. Osment Moody et al.,
organized crime figures, and CIA operatives, from 1961 to 1962.

- 9. Meetings in Florida, Texas, Louisiana, etc., with individuals threatening the life of President John F. Kennedy, from 1962 to 1963.
- 10. Reports referring to a plot to foil deportation of ex-President Perez Jimenez of Venezuela from Mismi. Florida in 1963.
- 11. Reports referring to an operation conducted by Cuben exiles (anti-Castro) to exfiltrate Soviet mizzile technicians and officers from Oriente, Province, Cuba from February to April of 1963, resulting in the loss of entire commando team to enemy action.
- 12. Report to the FBI field office, Los Angeles, regarding suspect in the assassination of Dr. Martin Luther King at Memphis, Tennessee in 1968.
- 13. Reports to the U.S. Secret Service at Miami field office which were later passed on to Federal Bureau of Investigation, Central Intelligence Agency, Office of Naval Intelligence, Office of Special Investigations (U.S.A.F.), U.S. Army Intelligence or Counter-Intelligence, U.S. Customs Service, et al., with reference to a conspiracy by U.S. and foreign nationals to assassinate President Richard M. Nixon at Key Biscayne, Miami, Florida, from September to November of 1970.
- 14. Reports referring to "Watergate" figure Frank Sturgis AKA Frank Fiorini and Ed Keiser from 1971 to 1972, given to the F.B.I. and the A.T.F. at Miami.
- 15. Reports referring to Military Armaments Corporation, Sionics, Incorporated and Defense Services Industries, all of Powder Springs, Georgia, and Quantum Corporation of Washington, D.C. in reference to certain arms sales via the Miami office of Parabellum Corporation to countries in Central and South America including Mexico, from 1971 to 1972.
- 16. Reports referring to Parabellum Corporation of Miami, Florida and Latin America specifically referring to a plot to assassinate a Latin American Head of State, originating in Guatemala City, Republic of Guatemala in 1972.
- 17. Reports referring to Andres Castro, Bell Mortgage, Incorporated, versus Central Intelligence Agency et al., law suit and investigation during 1975.

I am an investigator in liaison with Bernard Fensterwald, Esq., Attorney, Washington, D.C., who has, for some time, been coordinating the activities of various committees of inquiry into intelligence operations, conspiracies, attempts (thwarted and successful) to assassinate, and related matters involving the security and safety of numerous public officials and other public figures. I therefore formally request, pursuant to Title 5, United States Code, Section 552 (a) (3), and the First Amendment to the United States Constitution, that you make promptly available to me copies of the above information.

To assist you in your search, I have indicated my Social Security number, together with other pertinent information relating to the above, and date and place of birth below my signature.

As you know, the amended Act provides that if some parts of a file are exempt from release that "reasonably segregable" portions shall be provided. I therefore request, that, if you determine that some portions of the requested information are exempt, you provide me immediately with a copy of the remainder of the file. I, of course, reserve my right to appeal any such decision.

If you determine that some or all of the requested information is exempt from release, I would appreciate your advising me as to which exemption(s) you believe covers the information which you are not releasing.

I am prepared to pay costs specified in your regulations for locating the requested files and reproducing them.

As you know, the amended Act permits you to reduce or waive the fees if that "is in the public interest because furnishing the information can be considered as primarily benefiting the public." I believe that this request plainly fits that category and ask you to waive any fees.

If you have any questions regarding this request, please telephone me at the above number.

As provided for in the emended Act, I will expect to receive a reply within ten working days.
