McCarthy Terms Death Of Dr. King a Sacrifice

SAN FRANCISCO, April 5 — Senator E u g e n e J. McCarthy; (De m.), Minnesota, expressed shock and grief last night over the killing of the Rev. Dr. Martin Luther King.

The death of Martin Luther Hirg is a tragedy for all Americans. Not only have his people as a noble and great leader, by all people, especially Americons, have lost a man of peace.

McCarthy said he would not go to Atlanta for the King funeral. He said he would attend r amorial service wherever he responed to be at the time.

Carthy referred only briefly to the killing in a speech largely on domestic affairs. He c.ew a standing ovation with an attack against the Central Intelligence Agency, the Federal Bu-reau of Investigation and the Selective Service System.

McCarthy's Attack Cheered

s "institutions that I think have gotten out of hand," and the audience jumped to its feet

McCarthy's attack was an unusual political act. Most politicians avoid criticism of the ClA and FBI. John F. Kennedy, before his inauguration as president in 1961, saw fit to announce that he would keep the then CIA director John McCone and FBI director J. Edgar Hoover in office.

On Draft Objectors

McCarthy drew more applause by indorsing campus as-sistance to draft resisters — although he said he did not favor encouraging draft resistance in the first place — and readmis-sion of students to colleges and universities after serving sen-tences for draft evasion.

At a press conference, he advocated a "sort of amnesty" for young American men who have fled to Canada to avoid the draft. He said he would make them eligible for "selec-tive objection" to war under an amended draft system that would permit alternate service

for those who nonestly objected to a particular war.
