

In connection with its investigation into the assassination of President John F. Kennedy, the Select Committee on Assassinations requests that you make available to our staff all files and index references pertaining to the individuals listed below:

1. Lee Harvey Oswald: Check also under Lee Henry Oswald, Henry Lee Oswald, Harvey Lee Oswald.
2. Marina Nikolaevna Prussakova Oswald: Check also under Marina Nikolaevna Pusakova Oswald.
3. Rima Shirakova: Lee Harvey Oswald's Intourist guide in Moscow in 1959.
4. Louis Hopkins: Manager or officer of travel agency located in the International Trade Mart in New Orleans; made travel arrangements for Oswald from New Orleans to the Soviet Union.
5. George DeMohrenschildt: Born on [] in Mozyr, Russia; close friend of Oswald's in Dallas after Oswald's return from Soviet Union.
6. Marilyn Dorothy Murret: Oswald's cousin who housed the Oswald family in New Orleans upon their return from the Soviet Union. Her present address is: 7055 General Haig Street, New Orleans, Louisiana.

7. Harold Isaacs: Served as a research associate at the Center for International Studies at MIT; referred to in Warren Commission Document #942.
8. John A. McVickar: Officer in the Consular Section of the American Embassy in Moscow from 1959 - 1961.
9. Leo Cherne: Director of International Rescue Committee in 1962.
10. Gregory Yeugenyvich Golub: Employed by Soviet Embassy in Helsinki in 1959.
11. Eusebio Azcue: Cuban Consul in Mexico City in 1963.
12. Silvia Duran: Assistant to the Cuban Consul at the Cuban Embassy in Mexico City in 1963.
13. Horatio Duran: Husband of Silvia Duran.
14. Ivan Obyedkov: Guard at Soviet Embassy in Mexico City in 1963.
15. Alvarado Gilberto Nolasco Ugarte, or Gilberto Alvarado: Born on [] in Ciudad Rama, Nicaragua; agent for Nicaraguan intelligence who was in Mexico City in September 1963.
16. Spas T. Raikin: Representative of the Travelers Aid Society who met the Oswalds upon their return to the United States at Hoboken, New Jersey on June 13, 1962.
17. William Harvey: Chief of CIA's Foreign Intelligence Staff during early 1960's before being assigned to Task Force W, the CIA operations staff for Operation MONGOOSE (files for 1959 - 1964 only).
18. E. Howard Hunt: CIA case officer who was the political officer for the Cuban Revolutionary Front (files 1959 - 1964 only).

19. Jim Garrison: Former New Orleans District Attorney who launched his own investigation into the Kennedy assassination in 1967.
20. John E. Donovan: Commander of Oswald's radar crew when Oswald was stationed at the El Toro Marine Base in California.
21. Dr. Rex J. Howard: A doctor from Fort Worth, Texas, who supplied an affidavit for Marguerite Oswald in 1959 on behalf of Lee Harvey Oswald's pending discharge from the United States Marine Corps.
22. Dr. Rex Z. Howard: A doctor from Fort Worth, Texas, who supplied an affidavit for Marguerite Oswald in 1959 on behalf of Lee Harvey Oswald's pending discharge from the United States Marine Corps.
23. QJ/WIN: CIA operative involved in William Harvey's ZR/RIFLE program.
24. Bernardo DeTorres: Latin American Sales Representative for the Military Armaments Corporation, a Georgia-based firm headed by Mitchell Livingston WerBell III.

31. All post-assassination communications between former Director of Central Intelligence Allen Dulles and the CIA.
32. All cable traffic to and from Mexico City for October-December 1963.
33. All tape recordings and/or transcripts of recordings relating to Lee Harvey Oswald in Mexico City.
34. All of Richard Helms' correspondence, documents and materials pertaining to Oswald's embassy visits.
35. All materials pertaining to preparations for the Director of Central Intelligence's appearance before the Warren Commission.
36. All materials pertaining to Southern Research Corporation, presently known as Wackenhut Corporation.



We request further that your search include all files that are centrally indexed as well as those that are maintained in a non-centralized manner. This search should specifically include, but not be limited to, the Western Hemisphere Division files, the Office of Security files, the Office of Personnel files, the Technical Services Division files, and the Office of Finance files.

Because item #38 above and the paragraph below are derived from "Top Secret" material, you might find it appropriate for the Agency to so classify them. All copies held by this office have been marked "sensitive".

Finally, please be advised that the Committee will provide you shortly with the names of those staff members who are to be given direct access to selected portions of the 1977 CIA Staff Study.



In connection with its investigation into the circumstances surrounding the death of President Kennedy, the Select Committee on Assassinations requests access to all files and file references concerning or referring to the following individuals:

- 1) Martin Isaacs - As an employee of the Special Services Welfare Center, Department of Welfare, New York City in 1962, he aided in getting the Oswald family back to Texas upon their return from the Soviet Union. DOB: in Hungary.
- 2) Marion S. Wyeth, Jr. - Currently a Vice President and Editor-in-Chief at Harper and Row, Inc. Present address: 364 W. 19th Street, New York, New York.
- 3) John Leggett - Currently Director of the Writers Workshop at the University of Iowa. Present address: 415 S. Summit, Iowa City, Iowa.
- 4) Burton Beals - Present address: 115 Washington Place, New York, New York.

In regard to paragraph two of our letter of April 6, 1978, requesting information on the Agency's contact with repatriated American defectors to the Soviet Union, we request that you include in your response the following information:

- A) If it was not standard operating procedure to interview such persons as described above, please explain the basis for this policy.


- B) Any manual or written set of regulations outlining the procedures utilized by the CIA during the period of 1958-1963 in dealing with U.S. defectors to the Soviet Union or Soviet bloc countries.

In addition, we would like you to provide access to an organizational chart of the DDP in 1963 and of the DDO in 1978.

Finally, this letter serves as written confirmation of an oral request by Staff Researcher Betsy Wolf for access to any files or documents in the possession of the Domestic Contacts Division pertaining to the individuals listed in our letter of February 27, 1978. (My understanding is that the DCD files were not originally checked because the Committee's initial request sought access only to these individuals' 201 files).


In connection with the investigation of the House Select Committee on Assassinations into the death of President John F. Kennedy, I am writing to request that the Central Intelligence Agency provide the following information to the Select Committee on Assassinations:

1. A detailed written statement indicating both whether Lee Harvey Oswald was ever contacted in any way by any CIA officer, agent, contractor, or other CIA employee or whether Oswald himself ever initiated such a contact. If so, please indicate the circumstances under which such contact was made and identify those persons who contacted, spoke to, or interviewed Lee Harvey Oswald on behalf of the Central Intelligence Agency.
2. A detailed written statement indicating whether the Central Intelligence Agency, from 1958-1963, interviewed or debriefed former American defectors to the Soviet Union who repatriated to the United States. If such interviews were conducted, please indicate whether they were done as standard CIA operating procedure. If such interviews were conducted but not as standard operating procedure, kindly indicate under what circumstances such interviews would be initiated.
3. A detailed written statement indicating whether Lee Harvey Oswald received CIA intelligence training or CIA intelligence-related training while serving in the United States Marine Corps. If so, please indicate the nature of this training.

In connection with its investigation into the circumstances surrounding the death of President Kennedy, the Select Committee on Assassinations requests access to all files and file references pertaining to the following individuals:

- 1) Edward Jay Epstein
- 2) Marvin Kantor
- 3) Charlotte Bustos
- 4) Annie Goodpasture.

In addition, please provide the Committee with access to the following information:

- 5) Any and all investigative reports prepared by E. Howard Hunt pertaining to the John F. Kennedy assassination. (These reports were not necessarily prepared during the period of Mr. Hunt's employment with the CIA).
- 6) The file that was prepared by the CIA in reference to E. Howard Hunt's alleged Watergate-related activities.

The Committee previously requested access to all CIA files pertaining to E. Howard Hunt in its letter to you of January 6, 1978. However, Roger Gabrielson, of your staff, has requested that the particular requests identified above, be put in writing.

The Committee would also appreciate a response from the CIA regarding the following matters:

- 7) The CIA's written statement replying to the Committee's request of February 21, 1978 for an explanation of the criteria that governed the opening of a 201 file during the years 1958-64 was not responsive to our inquiry because the CIA's written statement did not focus on the relevant time period. Accordingly, I am renewing our request of February 21, 1978. In the event that there were no criteria governing the opening of such files during that period, the Committee would appreciate a written statement indicating that this was the case.
- 8) CIA document #563-810 indicates that there are 37 documents that should be in Lee Harvey Oswald's 201 file but which are missing from the file. Furthermore, this document also indicates that there should be a machine listing of these documents attached as part of document #563-810, but no such listing appears in the file. The Select Committee on Assassinations requests that the CIA provide a listing of such documents as well as a written explanation of where those documents are located and why they do not appear in Oswald's 201 file. Pursuant to my letter of December 27, 1977, I would like to note that the document referred to in this paragraph is a classified document.
- 9) After having reviewed both the documents contained in the CIA's files on Priscilla Johnson McMillan and the materials that were independently made available to her under the Privacy Act, it is apparent that the files which were made available to the Committee did not include HTLINGUAL materials. As the Committee has already requested all information contained in your files on the individuals who are the subjects of our requests, please review the files that you have previously made available to us for the purpose of ensuring that all of the information pertaining to the individuals involved has, in fact, been provided.





In connection with its investigation into the circumstances surrounding the assassination of President Kennedy, I am writing to request that the CIA provide the Committee with access to the following information:

- 1) A list of documents in the possession of the CIA concerning Lee Harvey Oswald (Lee Henry Oswald, Harvey Lee Oswald) prior to the opening of a 201 file on him, as well as the office in which each of those documents was located prior to the opening of the file.
- 2) A statement, including any written regulations, which establishes the criteria utilized by the CIA in classifying its relationships with individuals with whom it has had contact; i. e., whether such an individual would be classified as a source, an asset, an independent, a witting collaborator, an unwitting collaborator, etc.
- 3) All dispatches to and from Mexico City for the period of October 15 through November 26, 1963.
- 4) The three 201 files immediately preceeding Lee Harvey Oswald's file as well as the three 201 files immediately following it.
