SUBJECT: Records Management Procedures re Meeropols Case

Dan:

1. I was somewhat concerned that this office had been remiss in its responsibilities when I read in your "Recent Legal Developments" of 18 October 1979 of the records management problem with respect to the Meeropols. Danny May was also somewhat upset that perhaps we had goofed. As a result of your note, we went to considerable effort to develop the facts of the case and we find that they are at variance with your note.

SUBJECT: IPD Comments Regarding an Excerpt from
OGC's Weekly Roundup of Litigation in
Process

1. The following are the facts as obtained by me from discussions with IPD personnel knowledgeable of IPD case number F75-0144, Michael Meeropol:

(a) In the summer of 1978, IPD representatives went to the records center to review IPD case files for the purpose of identifying those to be destroyed when the moratorium was lifted.

(b) During this review, job number 76-00900 was examined. This job number consisted of 14 boxes. Thirteen of these boxes were marked for destruction when the moratorium was lifted. Contained in these 13 boxes were cancelled cases, "no records", and negative and granted-in-full responses, and chronos. The 14th box (numbered 13) was set aside because it contained litigation cases. Unfortunately, it still retained job number 76-00900. It was the intention of the IPD employees reviewing the files to have this box retained and not destroyed until April 1980. To accomplish this action, box number 13 was physically separated from the other 13 boxes, however, a new job number was not assigned to box number 13.


(c) On 2 February 1979, Chief, IPD, sent a memorandum to DDA/Records Management Office identifying job number 76-00900 as being ready for destruction as soon as the moratorium was lifted. In making this determination the IPD/RMO was not aware that box number 13 of the 14 boxes, was not properly marked for retention until April 1980. IPD's decision to have 76-00900 destroyed was based upon the fact that the IPD task force sent to the records center had identified 76-00900 as being ready for destruction.

(d) As best as IPD can determine, the 13 boxes noted in (b) above, were destroyed in March 1979 after the moratorium was lifted. The 14th box (#13) was not destroyed until May 1979. The difference in destruction dates apparently arose because the one box (#13) was physically separated from the other 13 with the same job number.

(e) Box number 13 contained 19 litigation cases, including the Meeropol case. Based upon the fact that 19 litigation cases were stored in one box, IPD has concluded that the Meeropol file was small and probably contained only copies of component transmittal responses and other Agency reference memoranda, but not copies of the documents released in the Meeropol case.

(f) Presently located in IPD are duplicates of some 2500 documents pertaining to the IPD 1975 Meeropol case. Included with these documents is an affidavit containing a listing of the documents held in our Meeropol file. The decision to retain these some 2500 documents was made by IPD mainly because so many individuals were involved, and as long as those individuals noted in the documents were still alive, the Case Officer felt we should retain the records.

2. I'm not sure that a revamping of our present records destruction procedures is necessary. In the Meeropol case, it appears that IPD employees were under great pressure when given a three week deadline to review the files at the records center. The group probably did the best they could under the circumstances. If box #13 had been marked with a new job number it would not have been destroyed. On the other hand, the best we can find is that the destroyed records were not the most important ones. The most important are the some 2500 documents which were released on the Meeropol case, and these are still available in IPD.

SUBJECT: Weekly Excerpt from OGC of Litigation in Progress.

Attached is a detailed report of investigation by the Chief, RSB, into the statement by OGC that certain records pertinent to an FOIA request now in litigation were destroyed. The report concludes that since neither Morton nor Helen Sobell's names appeared on the OGC listing being used at WTC during the OS review of their records such records were destroyed in accordance with both federal mandatory requirements and Agency procedure. In addition, other Agency components, reviewing records and using the same listing may well have destroyed similar records. In the case of IPD, it appears they authorized the destruction of a working chrono file containing duplicate copies of information still being held in IPD as part of the Julius and Ethel Rosenberg case.

SUBJECT: Weekly Excerpt from OGC of Litigation in Progress.

1. The excerpt from the OGC weekly of Litigation in Progress entitled Records Management, in itself, is not in good faith, nor does it follow the path of the excellent cooperative and productive working relationship that has existed between RMD and OGC since the beginning of FOIA, PA, Files on Americans, litigations, accusations, disposition of records, etc.

2. To begin, the OGC did not establish the procedures for the protection of litigation type records. The procedures, including implementing forms and notices were all prepared and implemented by RSB with the cooperation and concurrence of all Agency operating offices, including OGC. OGC's primary contribution to the established procedures was to provide through RMD to all Agency RMO's, semi-annual listings of individuals, etc., on which files were not to be destroyed. The last listing made available to RMD was in late 1978. In addition, incidents such as the two referred to in the excerpt were to be immediately brought to the attention of the Chief, RMD, where an investigation of the circumstances would be immediately conducted. RMD was not informed of these two incidents.

3. On 22 October, the Chief, RMD, brought the OGC complaint to the C/RSB for the first time. C/RSB contacted Mr. Steve Bradley, OGC/RMO and was informed that there were two offices involved in the destruction of FOIA type material, the Office of Security and the Information Privacy Division.

4. Office of Security - The event referred to here was that the OS had, in the summer of 1978, while doing their records review at WTC, authorized the destruction of Records Center Job No. 65-173, which was ultimately destroyed on 23 March 1979 and that this job contained information on a Helen Sobell.

- Fact 1. The job in question was reviewed by OS representatives during the DDA Records Review at WTC in the summer of 1978.
- Fact 2. Working under established procedures and with the OGC listing of files to be retained (See Attachment - 1), the job was designated for destruction. The OGC list did not contain the names of Morton & Helen Sobell.
- Fact 3. Although designated for destruction in the summer of 1978, the job was not destroyed until 23 March 1979, after the lifting of the moratorium.
- Fact 4. IPD received an FOIA request from Helen & Morton Sobell dated 13 August 1975 and responded on 26 August 1975 to the effect that their files were inter-twined with the information requested in the Meeropol (Julius & Ethel Rosenberg) lawsuit, and could not be made available at the time. Action on this FOIA request would be taken when the Meeropol case was closed.
- Fact 5. The OS/Information Review Group, on 8 May 1979 received a request from IPD to begin processing the Morton & Helen Sobell FOIA request, No. F-75-4982. This was two months after the destruction of the Helen Sobell file and the first time the OS had received a request concerning Helen Sobell. (OS has no record of the Morton Sobell file being destroyed).
- Fact 6. On 4 October 1979, the OS/IRG received a listing from OGC which, for the first time, contained the name Helen Sobell. (This was six months after the destruction of Helen Sobell's file, mandatory under the Senate Select Committee's orders that unless good reason could be demonstrated for retention, all files on Americans must be destroyed).
- Fact 7. The listing of additional names on subjects relating to records to be withheld, made available by OGC to OS/IRG on 4 October 1979, which contains the Sobell's names, has not to this date, been made available to RMD or RSB as was previously the procedure agreed upon. Therefore, Agency RMO's are not at this time aware of these additions.

Fact 8. The OS acted in accordance with procedures as established by the Records Management Division. The lack of up-to-date information appears to be the area where corrective action is required.

5. Information Privacy Division - The event referred to here was that IPD had authorized the destruction of Records Center Job No. 00900R during their review of records at the Records Center in the summer of 1978. The records, ultimately destroyed on 1 March 1979 contained information related to the Meeropol lawsuit (Julius & Ethel Rosenberg), specifically a file on Michael Meeropol, son of the subjects.

Fact 1. During the records review at WTC in the summer of 1978, IPD reviewed Job No. 00900R which at that time consisted of 14 boxes of IPD records. Boxes 1-12 and 14 were sent back by the reviewers to IPD for retention. Box 13, Entitled "FOIA & PA Care Files" remained at the Center and was changed to Box 1 of Job 00900R and entitled "Chrono Files - 30 June 75-1 Oct. 75, along with a form 141 B, Authority to Destroy dated 8 August and signed by Ms. Sally Weiler of IPD.

Fact 2. Because of the moratorium, Box 13 (Now Box 1) was not destroyed at that time. With the lifting of the moratorium, IPD was requested by the Center to concur with the original destruction authorization. IPD did so in a memo from George Owens dated 2 February 1979. (Cp. at R.C.), and the box was destroyed on 1 March 1979.

Fact 3. The Box did contain a file entitled Michael Meeropol.

Fact 4. The file was not an official agency file. It was an IPD working file made up of copies of documents received from various Agency offices in response to an IPD request for information on Julius and Ethel Rosenberg. IPD stated that this is SOP, that they do not receive original documents, only copies, both in full or sanitized version. The originals are retained by the submitting office, flagged and held until such cases are closed.


Fact 5. The Title "Chrono Files" as set forth in Fact 1, usually refers to a chronological collection of records, the originals of which are maintained in other individual subject or case files.

Fact 6. From here on out, my investigation was, to say the least, frustrating. It appears that IPD and OGC operate totally independent of each other, the one not knowing what the other is doing which in turn frustrates those responsible officers in between. For example, IPD indicated that this case was closed on 1 January 1977 and re-opened later. They did not know when. OGC on the other hand, could not tell me when the case was closed, if it was, nor when it was re-opened, if such did occur. OGC insists that names of individuals of interest to them are made known to all offices, yet, our own office, charged with notifying all Agency components of such individuals of interest to OGC was never informed of their interest in Morton & Helen Sobell. IPD informed OGC that they have copies of the materials destroyed in Box 13 (Box 1 when destroyed), on the shelves in IPD with the rest of the Meeropol documents yet, OGC asked me where are the Meeropol files today, to which I replied, "well I suppose IPD has the duplicates, and I know OS has four or five boxes, and most likely the originals are scattered throughout the Agency in various component subject, case, and personality files, flagged and being retained until no longer required by IPD, OGC, OLC, or other mandatory retention requirements."

6. It is my judgement that in view of the fact that neither Morton nor Helen Sobell's names appeared on the OGC listing being used at WTC during the OS review of their records such records were destroyed in accordance with both federal mandatory requirements and Agency procedure. In addition, other Agency components, reviewing records and using the same listing may well have destroyed similar records. In the case of IPD, it appears they authorized the destruction of a working chrono file containing duplicate copies of information still being held in IPD as part of the Julius and Ethel Rosenberg case. It also appears that there exists between OGC and IPD a communications gap that may give rise to similar problems in the future. Finally, I have no doubt that OGC is not, as required, notifying Agency components of additional individuals in which they have interest. In our own case, we still do not have notification of a hold on Morton and Helen Sobell records nor have we received any updates since the last listing received from OGC dated November 1978. In order to ensure that such listings, updates or deletions had not been sent directly from OGC to the Directorates, the Directorate RMO's responsible for such distribution in NFAC, DDS&T

and DDO were contacted and asked if they had received such listings and/or additions to the previous list, specifically, the names of Morton and Helen Sobell. All replied they had received no additional lists or additions from OGC since the last listing dated November 1978, nor have they received any instructions to hold material on a Morton and Helen Sobell. It therefore appears that the only office that could show me a list containing the Sobell's name was the Office of Security, sent directly to them by OGC and dated 4 October 1979. I fully agree with the OGC statement in their "weekly round-up" that "recent events do indicate corrective action may be necessary", however, I disagree with them that such action should be directed towards records retention practices and recommend that such action be directed towards adherence to established communication procedures.

7. In conclusion, since I have been advised that this was one of the subjects discussed at a recent Executive Staff Meeting, which I presume was at the DCI level, I will also presume that action will be taken to rectify any and all misconceptions that may have been presented to those in attendance.
