Dear Mr. Garbler:

Pursuant to its mandate under House Resolution 252, the Committee on Standards of Official Conduct requests the following information and assistance.

The Committee requests access to any and all documents, materials, and information in any form, in the possession, custody or control of the Central Intelligence Agency, whether or not disseminated outside the Agency, and whether originating in the field, at CIA Headquarters, or elsewhere, related to:

- (1) efforts by the Government of the Republic of Korea to influence Members of Congress or other United States officials, legislation to be considered by Congress, or the policies of the United States;
- (2) the sale of rice from the United States for use in the Republic of Korea, or the disposition, for any purpose, of commissions generated by such a sale;
- (3) Lee Hu Rak, former Director of the Republic of Korea Central Intelligence Agency, insofar as any documents, materials, or information related to Lee Hu Rak may also be related to:
 - (a) efforts by the Government of the Republic of Korea to influence Members of Congress or other United States officials, legislation to be considered by Congress, or the policies of the United States;

- (b) the sale of rice from the United States for use in the Republic of Korea, or the disposition, for any purpose, of commissions generated by such a sale;
 - (c) the removal of Lee Hu Rak as Director of the Republic of Korea Central Intelligence Agency;
 - (d) the departure of Lee Hu Rak from the Republic of Korea after his removal as Director of the ROK CIA, and any subsequent cooperation by the United States in locating him or returning him to the Republic of Korea;
- (4) Park Yong-hak or Park Yong-hap;
 - (5) Kim Soon-Jai, aka Sunja Kim, aka Mrs. Kwon Chul-Hyun;
 - (6) The Conference for the Development of Free Institutions.

The Committee also requests the cooperation of the Agency in arranging for interviews with Mr. Robert Brewster and Mr. Robert Bodroghy. These interviews are to be conducted separately, and while the Committee has no objection to conducting the interviews at CIA Headquarters, it is our expectation that the interviews will not be conducted in the presence of any other CIA personnel.

In addition, please note that the Committee's request of September 28, 1977, for a list of CIA chiefs of station in Seoul and a list of Korean desk officers at CIA headquarters has not been met. We would like to expand this request to include all deputy chiefs of station in Seoul since 1967 and all CIA division chiefs of the East Asia Division since 1967.

Finally, the Committee renews its request, made previously in June 1977 and again in August 1977, and agreed to on both occasions, for access to all material made available by the Central Intelligence Agency to the Department of Justice in connection with the Department's investigation of Korean influence matters.

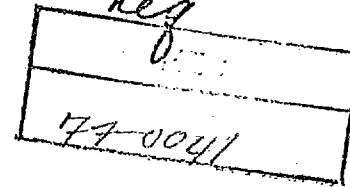



Dear Mr. Garbler:

We have reviewed your summaries of information in the CIA files related to PARK Tong Sun, Sue Park THOMSON, and Kim Kwang. The Committee now requests access to all documents used in the preparation of these summaries, and any additional documents and information in the possession, custody or control of the Agency related to any of these three named individuals.

In addition, the Committee requests that you prepare for us a summary of information in your files related to Dr. SHIN Don Shik. Information which we now have indicates that Dr. Shin, a South Korean national, was attached to the United States Bureau of Ships for training purposes in about 1966, that he was subsequently an advisor on economic problems to President Park, and that he is presently head of the Korea Shipbuilding and Engineering Company.

I understand that, pursuant to my oral request of September 27, you are preparing for the Committee a list of CIA Chiefs of Station in the Republic of Korea since 1967. We would like to arrange interviews with these persons as soon as possible.

In the case of Mr. John Richardson, we propose to conduct an interview in the Washington area, and we request that you proceed immediately to make arrangements to bring Mr. Richardson to the area. The Committee will bear responsibility for necessary transportation costs. Please contact us to arrange the details of financing such transportation.

During the course of the inquiry currently being conducted by this Subcommittee into the relations between the United States and the Republic of Korea, it has come to the attention of the staff that one or more meetings took place at the State Department in mid-1971 about which your Agency may have useful information.

The meeting(s) were between Don Ranard, then Korea Country Director for the State Department, and a CIA official, and one or more other persons. The subject of the meeting was the attempts by the Government of the Republic of Korea to influence U.S. officials and policy, and, in particular, to influence and control the actions of Congressional staff aide(s).

At this time we would like to request that you provide this Subcommittee with (1) the name and position of the CIA official in question; and (2) any contemporaneous memoranda, reports, or notes concerning the meeting(s).

In addition, we are interested in any and all memoranda, letters, notes of conversations or other reports concerning the above subject that would have been communicated between the Agency and the Federal Bureau of Investigation during the approximate period of 1971 through 1973. In particular, we understand that a conversation took place between an FBI official and an Agency official during which the FBI requested permission to pass on certain information to the Attorney General and to Dr. Kissinger. We would greatly appreciate your supplying us with the names and positions of the Agency persons involved, as well as any contemporaneous memoranda.

Once again I would like to thank you for the Agency's cooperation in this matter.




As Special Counsel to the Select Committee, I request access to the following documents, whether classified or not:

REFERENCE: Memorandum for the Record, Same
Subject, dated 27 June 1977

1. In a follow-up to the referenced meeting, Mr. Cary, accompanied by Mr. Brewster, met with Senators Stevenson and Schmitt on 28 June 1977. Mr. William Miller, Staff Director for the Senate Select Committee on Intelligence (SSCI) joined the group later.

2. The purpose of the meeting was to allow the Senators to read copies of Agency messages containing references to the Senate in connection with the ROK and KCIA activities. Two duplicate files of this material were carried to Senator Schmitt's office; one set with all the names of Senators excised, and the other set contained the names. The Senators chose to review only the documents which did not contain the names.

3. After they had reviewed this material, the Senators concluded that nothing was contained therein which would provide the basis for any investigations by the Senate Ethics Committee. The Senators agreed that the activities mentioned in the documents carried no implications of improper action. Mr. Miller joined the conference after the situs had been moved to Senator Stevenson's office in the Capitol Building. In answer to a direct question from Senator Stevenson, Mr. Miller stated that the review of all of the Agency documents



on the Korean subject by the SSCI Staff investigators, Mike Epstein and himself, led Mr. Miller to the conclusion that there was nothing in this material which would support an investigation by the Senate Ethics Committee. Mr. Miller and Mr. Cary were asked if NSA's files on the subject contained any such information. Mr. Cary stated that he had been assured by the NSA General Counsel that there was nothing in their files. Mr. Miller confirmed this and stated that their review of the NSA material had indicated no references to senatorial improprieties. Stevenson asked Miller to double check with NSA on this subject since it seems strange that the Koreans were so successful in cultivating Congressmen and not Senators.

4. Earlier, Senator Schmitt had asked if the Agency files had contained any references to former Senator Thomas Kuchel who apparently has an active lobbying practice in Washington. Senator Stevenson requested that the Agency check its files for any information on ROK connections with the firm of Wyman, Bautzer, Rothman and Kuchel of 600 New Hampshire Ave. Northwest, Washington, D. C. He also asked for any information on other U.S. firms who had represented the Korean Government. We informed the Senator that it was our recollection that while there were references to U.S. firms in our files, specific names were not included. We also suggested that the Senator might wish to levy this request on the Department of Justice since such firms would have to register under the Foreign Agent's Registration Act. The Senator said they would be in touch with the Justice Department on this subject.

5. In reviewing the material which had been made available to them, Senator Schmitt asked for any background as to the sponsors of the Friends of Free Asia and also was assured that this information would be made available to him.

6. At the conclusion of the meeting, the Senators thanked Mr. Cary and Mr. Brewster for their assistance, and stated that they felt that their questions had been answered and, for the moment, no further action by the CIA was necessary.

The Select Committee on Assassinations has subpoenaed Santos Trafficante to appear before it. His appearance is scheduled for Wednesday, November 2, 1977 at 9:30 a.m. It has been alleged from numerous sources that Mr. Trafficante was involved in various activities in conjunction with the Central Intelligence Agency.

I would appreciate it if you could determine whether or not Santos Trafficante, in any manner, had any relationship or was ever affiliated with the CIA and inform me of this information prior to the scheduled meeting on November 2.

Further, even if Mr. Trafficante had no relationship with the CIA, he may believe that actions he has taken were at the direction of responsible persons in the Central Intelligence Agency. Accordingly, in order for the Select Committee to obtain Mr. Trafficante's truthful testimony, it would be most useful for the Committee to have a letter from yourself releasing Mr. Trafficante of any obligation of secrecy he may have made to the CIA, to anybody who represented himself as being affiliated with the CIA or to anybody Mr. Trafficante believes was affiliated with the CIA. It would be very much appreciated if we could have this letter prior to Mr. Trafficante's scheduled testimony.
