11. (Unclassified - RSG) LIAISON Called Mike Glennon, on the staff of the Subcommittee on International Operations, Senate Foreign Relations Committee, to indicate that we had ready for his review materials in response to his 19 December request. Glennon responded that he would schedule a meeting next week, and that he would be accompanied by John Ritch, also of the Subcommittee staff.

12. (Unclassified - RSG) LIAISON Took a call from G. Robert Blakey, Chief Counsel and Staff Director, House Select Committee on Assassinations, who inquired whether Lee Harvey Oswald or James Earl Ray had ever had a psychological profile prepared by CIA. I responded that we had nothing on Oswald but that we had handwriting analysis on Ray. House Select Committee on Assassinations will put this request in writing. We are retrieving from Archives the Ray analysis. This information was provided by OIG, OMS, and and OTS.

✓ 13. (Unclassified - THW) LIAISON I called Jim George, on the staff of the House Government Operations Committee, and told him that we had no unclassified information on the Soviet Navy and suggested that he might want to check with the Department of Defense and/or DIA. He thanked me for my help.

14. (Secret - THW) LIAISON Benjamin Forman, Office of General Counsel/OSD, called to review with me the request set forth in the letter from Senator William Proxmire (D., Wis.) regarding the confirmation hearing of G. William Miller as Chairman of the Federal Reserve System and asked if we had any problem with his including a short statement from a CIA report that General Mohammed Khatami was the owner of Air Taxi Corporation. I told him that we had no problem with his including that information and I asked if he had any problem with our including in our letter to Senator Proxmire the same information we obtained from a DIA report. After checking with the General Counsel, he called and said that we could use the information from the DIA report in our unclassified response to Senator Proxmire.

✓ 5. (Secret - PLC) LIAISON Rodger Carroll, GAO employee detailed to the House Government Operations Subcommittee on Legislation and National Security who is conducting an inquiry on behalf of the Chairman to determine if CIA had given any preferential treatment in the awarding of contracts to E-Systems, met with me and noted that he is nearing the completion of his inquiry and agreed that before he gives his report to Chairman Jack Brooks, which he will either give as a short summary or orally, he will clear it with the Agency. He confirmed that he has not and will not discuss the results of his inquiry with any other member of the staff other than the Chairman. He gave no indication of the conclusions that he is reaching and said his conclusions will be made known to the Chairman, but not the Agency. Carroll requested whether CIA has any entities which are in any way connected with E-Systems and asked specifically if the BETEC Corporation, 1801 North Kent St., Rosslyn, Virginia, was such an entity. He noted he is aware that the Agency has proprietaries and he wants to be absolutely sure that no such entity exists with E-Systems. I told him I felt certain that none existed, however, I would make appropriate checks for confirmation.

6. (Unclassified - PLC) LIAISON Received a call from Gary Cornwell, Deputy Staff Chief, House Select Committee on Assassinations, inquiring as to the status of the Director's letter responding to Chairman Louis Stokes' letter setting forth revised procedures for the review of CIA documents. I told him the letter had been sent to the Director's office this morning and should be signed by the end of the day. Cornwell said that he and Counsel Jim Wolf, will be out in the morning to discuss the Committee's review of Senate Select Committee on Intelligence transcripts on assassination and problems that both the Agency and the Committee may be facing under the Freedom of Information Act when the investigation is completed. An expert on FOIA and congressional documents from OGC will be present.

7. (Unclassified - PLC) LIAISON J. J. Hitchcock, State Department, called and requested a copy of the Agency's Memorandum of Understanding with the Senate Foreign Relations Subcommittee on International Operations in connection with the Subcommittee's KCIA inquiry. Hitchcock wants to use this as a model to prepare a Memorandum of Understanding between State and the Subcommittee. A copy was LDX'd to Hitchcock. Hitchcock said that the Department has little, if any, documents reflecting State's association with the foreign intelligence services of interest to the Committee. He informed me that he will exercise the Third Agency rule for any CIA documents in State's possession and will refer the Subcommittee to CIA.
