1. An intensive search of the files and indices of this Directorate has surfaced 12 documents pertaining to correspondence between the Federal Bureau of Investigation (FBI) and the Central Intelligence Agency (CIA) concerning Dr. Martin Luther King. The time frame of this correspondence extends from before to after Dr. King's assassination. These documents, which are summarily capsulized below, indicate the extent and nature of contact between CIA and the FBI regarding Dr. King.

2. The context of the surfaced documents mentioned above concerns Dr. King's associations, discussions, travel and items possibly related to his assassination. The subject matter, briefly, is as follows:

- a) discussions with one C.L.R. James *minor mention (FBI memo)*
- b) correspondence from one Paul Krassner concerning an interview with King. *minor part of it*
- c) travel to European countries
- d) alleged meeting with members of the Italian Communist and Socialist Parties. *cut to FBI*
- e) a request from a union leader asking King to grant an audience with Josiah Mwangi Kariuki, a member of the Kenyan Parliament
- f) departure schedules for European trips *(FBI to State)*
- g) planned appearance at Oslo, Norway rally. *original source?*
- h) fund raising activity by Southern Christian Leadership Conference (SCLC) in behalf of King's proposed trip to the Holy Land. *(FBI, property to cut for info)*
- i) request for King and Dr. Benjamin Spock to visit England for meetings aimed at campaigning against the Vietnam War. *(FBI, property to CIA for info)*
- j) a plot by a female Dominican Republic citizen involving Stokely Carmichael and H. Rap Brown, to assassinate King. *from FBI to CIA for info*

- ✓ k) reaction to King's assassination by Carmichael, Floyd McKissick and others, ^{FBI stuff} as aired on Havana Radio. ~~At Miami cable~~
- ✓ l) a 1964 offer of employment to a Panamanian national who, in retrospect, believed it was an assassination plot. ^{good CIA memo to FBI}
