(C) Assuming OGC has no objections, John Turnicky (DD/CCS/PS) also has no objections to these two outstanding requests from DOJ if DOJ has agreed to: 1) respect CIA's classification decisions; 2) handle all CIA provided material "for lead purposes only;" and 3) coordinate with CIA for CIA's concurrence before releasing any CIA provided material publicly. DOJ should be told that the results of any interview of the examiner who conducted Mr. McCollough's EOD polygraph examination will need to be treated as classified until CIA has an opportunity to review the material for disclosure of sensitive CIA polygraph methodologies. Also, DOJ also needs to understand that Mr. McCollough's 1989 BI was conducted under DoD cover. As a result, the results of the O'Brien interview will also need to be treated as classified pending CIA review.

(C) Hans G. Bialasik was Mr. McCollough's EOD poly examiner. He retired from CIA in October 1996 as an overt Agency employee. His last known address is 1809 Sycamore Valley Drive #302, Reston, VA 22090 (tel: 703-787-9178). I'll fax you a copy of the 89 BI. However, does DOJ really want the whole BI report or just the interview of William Hicks?
