Dear Mr. Caudle:

In response to Barry Kowalski's letter to Guy Watts, CIA, Office of General Counsel, dated December 22, 1998, your office made Marrell McCollough's personnel, security and polygraph files available for our review and we greatly appreciate that assistance. In addition, however, we need copies of certain materials relevant to the conduct of the criminal investigation initiated by the Attorney General regarding new allegations related to the assassination of Dr. Martin Luther King Jr. It is our understanding that none of the materials we seek to copy are classified.

Therefore, to comply with the requirements of the Privacy Act, we are making this formal inter-agency "law enforcement request" for materials in accordance with 5 U.S.C.§ 552a(b)(7).

The following is a list of the items that we are requesting to copy:

- 6. Routing and Record sheet dated 9 Oct 93;

- 7. Personal History Statement dated 23 Aug 73; and
- 8. Appointment Affidavit dated 24 Jun 74.
- B. From Mr. McCollough's security file the following documents:
  - 1. 16 May 1973, letter from F.J. Warner; and
  - 2. 15 May 1989, internal letter to Headquarters.
- C. From Mr. McCollough's polygraph file:
