She then asked why they celebrated the death of a negro and did not celebrate the death of a president.

Our indices are negative on DOLLY RAY.

ON DECEMBER TWELVE, SIXTYSEVEN, INDIVIDUAL USING NAME WALTER R. JENNINGS, ACCOMPANIED BY ONE "BILL", RENTED HOUSE ON PROPERTY OF THOMAS SAND AND GRAVEL COMPANY NORTH OF SALT LAKE CITY. JENNINGS IN POSSESSION OF WHITE DELIVERY TRUCK, WITH OUT OF STATE LICENSE. "BILL" DRIVING NINETEEN FIFTYSEVEN TWO-TONE CHEVROLET. WHEN THEY MOVED IN, RENTAL SIGN ON HOUSE WAS TURNED OVER AND "TOPAZ MINING COMPANY" WRITTEN ON REVERSE. NO RECORD THIS COMPANY OPERATING IN UTAH. Denver T-1, who has furnished reliable information in the past, advised during the early morning of April 5, 1968, that Lauren Watson, self-described leader of the Black Panther Party and Negro militant, participated in a meeting the evening of April 4, 1968, at which time plans were made for action in Denver to honor Martin Luther King, Jr., who was assassinated the afternoon of April 4, 1968. Denver T-1 advised that as of 8:30 A.M., April 5, 1968, Watson and approximately twenty Negro young adults and youths were marching to Manual and East High Schools, where there are considerable Negro students enrolled, to demand that the schools be closed in memory of King.

The April 5, 1968 issue of the "Denver Post," a Denver daily newspaper, indicated that Joe Brown, publisher of the "Denver Blade," a Negro newspaper, reported that at a meeting held at 3224 Dahlia Street the evening of April 4, 1968, of about sixty members of a new organization called the Black-Brown Unity Council, a list of demands had been drawn up. Brown reported that the new group is being led by Rudolph "Corky" Gonzales and Lauren Watson, representing the militant factions of the Spanish-surnamed and Negro communities respectively. Cornelius Webb, a spokesman for the group, read the demands, which are as follows:

---Communications consisting of a Negro radio station, for which application is on file with the Federal Communication Commission. Webb said the group hopes the application will be acted on immediately.

---Flags to be displayed in Denver at half-staff for one month.

---Boycott of all schools and stores for "several days" to emphasize the need for justice and fair play from a racial standpoint.

---A march, scheduled to start at 10 a.m. Saturday at Fuller Park, E. 28th Ave. and Williams St., to the Denver Civic Center.

It was reported that Webb, in making the announcement, said, "These are not requests, but demands that will be met by any means possible in honor of the late Dr. King. It is hoped that these proposals will be met in a respectful and peaceful manner appropriate to the principles he stood for."

Richard Genser, student teacher at Cole Junior High School, Denver, advised on April 5, 1968, as follows:

At 9:00 a.m. on April 5, 1968, at Cole Junior High School everyone was in class. A large group of youths began coming in and out of the school. A tall Negro man wearing a goatee and moustache came into the school and wanted to talk with the principal. Genser said it looked as though this individual was attempting to get all of the students released from school for a mass meeting.

At 9:15 a.m., a large group from Manual High School came to Cole and stirred up the students, who began running out of the building and several students were injured.

At 9:30 a.m., six Negro men in their late twenties or early thirties, well dressed and driving a late-model blue Cadillac, came down 32d Street and stopped in front of Cole Junior High School. These men managed to get numerous junior high school students and also students from Manual High School to follow them to a small park within walking distance of the school. The majority of students from each school left to go to the small park.

On April 5, 1968, a Special Agent of the Federal Bureau of Investigation observed approximately 100 Negro youths and young adults enter Curtis Park Community Center located at 29th and Champa Streets at approximately 10:00 a.m. At approximately 10:30 a.m. this group left the Community Center and dispersed.

Denver Chief of Police George L. Seaton advised at 10:00 a.m., April 5, 1968, that Negro students were leaving East High School in Denver and some of them had congregated on East Colfax near the high school. He stated he had received reports that some of these students had broken windows in business establishments in the vicinity of East High School.

At 10:50 a.m., April 5, 1968, a Special Agent of the FBI determined that windows were either cracked or broken in five different business establishments in the 2800 Block of East Colfax Avenue. A large number of Negro high school students were gathered around the area of East High School at this time. This croud of Negro youths were heard to be chanting some unknown phrase. Officers of the Denver Police Department were on the scene observing the youths.

Reverend C. B. Woodrich, 3621 Humboldt Street, Denver, advised on April 5, 1968 that he learned through sources that "militant Negro leaders" were endeavoring to organize high school and young Negro adults to participate in some type of violent demonstration.

On April 5, 1968, James Jordan, Arson Investigator, reported that the Denver Fire Department had responded to numerous false alarms, including alarms set off at East and Manual High Schools.

It was reported in the April 5, 1968 issue of the "Denver Post" that a group of fifteen to twenty Negroes, all 16 to 21 years of age, entered the Boy's Store, 5701 East Colfax Avenue, at 11:00 a.m. (April 5, 1968), and stole fifteen to twenty pairs of pants and about eight suits. It was further reported that there were unconfirmed reports of looting along 16th Street in downtown Denver and at East Denver liquor stores.

It was also reported that three white staff members of the George Washington High School newspaper, the "Surveyor", reported

they were attacked by four Negro youths on the school parking lot.

It was further reported that windows were broken at the Red Barn Restaurant, 2975 East Colfax Avenue.

The April 5, 1968 issue of the "Denver Post" reported that five Denver County schools with substantial Negro enrollments closed on that date as an aftermath to the killing of Dr. King.

It was reported that Manual High School was the first to close. Principal James D. Ward said many students and a number of persons living in the neighborhood asked if the school could be dismissed out of reverence to King. It was reported that a false fire alarm was turned in from the school moments after it opened at 8:00 a.m. Ward indicated that Manual is 70 per cent Negro.

It reported that Howard Johnson, Assistant Superintendent of the Denver Public Schools, informed the principals of the following schools that they could dismiss the schools if they wished. Those doing so were:

East High School
1545 Detroit
36 per cent Negro

Smiley Junior High School
2540 Holly Street
66 per cent Negro

Cole Junior High School
3240 Humboldt Street
65 per cent Negro

Morey Junior High School
840 East 14th Avenue
53 per cent Negro

It was further reported that youths from outside visited these schools and demanded they be closed. There were some fights between students of different races and some fire alarms were pulled.

It also reported that Philip G. Serafini, Principal at Cole Junior High School, stated that seven or eight Negro adults visited his office and demanded that he close the school. When he was asked if threats were made to him, he replied, "Well, they were very firm."

It reported that at East High School a group of adults walked into the auditorium at the close of a memorial assembly for King and some Negro youngsters were forcibly dragged from the seats and told they should attend a rally in Curtis Park.

Re: Lauren Ralph Watson

On December 22, 1967, Denver T-1 advised that on December 16, 1967, Lauren Ralph Watson, 1728 Downing Street, Denver, a militant black nationalist Negro leader, made the statement that he, Watson, planned to travel to Cuba in January 1968.

On March 26, 1966, Special Agents of the FBI observed Lauren Watson speak at an anti-Vietnam war demonstration held on the State Capitol grounds in Denver, Colorado. In his speech Watson stated that while American Negroes are forced to go hungry in the United States, millions of dollars are being poured into the war in Vietnam to keep the people in that country divided. Watson stated that no American Negro should participate in the war in Vietnam. Watson urged all Negroes to refuse the draft and not volunteer for military service because "their war is in this country."

On August 6, 1966, Special Agents of the FBI observed Watson make a speech at an anti-Vietnam rally held at the State Capitol, Denver, Colorado. At this time Watson said, "the white structure has trained Negroes in how to use guns and to kill in Vietnam. When they come back to the United States, watch out, Whitey!"

The May 7, 1967 issue of the "Denver Post" reported on a black power symposium held at the Black Forest Camp

on May 6, 1967. It reported that Lauren Watson was present and stated that he had recently formed the Black Panther Party, a militant Negro group.

Re: Rudolph "Corky" Gonzales

Denver T-2, who has furnished reliable information in the past, advised on January 25, 1967, that Rudolph "Corky" Gonzales is the director of the Crusade for Justice.

The Crusade for Justice is a national civil rights organization that has been created for and by the people. The movement was born out of frustration and determination to secure equality with dignity for the Mexican-American and Spanish-named people of the City of Denver, the State of Colorado, and the entire Southwest. The Crusade for Justice has stimulated action, has involved heavy participation in all community affairs, has inspired new pride and confidence, and has motivated and encouraged leadership and organization in our community.

Denver T-3, who has furnished reliable information in the past, reported on October 24, 1967, that Rudolph "Corky" Gonzales talked at an anti-Vietnam war protest and rally on October 15, 1967 at the East Los Angeles College Stadium, Los Angeles, California. At this meeting Gonzales said President Johnson was a "murderer" and that Johnson's policies in the Vietnam war were policies against the color of people's skins, "yellow, black and brown." Gonzales reportedly called for a revolution to remove the present Government from office. He stated that peaceful policies and demonstrations used up to the present time had not worked. He stated that the time had come to use violence to achieve the demands of the minority. He stated that all minorities would resort to violence and revolution and all cities in the United States would burn.

On April 6, 1968, Special Agents of the FBI observed a group of Negroes gather at approximately 9:50 a.m. at 28th and Williams Streets in Denver. At about 10:15 a.m. this group began to line up in the street, at which time Denver police officers gave them an escort and blocked the streets. The group, made up of approximately 75 to 100 Negroes, proceeded from 28th and Williams west on East 28th Avenue to Welton Street, to 23d Street, to California Street, and then east on East 31st Avenue to Skyline Park located near East 33d Avenue and Holly Street. At the time the march ended there were approximately 60 to 70 individuals. Lauren Watson and Rudolph Gonzales took part in the march. The march terminated at approximately 12:40 p.m.

On April 7, 1968, the "Denver Post" reported regarding the march from 28th and Williams that the march was late in getting started because the leaders refused to tell white policemen the route the procession would follow. After a Negro patrolman arrived the leaders then outlined their plans to him. Several white reporters and photographers were told by Negro leaders that "we don't want any white reporters or policemen bothering us." It reported that a carload of Negroes took two rolls of film away from a "Denver Post" photographer and threatened a "Rocky Mountain News" (a Denver daily newspaper) photographer. It reported that among those marching were Dave Butler, local black power leader, Rudolph "Corky" Gonzales, chairman of the Crusade for Justice, and Colorado State Senator George Brown of Denver. It further reported that throughout the hike the marchers had been silent except for their attempt to get others to join them.

The April 5, 1968 issue of the "Denver Post" reported that the Core-City Ministries, an interdenominational group, planned two demonstrations to demonstrate the white community's willingness to take responsibility for the death of Dr. Martin Luther King. The first march was scheduled to begin Friday noon, April 5th, at the Denver Civic Center. The second march was scheduled for April 6, 1968 from Loretto Heights College, 3001 South Federal Boulevard, to the Cinderella City shopping complex in Englewood, Colorado. It was reported that the shopping center complex was chosen because of labor difficulties of Negro janitors recently at the shopping center. It also reported that The Reverend Craig Hart stated that approximately 1,000 handbills were distributed on the downtown streets of Denver to publicize the Friday (April 5, 1968) demonstration.

A Special Agent of the FBI obtained a leaflet on April 5, 1968, which was being distributed during the morning hours of April 5, 1968. This leaflet contained the following information:

Special Agents of the FBI observed on April 5, 1968, that approximately 200 individuals participated in a memorial service at the Civic Center, Denver, for Martin Luther King.

On April 5, 1968, Denver T-4, who has furnished reliable information in the past, reported that at the Civic Center demonstration mentioned above one Peter Praetz stated that there would be a march on April 6, 1968 from Loretto Heights College to Cinderella City, Englewood.

The April 7, 1968 issue of the "Denver Post" reported that approximately 400 persons walked from Loretto Heights College to Englewood, Cinderella City shopping complex. It was reported that the individuals marched not only in memory of the slain civil rights leader but in repentance for the guilt of the white man. It reported that some of the signs that were carried stated "We Are All Murderers."

On April 5, 1968, James Jordan, Arson Investigator, Denver Fire Department, advised that three Molotov cocktails were thrown through a window of the Annunciation Parochial Grade School located in a predominantly Negro and Spanish-American neighborhood in Denver. He reported there was very little fire damage.

James Jordan, on April 5, 1968, reported that a Molotov cocktail made from a large Coke bottle and gasoline was thrown through a window of the Annunciation High School. He reported moderate damage to the window frame, a table, the floor, and ceiling of a room in the high school.

On April 6, 1968, James Jordan reported that the Denver Fire Department had on that date recovered a possible explosive device which had been located near a parking ramp at the Cinderella City shopping center, Englewood, Colorado.

James Jordan reported on April 8, 1968, that at 11:00 p.m. on April 7th a single Molotov cocktail had been thrown against the door of the Lincoln Cut-Rate Market, 704 East 25th Avenue, Denver. He reported there was no damage except scorched paint on the door.

Mr. Jordan also reported on April 8, 1968, that one or more Molotov cocktails had been thrown through a plate glass window of the Ace Market, 1304 East 22d Avenue, Denver. He estimated the damage to the store as between \$2,000 and \$3,000.

FBI Is Mum On Clues to King Slayer

WASHINGTON, April 9—Five days after the slaying of the Rev. Dr. Martin Luther King Jr., the FBI does not know where the killer is, and it may not know for sure who he is.

"We are continuing the investigation in every which way and direction," was all an FBI official would say Tuesday despite earlier statements by Atty. Gen. Ramsey Clark which had indicated the case would be solved quickly.

At a press conference in Memphis last Friday—the day after Dr. King was slain—Clark was quoted as saying he was "Confident" of a quick solution.

Sunday Clark maintained his optimism, saying: "Our judgment of the evidence at this time is that we have evidence of a man on the run."

"We know quite a bit more today than we knew two days ago and we hope we can show you a picture of exactly what he (the assassin) looks like before too long," Clark said.

Successful Conclusion

"We have a very substantial amount of physical evidence. We remain optimistic and, as I said in Memphis Friday, are very hopeful that we can have an early and successful conclusion to our investigation followed by indictment, prosecution and conviction."

But Clark warned against over-optimism. He said:

"The focus is sharpening and we are quite close, we think, but that depends upon how some of the leads that we have develop. And to get too optimistic wouldn't be fair."

Some officials here said Tuesday that, while Clark's earlier statements may have been too optimistic and therefore perhaps misleading, they were based on information from both local and federal law officers and almost certainly reflected the attorney general's anxiety to display a calm, positive attitude.

The suspect was described by several credible witnesses, including the manager of the rundown rooming house from which was fired the single fatal shot at Dr. King as he stood on his Memphis motel balcony.

'We Have a Name'

On Sunday Clark said: "We have a name. Whether it will prove to be the correct one or not remains to be seen."

Indications Tuesday were that Clark was depending on evidence left behind by the suspect to establish his real identity. The suspect had checked into the rooming house under the false name of John Willard.

"There are a number of studies of prints that may establish an identity, but there is nothing definite at this time," Clark had said the day after Dr. King's murder.

Since then, the Memphis police, FBI and Justice Department officials have refused officially to discuss prints and other physical evidence—including a rifle and blue overnight bag containing some clothes—left behind by the suspect.

Not Yet Been Matched

The rifle and bag are undergoing analysis at FBI laboratories here. And although it was reported that a handprint and thumbprint were found, they apparently have not yet been matched with prints in FBI files here.

A spokesman said the FBI has 186 million fingerprints on file and that when it is not clear which finger a suspect's print is from, trying to match them is a tortuous, time-consuming process.

The FBI also has refused to comment on reports it has asked Mexican authorities to aid in the search. Police in Mexico said Tuesday that a drawing of the suspect had been distributed throughout Mexico and at border crossing points.

But FBI spokesmen clearly indicated the search has extended far beyond the initial state area (Tennessee, Alabama, Arkansas, Kentucky, Mississippi, Missouri) staked out by investigators soon after Dr. King's death.

Dr. King Given Tearful Farewell

ATLANTA, Ga., April 9 — (AP) — "Peace be to his ashes, rest to his soul. Amen." Thus ended a day of tribute to Dr. Martin Luther King Jr.

The Rev. Ralph D. Abernathy, King's successor as president of the Southern Christian Leadership Conference, spoke the final words with tears as Dr. King's body was laid to rest at 5:20 p.m. in a crypt at South View Cemetery Tuesday.

Mrs. King sat dry-eyed throughout the graveside ceremony on the front row of seats with singer Harry Belafonte. Her composure wavered and she began to weep silently.

Dr. King's father, the Rev. Martin Luther King Sr., wept openly. When the body was placed, he stood and put his head on the crypt, weeping. Throughout the long day, Rev. Abernathy had kept his composure. But he began to weep as he began the graveside

ceremony.

"The soul of this great man and this great person ... is now in the hands of the eternal God," he said. "We therefore commit his body to the ground. The grave is too narrow for his soul but we commit his body to the ground.

"Earth to earth, ashes to ashes and dust to dust.

"We commend his deeds to all mankind, his services and sacrifices to all generations.

"We give thanks to God who gave us a peaceful warrior who was willing to die but not willing to kill.

"Peace be to his ashes, rest to his soul. Amen."

Then Dr. King's body was placed in the modern, Georgia marble crypt, its temporary resting place until the family decides on a permanent site.

Six hours and 35 minutes of memorial acts were at an end. The weeping Rev. Abernathy was led from the lectern.

150,000 Pay Final Tribute to Dr. King

ATLANTA, April 9—(UPI)—The body of Dr. Martin Luther King Jr., flanked by the great and humble, 150,000 strong, was borne through the streets of Atlanta on a mule-drawn cart Tuesday in a funeral tribute unprecedented in the nation's history.

He was laid to rest at 3:19 p.m. (Denver time) in a white marble crypt inscribed with a refrain from an old slave song:

"Free at last, free at last,
"Thank God Almighty, I'm free at last."

With his family and thousands of mourners jammed into the cemetery, Dr. King was interred with a solemn reminder from Rev. Ralph Abernathy, one of his longtime aides, that the slain civil rights leader is "now in the hands of the eternal God."

"We therefore commit his body to the ground. The cemetery is too small for his spirit, but we commit his body to the ground. The grave is too narrow for his soul, but we commit his body to the ground. No coffin, no crypt, no stone can hold his spirit but we commit his body to the ground."

Mrs. King and Her Children

After Dr. King was interred, Mrs. King and her children arose from their chairs, walked to the crypt, and touched it.

Scores of persons later crowded around the crypt to pluck flowers, bits of ribbon and sprigs of fern for souvenirs.

Many grim-faced, others sobbing, Americans, black and white, came by the tens of thousands to pay their final respects to the integration leader who was killed by a sniper's

bullet while in Memphis last Thursday to lead a protest march for striking sanitation workers.

The mourners — officials estimated there were 150,000 of them — walked with the creaking, mule-drawn wagon, some of them singing the "anthem" of the civil rights movement, "We Shall Overcome," and others striding along with arms linked in a symbol of brotherhood.

The procession, a sea of humanity stretching out for four miles, wound its way from Ebenezer Baptist Church, where Dr. King's father is pastor, to the quadrangle on the Morehouse College campus, resplendent with the pink and white blooms of dogwood, the "crucifixion flower," and the fresh green grass that bid for life in the warm, spring sunshine.

Cortege Reached Campus

The cortege reached the campus for the public services after a 2-hour procession through the streets.

The crush of humanity was so great outside the college gates that the mule train, with Hosea Williams, a King aide, leading the animals by their halters, was unable for a time to get through.

Once inside the grounds, the African mahogany casket was hoisted atop a platform covered by a blue cloth.

Temperatures climbed into the 80s and as mourners swarmed around the casket, those at the speaker's stand urged: "Get back please. My friends, this is a worship service and I

(Continued from page 3) know we all knew and loved Martin Luther King and all wish to make our expressions, but let's all make them as orderly as possible."

During the main eulogy, Benjamin Mays, president emeritus

of Morehouse College and the man who steered Dr. King into the ministry, praised the slain Nobel Peace Prize winner as a "prophet of the 20th Century" and "champion of all."

He noted that he had promised to preach Dr. King's eulogy in the event Dr. King died before he did. But he said because of his 73 years, compared to Dr. King's 39, he never expected to be called upon.

Mays said it was like asking a man "to eulogize his own son—so precious he was to me."

Negro spiritual singer Mahalia Jackson, wiping tears from her own eyes, sang the hymn that Dr. King requested just before his death, "Precious Lord Take My Hand."

Never in the history of the nation had there been such an outpouring of mourners and tributes for a person outside government. Much of Atlanta suspended business operations and ambassadors and representatives from foreign lands streamed into the city to pay their last respects.

Skies Darkened

The service finally ended at 2:17 p.m. (Denver time). By this hour the skies had dark-

ened and thunder rippled overhead.

Dr. King's body was carried to a waiting hearse and taken to South View Cemetery, south of the city. The cemetery was founded in the 1890s by Negroes who rebelled at being asked to bring their dead through the rear entrance to the city's main cemetery.

Earlier, a private funeral service attended by the fami-

ly, close friends and dignitaries who flocked in from around the World was conducted at Ebenezer before the body was put aboard the mule train.

Rev. Ralph Abernathy, in a final tribute, said the body was going "from the sanctuary of this church . . . to the people who say that Martin belongs to them."

The little Ebenezer Church, which seats 1300, was jammed to the overflow point for the private ceremonies. Vice President Hubert H. Humphrey, steered secretly through the crowd and apparently brought in through a rear entrance, represented President Johnson and the nation.

Among Notables

Among the notables who attended the rites were Mrs. John F. Kennedy, wearing a black veil; Sens. Robert F. Kennedy of New York and Edward M. Kennedy of Massachusetts; Sen. Eugene J. McCarthy of Minnesota; former Vice President Richard M. Nixon; Gov. Nelson A. Rockefeller of New York; former Gov. Carl E. Sanders of Georgia and Gov. George Romney of Michigan.

Mrs. King, dressed all in black, sat with her four children, Martin Luther III, 10, Dexter, 7, Yolande, 12, and Bernice, 5. The two girls, in contrast to the sober garb of the rest of the family, were in white, and the youngest, Albin, in white and the youngest, Albin, had two big bows in her hair. Mrs. King's black-gloved hand occasionally reached out to calm or caress the child as she started to fidget. The child finally fell asleep.



March Will Underline Move to End Racism

A march through downtown Denver to demonstrate white determination to eliminate racism in America is scheduled for Monday night by the Denver Core City Ministry.

The march is to start at 7 p.m. at 15th and Arapahoe Sts.

A press release from the bi-racial organization said "we acknowledge that our society is a sick society, that it is infected with the cancer of white racism,

that every one of our institutions, without exception, is infected at its roots and must be changed."

Calling on whites to attend the march, the announcement said a policy of "continued direct action" is necessary to remove every trace of racism from American institutions.

The ministers demanded that Tuesday be devoted to seeking policy decisions necessary to change the direction of society:

"We will stay off our jobs and publicly demonstrate that a dramatic change—as dramatic as taxing ourselves of our profits—is the only way that white America can become itself."

The Rev. Craig Hart of Annunciation Catholic Church said it's hoped normal business and community life will be shut down Tuesday for discussions of what can be done.

The march and hoped-for business closing Tuesday, he said, won't be simply another memorial for the Rev. Dr. Martin Luther King Jr. The need now is to plan action, he said.

The march is to go from downtown to Civic Center and, perhaps, to Metropolitan State College for a meeting.

Father Hart said most marchers are expected to be white, as they were in a march Saturday from Loretto Heights College in southwest Denver to Englewood — the Cinderella City shopping complex.

In another aftermath to King's assassination last week, a bi-racial group calling itself the Clearing House for Concerned People said it would give information by telephone to people who want to do something in King's memory.

The group is providing information on legislation pending in Congress and names and addresses of Colorado congressmen. Its telephone numbers are 323-7876 and 244-8659, and it will operate until 9 p.m. Monday and between 9 a.m. and 9 p.m. Tuesday.

Herrick S. Roth, president of the Colorado Labor Council, AFL-CIO, said all union officers have been asked to suspend union business Tuesday and meet at the Denver Labor Center, 360 Acoma St., at 10 a.m. for a two-hour meeting.

In addition to a Sunday me-

morial in Denver's Civic Center, services in honor of King were held elsewhere in the state.

More than 3,000 persons joined in prayer and hymn-singing at the Broadmoor Hotel in Colorado Springs for a two-hour service Sunday afternoon. It was conducted by the Rev. Milton Proby, pastor of St. John's Baptist Church, and Dr. Robert Bowman of All Saints Unitarian Church.

An estimated 1,500 persons marched through Boulder to a memorial service at the First Methodist Church.

At the University of Colorado a special memorial service is

planned for 11 a.m. Tuesday in Mackey Auditorium, and a series of seminars to discuss

King's life and the problems of the Negro is scheduled for the afternoon.

There will be no classes at Colorado State University in Fort Collins Tuesday, permitting students to participate in memorial services for King.

All CSU nonacademic departments will remain open, but Dr. A. R. Chamberlain, executive vice president, said supervisors were told to exercise a liberal policy of permitting employees time to observe any services for King.
