On April 22, 1968, SA BILL E. PEMBERTON attempted to contact Mrs. DORIS BYERS, 1130 Logan Street, Denver, Colo. The manager of the apartment building located at 1130 Logan, advised that Mrs. BYERS works during the day and could be contacted after 6 o'clock.

The apartment manager was displayed photograph of ERIC STARVO GALT and questioned as to whether a tenant in the building, ROBERT CATHEY, resembled the photograph of GALT. The apartment manager stated in his opinion the FBI Wanted Flyer photograph of GALT did not resemble ROBERT CATHEY. The manager advised that CATHEY at present is not employed, and in fact, was visiting the apartment manager and his wife at the time of the interview.

ROBERT CATHEY was interviewed at 1130 Logan, Denver, and advised that he was in Denver seeking employment and making preparations to attendathe Colorado School of Trade, Gunsmithing school, in the summer of 1968. CATHEY advised that his date of birth is and he was employed by the Louisiana State Patrol from January 10, 1961, to April 21, 1968. He also stated that he has been in the area prior to April 21, 1968, but was on vacation from the Louisiana State Patrol; and his resignation was not effective until April 2, 1968. He further stated that his family resides in Arcadia, Louisiana and that as soon as he finds gainful employment, he plans to bring his family to Denver to reside with him.



Ray Sought King Bounty,' Buddy Says



DALTON, Ga., April 23—(UPI)—A rison buddy of James Earl Ray said luesday when Ray heard there was a million-dellar bounty" on Dr. Martin Luther King Jr., he smiled and said "I'll collect it."

Ray, a 40-year-old fugitive from the Missouri State Prison, is accused by the FBI of assassinating Dr. King in Memphis on April 4.

In Atlanta, it was learned Tuesday that the FBI had investigated reports that Ray, masquerading as Eric Starvo Galt, met two women in a hotel the weekend after the slaying.

The FBI impounded three water glasses from the Briarcliff Hotel the week Dr. King was buried and showed a desk clerk pictures of Galt. The clerk said he recognized the picture as the man who rented the room the Sunday after the slaying.

The next day an attractive young brunet arrived at the room and the following day another young woman, wearing steel-rimmed glasses and dressed like a hippie, joined the other two, the clerk said.

The FBI has interviewed two Atlanta cab drivers who said they drove a man resembling Galt around the hippie district about the same time.

In the Dalton jail, Raymond Curtis, awaiting appeal on a murder sentence, said he

has known Ray in the Kansas City jail, in federal prison at Leavenworth, Kan., and in the state prison at Jefferson City, Mo.

He described Ray as likeable, addicted to "dope," a "loner" and a man concerned only with money

On the day President Kennedy was assassinated-Nov. 23, 1963-Curtis said he, Ray, and about 150 other prisoners were in an exercise yard when they heard the news.

He said Ray remarked "Well, somebody

made a pretty penny on that." About a week later, Curtis said, he and Ray were in the yard when "a new man just in off the street" told them "the businessmen's association has a million dollar bounty out for

Martin Luther King. Ray smiled, Curtis recalled, and said "If there's a million dollars out for King, I believe

if I ever get out I'll collect it.' Curtis said he never figured out what the 'new man' meant by the "businessmen's as ociation." He said he couldn't remember who he man was.

"I didn't think much about it at the time. In prison, you hear all sorts of hellacious ideas, said Curtis, a tall, rawboned man.

Authorities in Jefferson City confirmed that Curtis and Ray were in prison at the san time. Authorities in Dalton said the FBI has interviewed Curtis on Sunday and again Mo day night. It refused comment on the matter.

Curtis said Ray told him "he always carried a gun. He was always interested in money," Curtis said, but never mentioned racial matters.

"He never made no statements of any kiad a group," Curtis said. "He was a loner.

Ray couldn't "make a long conversation less he was planning something," said Curas. "If he was planning something, you could bet they'd be thorough plans." Ray, he said, masterminded things "that would be small things outside, but were pretty big jobs in prison" such as the theft of eggs and drugs and cigar-

He said Ray told him that if he ever wanted to kill someone, he would buy a gun under a false name, and have everything ready for an escape. "He used to talk a lot about escaping to New Zealand, Brazil and Argentina," Curtis

"I wouldn't consider him dangerous," Curtis said. "He didn't look for trouble

"Of course, I'm not saying he wouldn't shoot you if you ran up on him now."

Curtis said he first met Ray in 1955, when he was serving time for bank robbery, and Ray for forging postal money orders, in the Kansas City jail. He said they were tran ferred to Leavenworth, where Ray "played a lo of miniature golf."

They met again when Curtis was sent to Jefferson City on a 10-year armed robbery conviction.

Tighten Gun Bill

HE difficulty of enforcing laws against the misuse of firearms is demonstrated by the apparent actions of James Earl Fay, 40, named last week by the FBI as a suspect in the slaying of Dr. Martin Luther King.

There is strong public sentiment in favor of tightening controls over the sale of guns, according to the latest Harris survey. Control legislation has been before Congress for more than a year, the survey reported, but opposition from the National Rifle Association and other groups has prevented a vote on it.

Whether or not Ray is found guilty of the killing, it appears from facts presented so far

that he violated a 1938 gun law.

The Federal Firearms Act of 1938 provides penalties up to \$2,000 or five years in prison for violations of its provisions. The provisions make it unlawful for Ray, as a convict and fugitive from justice (Ray fled the Missouri Penitentiary last year), to buy a firearm and carry it across state lines. Evidence indicates Ray purchased a weapon in Alabama and transported it to Memphis, Tenn., where King was slain.

Ironically, while this old law has teeth in it, two proposed laws in the U.S. Senate would not have prevented Ray from obtaining the gun he is charged with misusing.

The two bills—one backed by Sen. Thomas Dodd, D-Conn., the other by Sen. Roman Hruska, R.-Neb.—are aimed more in the direction of halting promiscuous mail order sales of firearms.

B UT there is a provision in the Hruska bill requiring foolproof identification of a prospective mail order purchaser (the dealer can go to jail, too, if he accepts false information). It appears reasonable to suggest that this provision be extended to all gun purchases, mail order or over-the-counter.

This would be a form of registration, which gun groups oppose, but it seems a wise pre-caution to take.

Jonfusion in the Great Manhunt

N ASSISTANT police chief in Memphis said this week he was confused about the search for the kider of Dr. Martin Luther Imag. Imagine, then, the confusion of the rest of the nation.

Two days after King's death, U.S. Atty. Gen. Ramsey Clark said in Memphis the police were "very close" to the killer. But almost three weeks have gone by since then without much indication of an early arrest.

Fortunately the Federal Bureau of Investigation is now satisfied it has identified a fugitive suspect: James Earl Ray, also known as Eric Starvo Galt. This may go a long way toward dispelling the public's bewilderment and concern about the greatest national manhunt of recent times.

Obviously when Ramsey Clark spoke so optimistically in the early hours of the investigation he was trying to reassure people that everything possible was being done. Unfortunately his promise of an early arrest came to have a hollow ring as day after day went by.

At the same time, private and public investigators were pouring out a great, indigestible mass of fact and fancy about the King case. The wards man, they said, was in his 20s—or 1 a like 20s; he had black hair—or sandy hair; he was a nondrinker—or he liked vocka and heer; he was about 5 feet 8—or close to 6 feet time.



DE PUGH and WALTER PATRICK PEYSON are appealing a 1966 conviction in Kansas City for national firearms violation. DE PUGH and PEYSON are wanted on a Federal Grand Jury indictment accusing them of conspiracy to rob banks in Seattle in January.

HUNT advised that the aforementioned information with respect to the Minutemen recalled an article done by "LIFE" in about October, 1961 with regard to hate groups. 
