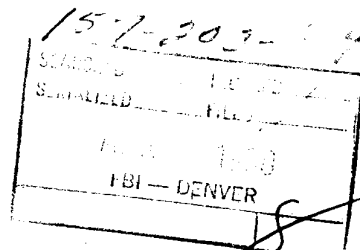
The following investigation was conducted by SA BILL E. PEMBERTON:

On April 23, 1968, EVELYN MC MILLON, Master Files Section, Colorado Department of Motor Vehicles, Denver, Colorado, advised that 1968 Colorado License TF 481 is issued to DWAYNE C. KIRK, 8054 Conifer Road. She further stated that the license was issued for a 1968 Dodge Pickup, VIN 1181804018. MC MILLON stated that Colorado Temporary Sticker T30045C is issued to MELVIN J. BLOCK, 1220 South Benton, Denver, Colorado, for a 1966 Ford, VIN 6N64C134080.

On April 23, 1968, MELVIN LESTER, owner, High Spot Bar, 3905 South Santa Fe, Englewood, Colorado, was displayed wanted flyers regarding JAMES EARL RAY and ERIC STARVO GALT. LESTER stated that to the best of his knowledge he had never seen any individual in his place of business resembling the wanted flyers of GALT and RAY. LESTER stated that he was not acquainted with DWAYNE C. KIRK or a MELVIN J. BLOCK. He further stated that if any further information comes to his attention, he will notify the local office of the FBI.

On April 23, 1968, Mrs. MAYNORES KIRK, 8054 Conifer Road, Denver, Colorado, advised that her husband DWAYNE KIRK is employed by Whitaker Industries, 4747 South Pecos, Englewood, Colorado. Mrs. KIRK was displayed wanted flyers regarding ERIC STARVO GALT and JAMES EARL RAY, at which time she stated photographs on the wanted flyers did not resemble her husband. Mrs. KIRK provided recent photographs of her husband, and after observing these photographs it was determined by the agent that KIRK did not resemble JAMES EARL RAY or ERIC STARVO GALT.
