Re memo from JOHN WARDS 4/18/68, Serial 233, pursuant to call from W. H. HOWARD, Brown Palace Hotel, which advised HOWARD may have seen GALT there yesterday.

On 4/19/68, WALTER H. HOWARD, residence 2552 Meadowbrook Drive, Denver, telephone 428-6179, advised that he has been a day bartender at the Brown Palace Hotel, Ship Tavern, for 14 years, and that he works every day but Sunday and Monday from 8:00 AM 4:30 PM. He advised that approximately 3:30 PM on 4/18/68, he observed a person at the bar of the Brown Palace Hotel, who very closely resembled a photograph he had seen of ERIC STARVO GALT. HOWARD was exhibited the latests wanted flyer regarding GALT whose true name at that time had been found to be JAMES EARL RAY. HOWARD was also apprised of the known aliases of RAY. Upon exhibition of this wanted flyer, HOWARD stated he was 90 per cent sure that this is the man who appeared at his bar the day before, but that he had never seen him before yesterday.

HOWARD said he half way expected this man to return on 4/19/68 as he had remarked that he would be in that date. HOWARD stated, however, that he owed this individual no money, it being noted that this individual received correct change after having bought a drink. Consequently, HOWARD stated there was no reason for this individual to return.

Physical surveillance was maintained by SA G. HOWARD CARTER from approximately 12:00 noon, 4/19/68, until 5:00 o'clock PM, but the above described individual did not return.

HOWARD said he would call the FBI immediately in the event he encountered this fellow again.

Re Sacramento teletype to Denver and Omaha dated 4/25/68, (Serial 305) which teletype reported interview of ROBERT DINKINS who stated he had recently observed a man who resembled name EARL RAY and whom he had known in 1954, or 1955, in the City Mission, Larimer Street, Denver, Colorado.

On 4/26/68, the following missions were contacted on Larimer Street, it being noted that there is no such mission as the City Mission at 612 Larimer Street.

The Baptist Mission, 1616 Larimer Street, at which place ROBERT G. COIL, Director, advised his establishment keeps no records and that he has never seen JAMES EARL RAY, but that his establishment is in possession of a wanted flyer regarding this man.

LEONARD GRAHM, WILL GILLIAM, both employees, and HUGH ALLDREDGE, Record Clerk, of the Denver Rescue Mission, 1818 Larimer Street. ALLREDGE advised his establishment has no record dating back to 1954 and 1955, and also no current employees who were employed back then.

The Citizen's Mission, 1617 Larimer Street, where employee LESTER WILLIAMS, Men's Counselor ROBERT SULLIVAN, Executive Director ROY MOUNDY, were interviewed and exhibited wanted flyer regarding RAY, with negative results. SULLIVAN checked his registration records of the mission which included the years 1954 and 1955 but was unable to come up with positive information on RAY.

All the above persons expressed their willingness to immediately notify the FBI in the event information becomes available regarding RAY.

On 5/1/68, SA KING, after being advised by the Dispatcher, did proceed to the vicinity of 16th St. and Tremont. Information received by the Dispatcher indicated that a Denver Police Beat Officer had observed an individual similar to subject in the vicinity of 16th and Tremont and that this individual was walking West on 16th.

Arriving at 16th and Tremont SA KING contacted Patrolman JOSEPH DOLAN, Badge #5214 and DOLAN stated that as he was questioning some Hippies he observed an individual sitting on a bench in the Plaza at 16th and Tremont. DOLAN described this person as follows:

W/M, Over thirty, 5'10", 165 lbs, Light Red goatee, Lt blue or white dress shirt, short sleeved, blue jeans and carrying a paperback novel.

DOLAN advised that the above described person seemed to become aware of the Policeman's presence and he then "hurriedly" left the area, walking West on 16th.

After confirming the above facts with DOLAN, SA KING was joined by SAs, ENYART, ~~CHAMBERLAIN~~, VOLZ, MISCHKE, AND ADSIT. The above named Agents were in four mobile units and the entire pertinent downtown area was covered by the above Agents. Surveillance of the downtown area failed to locate UNSUB.

Officer Dolan also described suspect as noticeably bow-legged to BWA.

Records of the Denver Police Department, Bureau of Identification and Records, Denver, Colorado, reveal that Holt Chew, Denver Police Department Number 58534, was placed on probation April 24, 1967 after conviction for shooting James Thomas Jackson, a Negro on January 20, 1966.

On April 29, 1968 and April 30, 1968, Chew was interviewed by Special Agents of the FBI. He was asked if he recalled he made a telephone call to the office of Martin Luther King in Atlanta, Georgia on December 13, 1965. He reflected for a few moments and then said he was not about to lie about the situation, especially to the FBI. He said that he has no love for Martin Luther King and is glad he is dead. He stated King was not the non-violent civil rights leader he claimed to be. Wherever he went, violence followed and he was responsible for 37 deaths in the United States. He added that, as a personal matter, King was directly responsible for the destruction of the business career of one of his sons, Bill Chew of Saint Augustine, Florida. He estimated his son's financial loss at \$400,000.00.

Chew stated that his son was head of a hotel and motel association in Saint Augustine, Florida a few years ago when King and his followers came down to Florida and started efforts to integrate the industry. His son was also operating a motel in Saint Augustine at the time. Bill Chew was taken into Federal Court by these people for refusing to integrate his establishment and as the result of an unfavorable court decision, he ended up resigning his position with the association and selling his motel at a

severe loss. Chew said that there was considerable newspaper publicity over the matter at the time.

Chew placed King in the same category as Stokely Carmichael and H. Rap Brown and stated frankly that he hoped the same fate befalls the latter two. He made the statement that he is not against the Negro race; that he was born in Georgia, brought up with Negroes and hunted and fished with them. He made it clear that he is against some individual Negroes like Carmichael and Brown, who advocate violence and have no regard for property rights, but is not against all Negroes.

Having made these points, he returned to the original question and stated that he had no recollection of the telephone call and admitted that the reason could be that he could have been drinking at the time the call was made. He volunteered that at that time in his life he was a "bad drinker". He emphasized that he had no doubt that he made the call, if interviewing Agents said he did, but that he could not recall it. He stated that he was certain, whether or not he had been drinking, that he would not have made a threat over the telephone since he knows such a threat could lead to trouble for him. He said if he had had any intention of doing anything concerning King, he would not have used the telephone, he would have taken direct action.

Chew advised that he is certain that no one "put him up" to making the telephone call, and it was not an action involving anyone other than himself. He was shown photographs of James Earl Ray, the man being sought in connection with the assassination of Martin Luther King, but disclaimed any knowledge whatsoever of Ray.

He constantly referred to King, Carmichael and Brown using expletives in an effort to show his intense dislike for these men.

He stated that he was in Denver on April 4, 1968 and April 5, 1968 and left the city by Eastern Airlines for Augusta, Georgia on April 6, 1968 where he is promoting business interests in the food industry, whereby he hopes to set up his son Bill in business. He was unwilling to further identify his business interests. He stated his son Bill is

presently running the Paradise Motel in Sylvania, Georgia and drove up from there to meet him in Augusta the first part of the week of April 7, 1968. Both he and his son then drove to Sylvania and on to St. Augustine, Florida where they were met on April 12, 1968 by Mrs. Chew and a younger son, who had just returned from military service in Korea. He said his wife and younger son flew from Denver. Thereafter, he and his family vacationed in Florida until he, his wife and younger son returned to Denver on April 29, 1968 in a new car he purchased in Florida.

He specifically stated that he had nothing to do with King's death and said that he knew of no conspiracy relating to it. He stated that he saw King's funeral on television and the way it was conducted it looked to him like it had been planned for 20 years.

He volunteered to the interviewing Agents that he has every intention of protecting his apartment house property in Denver, Colorado with as much force as is necessary if anyone attempts to cause damage or loot it. He stated that he was angry at the leaders of this country for putting up with rioting, looting and the like. He thinks that the Attorney General is "very weak" and used more expletives to emphasize his point. He stated that he is "all for" law and order, but would like to see law enforcement empowered to act. He also stated that he was angry because the National Association For The Advancement of Colored People were able to close businesses throughout the country after King's death when very few businesses closed after President Kennedy's assassination; and he is convinced that threats were used to accomplish the closing of businesses in Denver, as he was so informed before he left on his trip.

It should be noted that a source who has furnished reliable information in the past, advised on January 21, 1966 that Chew is a highly irascible and unpredictable individual, an alcoholic and possibly a user of narcotics.

Mrs. Holt Chew on April 30, 1968 advised that her husband left Denver on April 6, 1968 for Augusta,

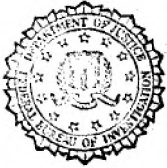

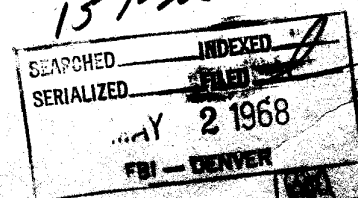

Marked Map Linked To Murder of King

WASHINGTON — A map of Atlanta with the areas of the Rev. Dr. Martin Luther King Jr.'s residence and church circled has been linked to the suspected assassin, James Earl Ray, by the FBI, it was learned Tuesday.

The Los Angeles Times learned from an unimpeachable source that the map is part of the FBI's evidence against Ray.

The map tends to support a theory by some investigators that Ray stalked King for some time before fatally shooting him on April 4 as the civil rights leader stood on a balcony outside his Memphis hotel room.

The areas circled included the Ebenezer Baptist Church in a Negro business area on the eastern edge of downtown Atlanta and the area of King's residence several miles southwest of downtown Atlanta. King and his father, the Rev. Martin Luther King Sr., served as co-pastors of the church.

Ray has been the object of a nationwide manhunt since April

17 when the FBI charged him — in a complaint listing him under the alias of Eric Starvo Galt — with conspiring to violate King's civil rights. Memphis police quickly followed up with a murder charge.

Two days after filing the complaint, the FBI announced that fingerprints uncovered in its investigation revealed that Galt actually was Ray, a 40-year-old escapee from the Missouri State Penitentiary.

How the FBI obtained the Atlanta map with its markings isn't known. It apparently was either left by Ray as he fled the murder scene or was found in a car he abandoned in Atlanta.

Suspect Hunted In Australia

CANBERRA, Australia— (AP)— Australian police are making a nationwide search for James Earl Ray, wanted in the United States on a charge of killing the Rev. Dr. Martin Luther King Jr.

Police officials said the U.S. Federal Bureau of Investigation cabled that it had information indicating Ray, also known as Eric Starvo Galt, might have fled to Australia.

Australian police have also begun an intensive examination of all entry documents filed at points of entry since King's assassination, but officers say nothing positive has turned up yet.

In Washington, the FBI had no comment.
