

A First Source, who is in a position to furnish reliable information, advised on May 28, 1969, that Dr. M. C. WILLIAMS, President, Religious Council on Human Relations, 1525 Josephine, Denver, Colorado, wrote a letter dated to January 9, 1969, to Mayor WILLIAM MC NICHOLS, Denver, Colorado, stating that he was working with a committee based in New York which committee is headed by Rev. WYATT T. WALKER, the former administrative assistant to MARTIN LUTHER KING, JR. He said the purpose of the committee is to petition Congress and the new Administration to make January 15, KING's birthday, a national holiday.

He stated in his letter that "we" are requesting the same of the Governor of Colorado and have been in contact with representative of the Colorado House of Representatives and Senate in hopes that the resolution may be passed supporting this idea. Rev. WILLIAMS also requested a Proclamation by the Mayor declaring January 15, 1969, as Martin Luther King Day in Denver. First Source stated the Mayor replied to Rev. WILLIAMS's letter suggesting Rev. WILLIAMS direct his efforts toward the Federal level and agreeing to issue the requested Proclamation. First Source stated that the Proclamation was issued; however, Martin Luther King Day is not to be an annual affair.

A Second Source, who is in a position to furnish reliable information, advised on May 28, 1969, that the Governor of Colorado, JOHN A. LOVE, received a letter and a telephone call from Rev. M. C. WILLIAMS, shortly before KING's birthday, January 15, requesting that the Governor declare January 15 a State holiday. The Governor advised Rev. WILLIAMS that what he wanted would be best accomplished on the Federal level. The Governor took no action to declare a State holiday.

The Second Source stated that there was some talk among members of the State Legislature concerning a resolution

supporting efforts to have January 15 declared a national legal holiday, but nothing was actually introduced. CRIMINAL HISTORY: Subject indicates that his first arrest was at age 18 for forgery. The FBI Report indicates that the subject has been arrested for investigation, passing checks on a government reservation, Dyer Act, insufficient funds checks, bogus checks, involuntary manufacture, investigation of forgery, forgery, ex-convict registration, no account checks, no operator's license, and for the present offense which is no account check.

MARITAL: At the age of 17 the subject married a 19-year-old girl whom he had known for 8 or 9 hours. There were no children by this marriage which ended in divorce after 1 month.

At the age of 26 the subject married a 43-year-old woman whom he had known for 3 months. There were no children by this marriage, which after 4 years is about to end in divorce.

The subject indicates that his present wife is the cause for his legal difficulties. We indicates that she is a very troublesome person who also has a criminal record.

MILITARY: The subject has served in the Arkansas National Guard from 1955 to 1956 and received an honorable discharge. He enlisted in the U.S. Air Force in 1956 but was given a minority discharge because he was under age when he enlisted. Subject enlisted in the U.S. Navy in 1957 and was reportedly given an inaptitude administrative discharge. Subject states that he struck an officer, appeared before a psychiatric board and received a discharge because of his emotional instability.

EMPLOYMENT: Subject states that his first job was as an electronic's assembly helper. He indicates that he has held numerous electrical related positions, worked as a draftsman designer and as a member of the engineering staff of the Lear Reno Corporation for 2 months.

RELIGION: This inmate indicates that he has attended the Mormon Church on an irregular basis. Subject indicates that he is personally acquainted with high ranking members of that church's organization.

HEALTH: The subject states that in general his health is good. He has an extensive medical history of both psychiatric and physical problems.

This inmate has received numerous psychietric evaluations. He has been described as an "emotionally unstable personality of long standing". He was diagnosed as "psychopathic personality with amotional instability."

This immate was involved in a motorcycle accident in which he received injuries to his back, head, leg and jaw. A previous psychiatric evaluation states that the subject has had an "outside tumor." At one time the subject complained of having blackout spells. During the interview the subject stated that he has often had severe headsches and stated that he has consumed a great deal of alcohol in order to releave this pain.

The Diagnostic Center Medical Report indicates that the subject is allergic to antibiotics and that he is fit for duty.

SOCIAL ADJUSTMENT: The subject has a long history of poor social adjustment in the home, school, military and marital experience. Subject indicates that he drinks to excess when he is depressed.

The subject's academic pursuits while incarcerated appear to be successful.

A previous institutional report indicates that subject received superior grades on a college level in such courses as interior decorating, engineering graphics and engineering drawing.

A previous psychiatric evaluation states that the subject has suffered from much emotional instability, and has done considerable 'acting out."

He reportedly had temper tentrums in which he would often leave home in the middle of the night, take the femily car and drive to a distant town. On various

occasions the subject has threatened to kill the rest of his family during these temper tentrums. On I occasion the subject left a suicide note stating that he intended to do away with himself since "no one loved him."

EVALUATION: The subject is 29 years old. He was born and raised in Fort Smith, Arkansas under fair economic conditions. This inmate has above average intelligence and good mechanical and engineering skills. Subject has had a very stressful and emotionally insecure life. He has made a generally poor social adjustment in spite of his talents.

During the interview the subject presented himself as a nervous individual who on several occarions reminded the interviewer not to insult his intelligence.

The subject has spent approximately the last 10 years in various institutions. He generally appears to have made a good institutional adjustment. The subject has a slightly overbearing personality, but is not totally disagreeable. He has been diagnosed as psychopathic personality with emotional instability."

During the interview the subject stated that while he was incarcerated at the Cummings Prison Farm in the state of Arkansas he was in a position of authority and consequently received the blame for several incidents of brutality which took place in that institution. Subject indicates that in H-Hall he has received several threats from immates who knew him from that institution.

RAYMOND LEON YOUNT, Missouri State Penitentiary #16900, was interviewed at his request at the Missouri State Penitentiary, Jefferson City, Missouri.

At the start of the interview YOUNT was shown a six page statement which had been made available by Warden HAROLD SWENSON. YOUNT read this six page statement and stated that he had prepared this statement a few days prior to this interview and the statement was true and correct, however, he did not wish to sign it.

"I, Raymond Leon Yount, 16900, do hereby offer this statement completely freely and voluntarily. I issue this statement without any threats of promises being imposed upon me. The the best of my knowledge, all facts given are true to the best of my memory.

"During the latter part of the month of June, or the first part of July of 1966, I was in Oxford, Mississippi. I state this date to be true as I recall that it was just a very few days from the 4th of July holiday.

"It was here (Oxford) that I met with another young fellow which I had served time with in the FRERO. This man's last name was Bean. I don't think I even knew his first name. He had the nickname of "Carnie" as he was a previous carnival worker. Bean appeared to be prosperous, well dressed and with funds. I had known Bean since 1951 at this time.

"I registeren in a motel in Oxford. I do not recall the name of the motel unit. It was a two-story structure located approximately 4 blocks north of the main city square of Oxford. The name used here was either Billye R. Sellers /or James G. Sellers. This will be on the motel records as I believe a worthless check was left there or else the bill for

the room was abandon. It was here that Bean and I talked, drank and that he told me of "some people I want you to meet".

"The next day, we together drove to another Mississippi city to get new I.D. cards. I am unable to recall the name of this town but believe that I could re-trace the route on a map. The I.D. I obtained was under the name of Bruce Richard Caldwell, 412 Elm Street, Windsor, Ontario, Canada. This I.D. was received out of a case located in the rear of a printing firm. The odd thing that I noted here was all of the packs of I.D. that we looked through were of Canadian orgin and that they were not counterfeit, rather real, used I.D. cards. There were several packs of I.D. card we looked through to find one that I fitted.

"Note: I was later arrested with this very I.D. on me in Douglas County Nevada. This was on Aug. 13, 1966. I understand that the I.D. cards were returned to an "Inspector" in Windsor.

"Later in the evening of the day which I received the I.D. cards, Bean arranged for us to meet with three men in a motel in the same city. I do recall various things about the location of this motel and the motif of the structure. Bean arranged this meeting by means of a phone call from the printing firm. Obviously it was a local call.

"Upon entry into the motel room the first thing I noticed was the tension about every one present. Drinks were poured and small talk exchanged."

"The three men were well dressed and obviously did not occupy the room full-time as there was no luggage or extra clothes. I would approximate their ages at 28, 35 and 39. I would recognize any of these men if I ever saw them again.

"The oldest man did most of the talking.
He was a large man, wearing a wine-colored silk jacket.
He spoke with a accent with I quickly classified as a
New Orleans-French. I was familiar with this pronunciation.
He wore his pants very high around his waist line which
I automatically connected also with the New Orleans French
Quarters. At no time did he state that he was from
New Orleans or from anywhere.

"He asked me where all I had served time and for what?

"If I liked "Niggers"?

"If I had ever been in the armed service?

"If I could fire a rifle with accuracy?

"If I was interested in making some fast easy money?

"With this, I was shown three large stacks of bills with a brown paper band around each stack.

"Note: These questions were not all asked at the same time, but rather over the course of an hour or so.

"During all this time I was listening more than talking and trying to figure out what the proposition was. No exacting details were given.

"Small talk continued for some time, one of the men, the middle aged one, of approximately 35 years left the room and returned about 30 minutes latter.

"Shortly thereafter, I was ask if I would go to Jackson, Mississippi on the next day with two other men. Martin Luther King was given, by name, as the target. He was to speak in public on the next evening. The three of us were to arrange ourselves on roofs of nearby buildings and then "open-fire" at

the same time. The closet door of the motel room was opened and there were three rifles leaning against the wall. The stacks of money was on the dresser. I knew, in my own mind that these men were serious and did intend to have this man killed. However, it was also obvious to me that there was no way to "get away" with such a crime and I even doubted that payment would be fulfilled. The general plan was not to realistic, for the three on the roofs. To be honest, I was more scared than anything.

"There was no decision made at this time. I told them that I would let them know in a couple of hours, with this Bean and I left the motel room. The younger fellow followed us outside. He handed Bean a motel room key which was to the next unit. The three of us went inside. I told Bean that I was going to the car to get some clothes and bath articles to clean up with. The young fellow stood in the doorway. As quickly as I was in the car, I turned the key and was gone!

"Somewhere north, approximately 50-75 miles of Jackson I stopped at a service stationed and phoned the F.B.I. office in Jackson Mississippi. I refused to tell the Agent who nor where I was. I only told him that there was a plot to kill Martin Luther King and to keep him out of public in Jackson the next day. The agent tried to hold me on the phone as long as he could. I talked all of 60 seconds. I explained myself clearly. This call should be on file in the Jackson Office. I hung-up the phone and left. I drove on into Jackson, left the car at the airport and boarded a plane for San Franisco, California."

YOUNT advised that the abbreviation FRERO refers to the Federal Reformatory at El Reno, Oklahoma. YOUNT advised he has never seen a picture of JAMES EARL RAY and he could not say if RAY was present in Oxford, Mississippi, when this matter was discussed in July, of 1966.

YOUNT described the three other unknown males that were at the meeting in a motel room in Oxford, Mississippi, as follows:

YOUNT advised that he has not seen any of these individuals again, however, he told this story to JOHN EMERSON, 412 West Musser Street, Carson, Nevada, a minister who can be contacted at the above address or through 409 South Tacoma Street, Carson, Nevada.

YOUNT stressed that he had cooperated with U. S. Postal authorities in the past at Little Rock, Arkansas, in November, 1965, concerning some stolen money orders.

YOUNT advised that he had not furnished this information until this time because he felt that the assassination had been averted, but now feels that this information should be given to the proper authorities.

YOUNT stated that unknown subject #1 hangs around the Itt'll Do Club in Dallas, Texas, and that he had met this individual prior to their meeting in Oxford, Mississippi, however, he did not mention this meeting to unknown subject #1.

YOUNT also stated that unknown subject #3 could be identified through an unknown individual who broke his arm in May of 1966 and was treated at Charity Hospital, New Orleans, Louisiana. YOUNT stated that this unknown individual is a "barker" on Bourbon Street in New Orleans.

YOUNT stated that unknown subject #1 could be identified by URETHA (phonetic) who is a cocktail waitress at Love Field Cocktail Lounge, Dallas, Texas. YOUNT stated that he was with URETHA at the Itt'll Do Club in Dallas when unknown subject #1 tried to start a fight with him, and URETHA knew unknown subject #1 at that time.

YOUNT also advised that his fourth wife, BILLYE RUTH SELLERS, was with him on a check cashing spree at the time of this meeting in Oxford, Mississippi, in July, 1966. YOUNT stated that perhaps SELLERS is wanted by the FBI in regard to these check writing activities. He stated that SELLERS is also known as BILLYE RUTH YOUNT, and BILLYE RUTH HARRIS, and was employed for a time at 201 West King, Carson, Nevada, with the State of Nevada Insurance Division. YOUNT stated that SELLERS could not be contacted through 1027 East Walnut, Springfield, Missouri, or through her children who reside at 1012 Ivy, Cassvialle, Missouri, or DEBORAH KAY SELLERS, a student at Southwest Missouri State College, Springfield, Missouri.

Information copies along with 2 copies each of FD-302 on RAYMOND LEON YOUNG, and 1 copy each of Missouri Department of Corrections report concerning YOUNT, are being sent to Denver and Seattle, who had cases on YOUNT and SELLERS in the past.

On 1/26/70 RAYMOND LEON YOUNT, Missouri State Penitentiary #16900 was interviewed at the Missouri State Penitentiary, Jefferson City, Missouri. After the interview Warden HAROLD SWENSON, Missouri State Penitentiary, Jefferson City, was interviewed by Special Agents ROWEN B. AYERS and KEITH M. HUNTER, at which time he made available a copy of Missouri Department of Corrections report of Division of Classification and Assignment concerning RAYMOND LEON YOUNT.

It is noted that this report states that the subject has an extensive medical history of both psychiatric and physical problems. "This inmate has received numerous psychiatric evaluations. He has been described as an 'emotionally unstable personality of long standing'. He was diagnosed as "psycopathic personality with emotional instability'."

The report also states that the subject has served in the United States Navy and was given an administrative discharge after appearing before a psychiatric board and receiving a discharge because of emotional instability.

The above is being furnished for information and evaluation by your office. In view of the above, no leads have been set out by the Kansas City Division.

Informant advised none of the four photographs are Denver BPP members, however, in photograph number 1, he recalls the individual with the white headband as being at the BPP rally at the Federal Building, Denver, on 2/11/70. He said no one from the Denver BPP group went to Wyoming to the game.

Informant advised that SIDNEY HAROLD VAUGHN and the photograph sound and look familiar to him as being an individual who hangs out at Mac's Bar on Friday and Saturday nights at 21st and Stout Streets. Informant will attempt to obtain more information regarding VAUGHN.

Informant advised ORA WILLIAMS has returned to Denver from California and is residing at the BPP community house, 3123 Franklin Street.

ANDREW AUSTIN has not returned to Denver from New York.

The Panthers are still having trouble selling their newspapers and less than eight children attend the breakfast program at the High Street Parish. Liberation classes are being held at 7:30 P.M. on Tuesday evenings but are attended by less than four people other than the BPP members.

Time reports on King silencing

NEW YORK (AP)—Time magaziné says FBÍ Director J. Edgar Hoover confronted the late Dr. Martin Luther King Jr. in 1964 with some wiretaps revealing King's alleged extramarital activities, and King later toned down his criticism of the FBI.

An issue of the magazine released Sunday gives Time's version of the 1964 Hoover-King meeting in an article discussing a new book about King by novel-

ist John Williams.

In his book, "The King God Didn't Save," Williams says the FBI started tapping King's telephone and bugging his hotel rooms in 1963.

Time says Williams reports that the surveillance uncovered no subversion but "did turn up an astonishing amount of infor-mation about King's extensive and vigorous sexual activities.'

Anonymous source

Williams quotes one anonymous source as telling him that King used a code. "A very attractive woman was called 'Doctor,' '' the informant is quoted as having said. "I forget the other names for women not so attractive."

Time says "most newspapers ignored the rumors and leaks to them of King's extramarital activities, but their existence undermined King's effectiveness just the same.

"The effect," says Williams, "was one of slow political assassination; King was spared it only by the bullet of James Barl Ray," Time said.

Ray pleaded guilty to killing King in 1968.

In presenting its version of the Hoover-King meeting, Time said:

FBI. King took the advice. His decline in black esteem followed, a decline scathingly narrated by Williams.

Manipulation

The magazine says Williams argues in his book that King was complicitous victim of a "white power" plot to manipulate and ultimately destroy him.

The fact that the FBI had been bugging King was revealed last year by FBI agent Robert Nichols in a courtroom in Houston, Tex., where boxer Cassius Clay was seeking to vacate a sentence for refusal to be inducted into the Army. One of the monitored conversations was between King and Clay.

Nichols testified he had been in charge of the surveillance of King until May, 1965.

Nichols was not allowed by the judge to say why King's phones were tapped, but he said it occurred at a time when King signing Southern agents, rather civil rights workers.

Later, when Carl T. Rowan, a Washington newspaper column-



Delegates from the Student Mobilization Committee to End the War in Vietnam, which is controlled by the Socialist Workers' Party, agreed to support this demonstration. The PCPJ is a coalition of various protest groups including the Communist Party. |

Re: Demonstrations in Connection with Anniversary of Death of Martin Luther King, Jr., April 4, 1971

In Chicago, Illinois, a coalition of labor, peace and social welfare organizations calling itself "The Martin Luther King, Jr., Commemoration Committee," has announced plans for "freedom marrhes" and rallies in Chicago on the eve of April 4. This group is hopeful of attracting 10,000 participants.

In view of the potential for violence and disorder in demonstrations such as those being planned for New York City and Chicago, all offices should be alert for any information indicating that mass demonstrations commemorating King's death are being planned in their respective divisions. or that militant or extremist groups and individuals are planning to participate in the demonstrations in New York City, Chicago, or elsewhere. If such information is developed. necessary investigation should be conducted to identify militant and extremist individuals and groups involved and to determine the tactics they intend to use in the demonstrations. All information is to be immediately furnished to the Bureau and pertinent offices by teletype suitable for dissemination and under appropriate descriptive caption. Individuals and organizations mentioned must be briefly characterized.

Informants are to accompany groups traveling to these demonstrations. Bureau authority is necessary prior to sending an informant. A copy of communication requesting authority to send an informant is to be directed to the pertinent office and is to include the code name utilized by the informant.

Close liaison should be maintained with police and other local agencies where the demonstrations are to be held and you should be particularly alert to possible violations of the antiriot statutes and other Federal statutes within the Bureau's jurisdiction.
