



MR. LEONARD BARKSDELL, ENGINEER, SOUTHERN PACIFIC RR OBSERVED SKETCH OF ASSASSIN ON FRANK MCGEE, TV NEWS REPORT. STATED THE LIKNESS FOR PERSON OBSERVED AT VALENTINE, TEXAS, CAFE, THIS MORNING APPEARED TO BE IDENTICAL WITH UNSUB ASSASSIN SKETCH.

BARKSDELL REPORTED HAVING BREAKFAST AT VALENTINE, TEX, APPROX. EIGHT FORTYFIVE AM CST, THIS DATE, WHEN OBSERVED THIS PARTY ALSO EATING. STATED HE HAD SHORT CONVERSATION WITH PERSON WHO MENTIONED HE HAD DRIVEN FROM WEST VIRGINIA AND WAS ENROUTE TO FORT HUACHUCA, ARIZONA AND HAD TO BE THERE BY NIGHT OF APRIL SIX AND WAS GOING TO VISIT FRIEND AT EL PASO ENROUTE.

BARKSDELL DESCRIBED PERSON OBSERVED AS WHITE MALE, ABOUT FORTY FIVE YEARS, FIVE FEET TEN INCHES, TWO HUNDRED TO TWO ONE ZERO LBS, STOCKY BUILD, RECEDING HAIR, WEARING LIGHT BLUE SUIT, WHITE SHIRT, NO TIE. OBSERVED THIS PERSON FROM LEFT PROFILE. PARTY SEEMED VERY NERVOUS AND SMOKED FOUR CIGARETTES WHILE EATING. BARKSDELL REPORTED OBSERVED VEHICLE OUTSIDE CAFE WHICH WAS BELIEVED TO BE ABOUT NINETEEN SIXTY MODEL DESOTO OR CHRYSLER. HE NOTED LARGE TAIL FINS. LICENSE PLATE UNKNOWN. CAR WHITE TOP WITH CREME COLOR
