In the use of pay stations, if the name of the person being called and the place to where the call is made, is known, a record is maintained for six(6) months at their accounting office at Phoenix, Arizona. If the call was made collect, the record would be kept where the long distance call was charged. If the call was a local call which would be dialed by the caller, no record is kept.

If a long distance call is prepaid by depositing the coins at the calling point, but no names given, in other words a person to person call or a station to station call, the records of the accounting office in Phoenix, Arizona would only show the number called and would be filed under the pay station telephone number.
