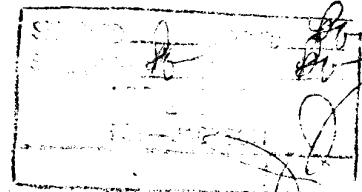

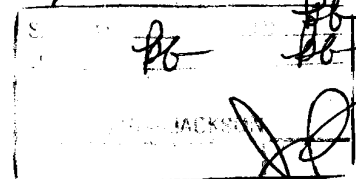

The following investigation was conducted by SA JAMES W. SAMMON on 4/10/68 at Standard Oil Service Stations, Highways Interstate 55 and 51 North, from Batesville to Hernando, Miss.

Without exception, every Standard Oil Service Station operator has advised that the Standard Oil "Georgia - Alabama" Road Map with the battleship on the cover is a 1967 Standard Oil map from the Standard Touring Service, 128 East Jefferson, Louisville, Kentucky, telephone no. 582-9744, Area Code 502. This map is printed by the H. M. Gousha Company, a subsidiary of the Times Mirror Company, no further address for that company.

Without exception, these dealers advised that the Standard Oil "United States" Map with a white cover and three circled colored photographs of mountain scenes is a Chevron map and that this particular map is not distributed anywhere in Mississippi. Dealers advised that that map is distributed only at Chevron stations and not at Standard stations, although Chevron controls the Standard Oil Company.

Therefore, Mississippi dealers cannot furnish the Chevron "United States" Map. They advised it is their understanding that this map is made up somewhere in California. They advised they are not acquainted with any Chevron Service Stations in Tennessee and none in Memphis, with the exception of two new Chevron stations which they believe just opened somewhere between Nashville and Memphis.



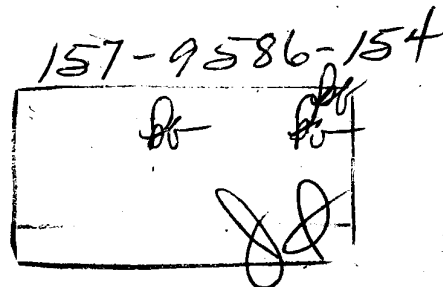

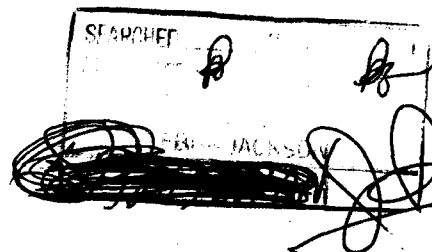
