On 4/9/68 CLEM MC GOWAN, Section Chief, CRD, SOG, telephonically advised that FRED RAMSEY, Producer, NBC News, told Inspector TOM BISHOP that he recalled doing a TV show on the Neshoba County case several years ago and that Rev. EDGAR RAY KILLEN and his three sons who are in their early 20's or 30's resemble the artist's conception of the murderer of Rev. MARTIN LUTHER KING. Further, that they all considered KING a dangerous person, and sooner or later KING would have to be killed.

It was requested that KILLEN and his sons should be considered suspects and that their time be accounted for during the pertinent periods of this case.

The following investigation was conducted:

On 4/9/68 Mrs. LONNIE RAY KILLEN, mother of EDGAR KILLEN, was interviewed (see attached FD-302) who advised that Rev. EDGAR KILLEN does not have any children. She stated she has five sons including EDGAR. She gave their names and ages and employments. She stated that all except ROY GENE KILLEN live at their home and he lives a short distance away. She stated all were at home on the morning and evening of 4/4/68 and could not have had anything to do with the murder of Rev. KING.

On 4/9/68 Rev. EDGAR RAY KILLEN was interviewed (see FD-302) who advised that he does not have any children. He stated that he has four brothers--ROY GENE KILLEN, age 39; BOBBY KILLEN, age 36; DONALD, 31; and JERRY, 29. He said

that he, JERRY and BOBBY all worked at their sawmill in Brandon, Miss., on 3/29-30/68 as well as 4/4/68. He said that ROY GENE is employed at Midland Shirt Co., Union, Miss., and DONALD KILLEN is employed at J. F. Barnett Electric Co., Philadelphia, Miss. KILLEN stated that he knows nothing regarding the murder of Rev. KING.

On 4/9/68 MARDY KOGON, Manager, Midland Shirt Co., Union, Miss., advised that the records of his company reflect that KILLEN was at work from 6:40 a.m. to 4:12 p.m. on 4/4/68. Further, that he was employed on 3/29/68 from 6:41 a.m. until 4:10 p.m. on this date. (see FD-302)

On 4/9/68 DONALD KILLEN was interviewed and accounted for his whereabouts on 4/4/68. (see FD-302)

In addition to the above, neighborhood sources were contacted and verified whereabouts of suspects.

Reverend EDGAR RAY KILLEN was contacted at his home and made aware of the identity of the interviewing agent and advised of the nature of the inquiry.

KILLEN stated that as best he can recall he and his two brothers, JERRY and BOBBY, were employed at their mill in Brandon, Mississippi, on March 29-30, 1968. He said that he definitely recalls that he and BOBBY were at the mill on April 4, 1968, and that JERRY was in the woods cutting logs. KILLEN said that he is married, but has no children. He added that his other two brothers, DONALD and ROY were at their respective employments. KILLEN added that all his brothers live at home with their mother and father with the exception of ROY who lives nearby in a small house. He added that he recalls that all were home on the evening when the news of the murder of Reverend KING was heard.

KILLEN stated that he did not desire to comment regarding the death of KING since anything he might say could be taken the wrong way.

DONALD KILLEN was contacted by agents at the J. F. Barnett Electric and Plumbing Company, 279 West Beacon Street. The identities of the interviewing agents and the nature of the inquiry were made known to KILLEN. He was advised by SA RUCKER that he did not have to talk with the agents and that anything he did say could be used against him in a court of law. He was told that he could consult with an attorney of his own choice before making any statement and could have an attorney with him during interview if he so desired. No threats or promises were made to induce KILLEN to talk with the agents. An attempt was made to allow KILLEN to read a warning and waiver of rights form, which form he declined to read or sign.

KILLEN denied having played any part or having knowledge, other than what he had heard or read in the news, about the murder of MARTIN LUTHER KING, JR. He related that he is employed at the Barnett Electric and Plumbing Company in Philadelphia, Mississippi, and that he did not work on the afternoon of April 4, 1968. He said that he could not recall his whereabouts on March 29 and 30, 1968. KILLEN did say that he does recall that on April 4, 1968, shortly after 6:00 p.m. he was at his home in rural Philadelphia, Mississippi, watching television when his television program was interrupted with a special announcement of KING's having been shot in Memphis, Tennessee. KILLEN then terminated the interview by saying that he was the brother of EDGAR RAY KILLEN who has been arrested by FBI agents in the past and "I'm a God-fearing man and have nothing further to say."

Mrs. LONNIE RAY KILLEN, Route 4, Union, Mississippi, was contacted by SA's DONALD J. CESARE and JOHN H. PROCTOR, JR., who immediately advised her of their identities as special agents of the FBI. Mrs. KILLEN was advised of the nature of the interview and voluntarily furnished the following information:

Mrs. KILLEN identified herself as the mother of EDGAR RAY KILLEN. She stated EDGAR had been "logging and sawing" as of late near Brandon, Mississippi, and would not return home until 8:00 or 8:30 p.m. each evening. She stated that EDGAR RAY is married, but does not have any children.

She related that she has five sons including EDGAR RAY. All but one married son reside with her at home. One son, ROY GENE, also known as "shorty", lives at the home adjacent to hers with his wife. ROY GENE is employed at the Midland Shirt Company in Union, Mississippi. The other sons she identified as JERRY, age 29, born

BOBBY, age 36, born She further advised that DON is employed by Barnetts Electric Company of Philadelphia and that BOBBY and JERRY work with EDGAR RAY logging.

Mrs. KILLEN stated that none of her sons have been out of the state or on any extended trips during the past year or so. 





ACCORDING TO MR. HOOVER, A 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL AND MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH 30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT
TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2,
1968.



ASSASINATION OF MARTIN LUTHER KING:

Source reported that EUGNE SMITH MANSFIELD, aka SUNSET teelphonically contacted L. E. MATTHEWS at Florence, from Buras, La. the morning of 4-10-68. SUNSET wanted \$300 to do a job or hit for MATTHEWS but MATTHEWS would agree only to pay \$200. Source did not know the location of the "hit", or whether an agreement on price was reached.

BOMBING OF BLACKWELL REALTY CO., 1967:

Source reported that the following had come to his attention concerning the indictment of L. E. MATTHEWS on 4-9-68, concerning the Blackwell Co.

ELAINE SMITH of Cystal Springs went to the Hinds County Court House on 4-10-68 but was told that the trial of J. L. HARPER, for the possession of explosives, had been postphned in view of the arrest earlier in the day of attorney HARRY KELLEY. She then met MATTHEWS at the Deposit Guaranty Bank and they discussed the warrant out for MATTHEWS, etal, and then went to the offices of Attorney PWEIFFER in the Barnett Building, who confirmed that he had seen the list of those indicted and MATTHEWS, BOWERS, etal were on it.

Source observed that SMITH & MATTHEWS drove to 51 Mart where MATTHEWS parked his white over blue truck, with pipe rack, got in the car with SMITH & they drove to MATTHEWS home below Florence.

MATTHEWS, his son who may be named STEVE, and SMITH ∞ mmenced to get rid of various items as MATTHEWS said the law would want to search his home & car, and it would ruin him.

SMITH was observed to take MATTHEWS carbine to his mother's house and hide it. They apparently were arguing over his pistols as he had two on him and claimed that he was going to kill an FBI agent when they came for him. SMITH was able to convince MATTHEWS that it would probably end his mother if he acted that foolishly. SMITH succeeded in getting the pistols away from him.

MATTHEWS had his son burning papers that he claimed were from SAM BOWERS.

MATTHEWS claimed that he was going to hide out indefinitely and attempted to get ELAINE SMITH to hide him out on the family farm between Hazelhurst and Wesson, out in the country, but SMITH was claiming that she could not do this as her mother would never forgive her, Source did not know if SMITH finally agreed. Source reported that SMITH drove MATTHEWS to Jackson, dropped him off at the Primos North Gate Restaurants, and was to meet him or receive a call from him at 3 PM in the lobby of the main office of Deposit Guaranty Bank in Jackson.

MATTHEWS was heard to instruct SMITH to go see Senior Vice President STEVE BURRELL of Deposit Guaranty to get him to make MATTHEWS bond.

Subsequently source reported that MATTHEWS was in JOHN SULLIVAN's (attorney) office completing his bond papers, and that SULLIVAN had called the Sheriff that MATTHEWS would be in shortly to surrender. MATTHEWS did not because BURRELL had signed the bond in the wrong place, and it had to be done over.

BYRON DE LA BECKWITH:

Source reported that he had occasion to observe that L. E. MATTHEWS hadre ceived a letter from BECKWITH postmarked at Pensecola, Fla. 4-1-68. This letter indicated his home as 1001 Dewey St., Greenwood, Miss. and on the stationary of the Barrentine Mfg. Co. Greenwood.

BLACKWELL REALTY BOMBING:

Source learned from L. E. MATTHEWS on this date that he was surprised that JACK SHEARER, SR. was not arrested, commenting thathe was at the party, the night it was planned, and that he MATTHEWS specifically recalled leaving with SHEARER.

Source reported that MATTHEWS had had a confrontation with BURRIS DUNN, JR. in HARRY KELLEYS office, that he had suspected that DUNN had been the informant in this matter, but that he had gotten DUNN straightened out. At this meeting it was pretty much concluded that CHARLES WILSON will be a state witness and that he will not be arrested and brought to Jackson until the day before the trial.

Source further reported that ELAINE SMITH will be a surprise witness for the defense of L. E. MATTHEWS as he was using her as his alibi the night of the bombing, and the fact that they were together is entered in her diary.

MATTHEWS & KELLEY agreed to meet for a conference this weekend, and the conditions were that they would meet out in a field and that each should be naked to insure the other that he was not "bugged".

MATTHEW's first wife WILLIE MAY LNU (at one time SMITH) has a trailer behind The Windmill in Jackson. MATTHEWS commented that he and T. J. BATES who stays at this trailer on occasion, had done some things over two years ago but indicated the statute of limitations had run on them.

MATTHEWS has been to see BILLY CARR and though CARR indicated he won't do anything now, he will get a job done at MATTHEWS request. Nothing was indicated for the present time.

L. E. MATTHEWS:

Source reported that Friday night 4-12-68, MATTHEWS went to the Court House in Brandon for the Rankin County APWR meeting but it was hot held as MATTHEWS, BILL PICKEL, ELAINE SMITH, Mr. and Mrs. BEN PULLEN and a black curlyhaired fellow who is believed a member of the Red Hill Baptist Church, showed up. SMITH & MATTHEWS apparently had a squabble so she left first. MATTHEWS, PICKEL and the latter described man said they were going to get some coffee.

BEN PULLEN'S four or five year old daughter took her mother's purse when they got out of the car in front of the court house, dropped it and the pistol went off without hitting anyone. Since the PULLENS were the only ones who showed up, and there are indications they have had a falling out with their next door neighbors NELL & PAT THOMAS, the RANKIN APWR is folding or has folded. The recent arrests in Hinds County of MATTHEWS and his cronies obviously is also having quite an effect on the attendance.

Source did not know the location of MATTHEWS on Saturday night 4-13, but reported that his car was backed into a parking place at the Town House Restaurant at Crystal Springs the night of 4-14-68.

KARL AUSTIN:

Source reported that L. E. MATTHEWS, JR. is real sore at KARL & RUBY AUSTIN as they would not go any part of his bond when he was recently arrested by Hinds County authorities in connection with the BLACKWELL REALTY BOMBING. KARL is having
