On April 1, 1968, Mr. WILLARD stated he was at his home resting due to inclement weather, but when the weather permitted around 10:00 a.m. he flew back to the Natchez-Adams Airport for the purpose of taking another flying lesson. He was at the airport for several hours, but due to inclement weather he did not rent the Cessna 150 plane and returned home by his Piper J-3 plane.

Mr. WILLARD stated that on April 2 and 3, 1968, he was at his home assisting his wife in the preparation of flower beds and sodding the lawn with St. Augustine grass. In addition he had some work painting his home and remained at home during the entire period of April 2 and 3, 1968.

WILLARD continued that on the morning of April 4, 1968, he again went turkey hunting in the Homochitta National Forest, but was very tired and came home around noontime. He ate, rested and he and his wife, EVA, sometime during the mid-afteroon fished in their pond on the farm. He stated that Mr. CLETUS BEALS, a neighbor, came by the farm pond and noted he and his wife fishing on the afternoon of April 4, 1968, and further that Mr. SEALS could verify that he was home most of the time between the period, March 29 through April 4,1968.

Mr. WILLARD stated that he and his wife returned to their home between 4:00 and 5:00 p.m. on April 4, 1968, and he cleaned the fish while his wife cooked supper. He pointed out during the evening meal a special announcement came over his television stating that MARTIN LUTHER KING, JR., had been shot in Memphis and a later announcement stated that KING was dead.

Mr. WILLARD stated that he has never been affiliated with any Klan or hate-type organization and in fact has a number of Negroes working under his supervision at the gravel pit.

He stated he is opposed to violence in any form and this is the first vacation he has had in several years working 12 to 14 hours per day.

Mr. WILLARD stated that he has not been in Memphis in ten or more years, does not own a white Mustang and is not aware of who assassinated MARTIN LUTHER KING, JR.

Mr. WILLARD was shown the artist's conceptions of the unknown individuals in this matter and he stated he was not aware of this individual's identity.

The following is a description of WILLARD as obtained from interview and observation:

WILLARD added that he is not aware of the identity of any other JOHN WILLARD or anyone who might have used his name as JOHN WILLARD. He is not acquainted with ERIC STARVO GALT and knows no one by the name of HARVEY LOWMEYER or LOWMYER.

Mr. WILLARD stated he served in the U. S. Navy as a Ships Cook, Second Class, from September 30, 1942, to January 20, 1946, and was honorably discharged under Navy Serial Number 7217671.

On 4/6/68, Mr. ANGUS MC CARREN, Metro Editor, Commercial Appeal, Memphis, advised he has received information from PAUL NORMAN, 1067 S. Perkins Road, and who is a salesman of Chip Barwick Automobile Agency, which might be of value in instant case. According to MC CARREN, NORMAN told him that at approximately 2:00 PM on 4/4/65, an individual going by the name KEN SINGFIELD contacted NORMAN in an effort to obtain employment as an automobile salesman at Chip Barwick Company. NORMAN stated that SINGFIELD said he used operate either a Holiday Innor some type of a motel in Clarksdale and also used to be an encyclopedia salesman. SINGFIELD was acquainted with BILL TIDWELL, whom NORMAN was also acquainted with, and who either operates a Howard Johnson Motel or some other motel in Clarksdale or somewhere in the Delta area.

NORMAN stated that he was reporting this information inasmuch as SINGFIELD acted rather strange and appeared to be either under the influence of narcotics or possibly drinking. NORMAN said that SINGFIELD's description fits the description of the person that shot Dr. MARTIN LUTHER KING. According to NORMAN, SINGFIELD appeared to be nervous and expressed opposition to the policies of President JOHNSON.

NCRMAN said he did not see any automobile in which SINGFIELD was traveling, but was merely reporting the information inasmuch as the description of SINGFIELD appears similar to that of the Unsub which appeared in the Commercial Appeal, and also because of his strange activities.






