

meeting of the City Council and to hear their recommendations. PORTER stated that a meeting was held on 3/23/69 by JOHNSON and KILLINGSWORTH and one thing discussed was a possible boycott of downtown merchants in protest over the killing of the Negro youth. PORTER stated that he did not believe this would come to pass since Negro leaders in the Meridian area were attempting to control the situation and return poverty to this area.

On 3/24/69, Rev. JOHNSON advised that his church would hold a revival during the week of 4/1-5/69 and that on 4/4/69, the NAACP would have a speaker (local) to commemorate the death of MARTIN LUTHER KING, JR. He stated that he knows of no persons planning to attend any marches at any location either in Mississippi or surrounding states.

On 3/24/69, CHARLES R. DARDEN, 1124 26th Avenue, Meridian, Miss., former president of the NAACP in Meridian and a member of the National Board of the NAACP, stated that he does not know of any plans of local citizens to attend commemoration of the death of MARTIN LUTHER KING, JR., on 4/4/69 either at Montgomery, Ala., or Memphis, Tenn. He stated that he was sure there would be some church services in the Meridian area; however, he knows of no anticipated marches or the like.

DARDEN stated that the local NAACP is not taking any part in connection with the killing of a young Negro boy by a Negro policeman. He stated that the authorities had ruled the death accidental and that NAACP members were attempting to avoid any violence in connection with this matter.
