FEDERAL BUREAU OF INVESTIGATION

Date 4/8/68

JOHN HUBEART WILLARD, after being advised of the nature of the inquiry and the identity of the interviewing agents, was given a form entitled "Your Rights" and after reading the form and signing the "Waiver of Rights" section of the form, furnished the following information concerning his activities. On April 4, 1968, he stated that he arrived at his place of employment, the Day Brite Lighting, Incorporated, plant located at South Green and Day Brite Drive, Tupelo, Mississippi, shortly before 7:00 A.M. He said that he was at the plant all the day long and punched out several minutes after 3:30 P.M. on April 4, 1968. He related after leaving the plant he and BILLY GLENN DOWDY went to the Union Hall located on North Spring Street, Tupelo, Mississippi, and attended a union meeting of local 1028, International Brotherhood of Electrical Workers. This union meeting lasted until shortly before 5:00 P.M., after which time he and DOWDY got into his 1968 Ford pickup Deluxe, yellow and white, having no license plate, and drove to the home of DOWDY located on Warren Street, Pontotoc, Mississippi, where he let DOWDY out of the truck and then he proceeded to his home located west of Pontotoc, Mississippi, on Highway 6, approximately five miles.

WILLARD stated that when he arrived at his home around 5:30 P.M. on April 4, 1968, his wife, BARBARA NELL, and their son, RANDY JOE, were already at home. He said he did not leave his home after arriving home and retired for the evening around 8:30 P.M. He stated that prior to his evening meal, he started mowing the lawn.

WILLARD stated he did not go to Memphis on April 4, 1968, and has not been to Memphis in approximately a month, at which time he had visited a brother who resides in Southaven, Mississippi. WILLARD further stated that he has no knowledge of the individual or individuals responsible for the shooting of Dr. KING, stating that the only information he has is what he

BILLY GLEN DOWDY, 115 Warren Street, Pontotoc, Mississippi, was interviewed at the Day Brite Lighting, Incorporated, South Green and Day Brite Drive, Tupelo, Mississippi.

Mr. DOWDY advised that he works in the same department at Day Brite's Lighting, Incorporated, as does JOHN WILLARD and they are in the same car pool together. He advised that on April 4, 1968, he and WILLARD punched out about the same time and got into WILLARD's 1968 Ford pickup Deluxe, yellow and white, and drove to the Union Hall located on North Spring Street, Tupelo, Mississippi, and attended a meeting of local 1028, International Brotherhood of Electrical Workers. He said the union meeting ended shortly before 5:00 P.M. on April 4, 1968, after which time the two of them got into WILLARD's truck and drove to Pontotoc, Mississippi, where WILLARD let him out at his home around 5:10 or 5:15 P.M. and WILLARD left his home en route to his, WILLARD's, residence located on Highway 6 west of Pontotoc, Mississippi.

Mr. WATSON MARLIN, Supervisor, Line 1, Day Brite Lighting, Incorporated, South Green Street, Tupelo, and Day Brite Drive, Tupelo, Mississippi, stated that he had occasion to immediately supervise JOHN H. WILLARD on Line 1 in the Day Brite factory on April 4, 1968. Mr. MARLIN stated that he recalls JOHN H. WILLARD being on the line during the entire working period which consisted of the period of time from 7:00 A.M. until 3:30 P.M. MARLIN stated that the only period of absence he could recall would have been from 11:45 A.M. until 12:15 P.M. during which time WILLARD would have been on his lunch break.

Mr. MARLIN stated that he could not verify the exact time that WILLARD punched in to work on April 4, 1968, nor could he verify the punching out at 3:30 P.M.; however, he stated that in WILLARD's absence the entire assembly line would have been closed down and this was not done.

JERRY WILSON, Office Manager, K G W Towing Company, Greenville, advised that BILLY RAY KING is an employee of that concern. He advised that on April 4, 1968, he personally observed KING get on a Greyhound Bus in Greenville at 7:55 P.M. He advised that on that date, he first saw KING in the K G W Towing Company, Greenville, Mississippi, at 5:00 P.M. He stated that at this time, he advanced KING money for a bus trip from Greenville to Quincy, Illinois. He stated that he received a telephone call from KING at approximately 10:00 P.M., April 4, 1968, from Clarksdale, Mississippi, during which KING advised the Greyhound Bus he had been riding had been stopped in Clarksdale. WILSON advised that he told KING to get a room in Clarksdale and go back to his home in Lake Providence, Louisiana, the next morning. He stated that WILSON stayed in a Downtowner in Clarksdale during the evening of April 4-5, 1968. WILSON furnished a paid receipt showing that KING had checked into the Downtowner in Clarksdale at 10:12 P.M., April 4, 1968.

WILSON advised that he next heard from KING during the morning of April 5, 1968. He advised that KING advised him at that time that his mother had come to the Downtowner in Clarksdale and picked him up. He advised that KING had stated his mother had taken him back to his home in Lake Providence, Louisiana.

WILSON advised that KING came back to Greenville on April 5, 1968, and at his instructions, caught a plane to Memphis, Tennessee. WILSON advised that the ticket had been confirmed from Greenville to Quincy, Illinois, with Southern Airlines. He advised that the plane had been forced to land in Memphis. He stated that KING

then took a bus from Memphis, Tennessee, to Rock Island, Illinois. WILSON advised that KING checked in on the boat "George Weathers" at 3:00 A.M., April 8, 1968, at Rock Island, Illinois.

WILSON described KING as follows:

ROME A. EMMONS, JR., President, The Phoenix Laundry Corporation, Hattiesburg, Mississippi, furnished the following information:

His corporation is the only laundry in Mississippi he knows of which uses the Thermo-Seal laundry-marking machine. He stated that the Phoenix Laundry does work for itself and for one other company, the Rite-Way Cleaners, Bowie Street, Hattiesburg.

Mr. EMMONS advised that laundry marking 02B6 is not a marking of his company. He stated that the marking of his company consists of a letter of the alphabet, followed by a number, followed by another letter, followed by a number up to 25. EMMONS furnished the following key to this laundry code:

First Letter	Day of the week (M T W X F S)
First Number	Series in alphabet
Second Letter	Lot
Final Number	Bundle within this lot

EMMONS advised that lots are lettered beginning on the Monday of each week with consecutive alphabets, thus the first lot on Monday begins 1A.

EMMONS stated that the tape for this machine is 5/16-inch laundry-marking tape made by the Textile Marking Machine Company, Syracuse, New York. He stated that the Phoenix Laundry purchases this tape from F. H. ROSS and RUDOLPH RAMELLI, both of Jackson, Mississippi.

EMMONS advised that this tape comes in eight to ten colors; however, red is not a good color, in that the ink from the machine tends to fade and run on red tape. He advised that all colors are used in regular rotation, changing after approximately 20 tickets in a lot.

EMMONS stated that a competitive machine called the Poly-Mark makes similar markings to the Thermo-Seal machine but uses slightly smaller tape, believing this tape to be one-quarter inch wide. He stated that the Crescent Laundry and Southern Cleaners, Hattiesburg, Mississippi, may use this type of machine.

EMMONS furnished samples of the tape used by his machine and several different markings made by this machine.

Date 4/12/68

REGGIE SMITH, cameraman, Columbia Broadcasting System (CBS), Atlanta, Georgia, telephonically contacted SA JAMES O. INGRAM on April 12, 1968. He stated he had just arrived in Atlanta upon instructions issued by officials of CBS. The news media is presently carrying headlines indicating that ERIC STARVO GALT is a prime suspect in the murder of Dr. MARTIN LUTHER KING, JR. at Memphis, Tennessee. A white Mustang registered to GALT was found in Atlanta, on April 11, 1968, abandoned. Through news media, SMITH has obtained description of GALT and believes he has information which could be of value to the FBI. He furnished the following information:

On Saturday, April 6, 1968, he and his soundman, LEROY COLLINS, traveled to Spelman College, Atlanta, Georgia, to film persons viewing the body of Dr. KING, or incidents. The first roll of film that he shot was of a group of about ten people. There was one lone white male who viewed the body in this first group and he and his soundman, COLLINS, noticed the unknown male pass by the coffin and smile. He appeared to laugh, looked around to see if anyone was observing him, and he left "with a smile on his face." SMITH did not consider the incident of any value at that time, until he reviewed the information on GALT and GALT's description.

He described the unknown subject who viewed the body of KING as a white male, in his early thirties, 5' 10" to 5' 11", weight 160 - 170 pounds, dark hair, and was wearing a light-colored suit. SMITH suggested that the FBI may desire to review his first can of sixteen

millimeter sound film which is presently stored at CBS Headquarters, New York, New York. He identified the film as the only white male on the first roll of film and feels he has a good photograph of him. SMITH stated he would contact SA INGRAM later and advise where he could be reached, if needed, in the future.

At 12:32 P.M., April 12, 1968, SMITH telephonically advised from Atlanta that he was residing at the Roswell Road Apartments, Atlanta, telephone number 252-3428, and could always be reached through CBS Headquarters, Atlanta 873-3195.

Mrs. BARBARA WILLARD, who is employed at the Credit Bureau of Oxford, Oxford, Mississippi, advised that her husband, JOHN H. WILLARD is employed at Day Bright Corporation, Tupelo, Mississippi.

Mrs. WILLARD stated that her husband is the son of ENOS and MAMIE WILLARD who reside in the Thaxton Community in Pontotoc County, Mississippi. Mrs. WILLARD could not recall ENOS and MAMIE ever living in Nesbit, Mississippi.

She continued that on Thursday, April 4, 1968, her husband was at the family home, Highway 6, Pontotoc County, Mississippi, at approximately 5:30 p.m., when she arrived following the completion of her day's work in Oxford, Mississippi. She recalled that her young son was there with her husband at that time.

Mrs. WILLARD stated that her husband remained at the house the remainder of the day and the night of April 4, 1968. He mowed the lawn for a short period of time.

Normally, Mr. WILLARD completes work in Tupelo, Mississippi, at 3:30 p.m., and returns home where he awaits the return of Mrs. WILLARD. Mrs. WILLARD advised she could not say for certain where her husband was from 3:30 p.m. until 5:30 p.m., April 4, 1968, but repeated that she is absolutely certain that he was at home at 5:30 p.m., and remained there the rest of the day.

She concluded by stating that to the best of her knowledge, no one has ever used her husband's name.

Mrs. JOHN (BARBARA) WILLARD, an employee of the Credit Bureau of Oxford, Mississippi, advised that, since speaking with the Federal Bureau of Investigation earlier in the day, she recalled that while employed by the Tupelo, Mississippi, Credit Bureau (specific year unrecalled, but perhaps 1966) she was made aware of another JOHN WILLARD in the Tupelo, Mississippi, area through credit files.

She could furnish no information about this individual other than the fact that he moved to Tupelo, Mississippi, from some other city. Mrs. WILLARD could furnish no additional information.

Mr. JAMES L. TATUM, Laundry Department Director, University of Mississippi, was interviewed at the University Laundry.

Mr. TATUM advised that the University Laundry presently uses two poly-mark machines in placing laundry marks on clothing and stated that the poly-mark machines are made by the Pinnacle Company of England and are distributed by W. A. Pullrin Company of New Orleans.

He described his machines as number 1, motor number 5069033, and serial number MC1247.

He identified as machine number 2 a poly-mark, motor number G3455C-8, and serial number MC14182.

Mr. TATUM advised ~~that~~ these are the only two machines in use at present and stated they have been in use at least five years since he has been director at the laundry for that period of time. He could not state how much longer they had been in operation, however, he located an inventory card listing machine MC14182 having been purchased August 1, 1961. He advised the other machine MC1247 was purchased according to his records in approximately 1955. He advised his records were incomplete concerning this stamping machine.

He explained that each of these poly-mark machines have five adjustable dials to adjust various variations of laundry marks. He explained that the first and second ring were listed only as numerals one through nine and stated the third ring was letters A through Z and stated the two remaining rings numbers 4 and 5 were numerals one through nine. He also explained that the first ring did not have a zero and it was impossible to print such a laundry mark as 02B-6 or D2B-6, it

being noted that the first digit ring was numerals only one through nine.

He made available samples from both of these machines which have been properly marked and identified.

With reference to a thermo-seal stamping machine, he advised that he has no such machines at the University Laundry. He also checked all available records concerning the existence of a thermo-seal machine, however, could find no record of any such machine ever having been the property of the University Laundry.

He did state, however, that the laundry has blue tago electric serial numbers 23463 and 24048, both being model number BPDC5S3B1. He stated these machines have not been used in many years and that they staple on the laundry mark rather than glue it on with heat as the poly-mark machine does.

Mr. TATUM advised that he has another poly-mark machine, serial number A1576, which has not been used in approximately three years since the machine is not in working order. He advised that he purchased this machine from Mississippi State University in 1965.

He concluded by stating that he is unable to furnish the significance of either laundry mark 02B-6 or D2B-6.

JOHN A. ANDERSON was interviewed at his place of incarceration, Natchez Police Department, Natchez, Mississippi. ANDERSON was advised of the identity of the interviewing Agent and the nature of the interview, and was immediately advised of his constitutional rights. ANDERSON waived these rights by executing the waiver of rights form and voluntarily provided the following information:

ANDERSON stated that during the evening of April 8 and April 9, 1968, he was at the Fountain Lounge in Natchez, driving heavily. He stated that the owner of the Fountain Lounge, JAKE GUERCIO, whom he knew from Woodville, Mississippi, recognized that he was in an intoxicated condition and asked how he was going to get to Woodville. ANDERSON stated that he told GUERCIO he had intended to ride down with a truck driver but that it appeared that he had forgotten him. ANDERSON stated that GUERCIO told him that he would let him sleep in the Fountain Lounge and "sleep it off" so that he would not be arrested by the police for public intoxication. ANDERSON stated that GUERCIO left him in the Fountain Lounge, locked the door, and apparently went home.

ANDERSON advised that after he was left alone in the lounge, he continued to drink beer and become even more intoxicated. He stated that he found a notepad and decided to write a note and leave it in the lounge as a joke. He stated that he found a pen and wrote the following on a notepad, "I killed M.L.K. in Memphis, Tenn. The Mayor is next. The Klan." ANDERSON further stated that he had written the note he dropped the pad and misplaced it and could not find it again. ANDERSON advised that he was very drunk at the time and did not realize that the note would be taken seriously.

ANDERSON concluded that he has been in Woodville for approximately a week and that on the night that MARTIN LUTHER KING was assassinated in Memphis, Tennessee, April 4, 1968, he was at the J. B. Nettles Truck Stop, Route 61 South, Wilkinson County, Mississippi, from 7:00 PM to 7:00 AM the following morning, in a drunken condition. ANDERSON stated that he is a good friend of the owner of Nettles Truck Stop and that MILDRED NETTLES would be able to verify his story.

EFFIE LEE WALTON, nee JENKINS, Route 2, Box 119, Potts Camp, Mississippi, was located and interviewed in Marshall County, Mississippi. After being advised of the identity of the interviewing Agents, WALTON volunteered the following information:

WALTON explained she is employed at Jack's Truck Stop located on Highway 78, between Holly Springs and Potts Camp, Mississippi. She stated that in conjunction with her employment, she was at work on Thursday, April 4, 1968.

WALTON stated that on April 4, 1968, at approximately 6:30 P.M., just before dark, she was standing in the front window at Jack's Truck Stop. She explained that she had just heard a few minutes prior about the shooting incident involving Dr. MARTIN LUTHER KING. She further pointed out that she is relatively certain of the time being approximately 6:30 as she gets off of work at 7:00 P.M., and the incident she has in mind occurred prior to her quitting time of 7:00 P.M.

WALTON stated as she was looking out the front window at Jack's Truck Stop, she observed a white Mustang which she believed to be a 1967 model, pull off of Highway 78 onto the driveway of Jack's Truck Stop. She stated that two white males were sitting in the front seat of this vehicle, and that

there was one white male sitting in the rear of this car on the passenger side of the vehicle. She stated there was possibly a second individual sitting in the rear seat of the vehicle; however, she could not be certain of this. She pointed out that the car apparently had clothing, or items, hanging in the car, and she just could not be certain whether or not she had observed a second individual sitting in the back seat of the car.

WALTON stated that the Mustang came to a quick stop and the white male sitting on the passenger side of the front seat got out of the car, proceeded around the vehicle, and got behind the steering wheel of the vehicle. She stated that the driver of the car apparently just scooted over the front seat and never actually got out of the car. WALTON stated that the vehicle immediately departed in what she considered to be a rather hasty fashion, spinning its tires in the gravel.

WALTON stated that the vehicle was definitely a white Mustang and she is relatively certain that it was a 1967 model vehicle. WALTON was requested to describe this vehicle in detail, and thereafter, furnished the following information:

WALTON stated she believed the vehicle was a two door, and was definitely not a convertible or sports model car. She stated she recalls observing a chrome strip running the complete length of the vehicle, and further recalls that the car was very clean, with shiny chrome hubcaps. WALTON stated she could not be certain concerning the license plates of the car, but believed the license plates had a white background and that the numbers or letters on the license plates were a dark color. WALTON stated that the only thing she could be certain about concerning the license plates was that the license plates were not Mississippi tags.

WALTON was requested to describe the white males she observed in the white Mustang. She pointed out that

the individuals remaining in the car while it was stopped at Jack's Truck Stop were not observed by her very closely and she could not furnish any real details concerning their description. She did recall that the individuals were all white males, and she estimated the individuals to be in their early twenties. She stated that her first impression concerning these individuals was that they were young college men.

WALTON furnished the following description of the individual that actually got out of the white Mustang, and who walked around to the driver's side of this car:

Hair:	light-colored and rather long like a Beatle haircut; she explained the hair was combed to the side

WALTON stated this individual was tall and rather slim, and was wearing what she believes to have been a dark brown sports coat with a white shirt. She stated this individual was not wearing a tie, to the best of her memory. She further stated this individual walked with the top portion of his body leaning over. She explained that he did not walk standing straight up. She explained that the only other way she could describe this walk was that the individual appeared to be walking in a hurry.

WALTON has stated she did not recognize any of the individuals in this automobile, and that she did not recognize the car as belonging to anyone she was familiar with. She further stated it was questionable whether she could ever identify the one white male that she observed get out of the 1967 Mustang and walk around the car.

WALTON concluded by stating she could furnish no other information regarding the white males or the vehicle

they were driving. She did recall that the vehicle approached Jack's Truck Stop on Highway 78 from the north, and was headed south when it departed.

Mr. RICKS said when the Thermo Seal machine had been used, it had placed a tape bearing a lot and serial number on each garment. He said there were no printed tapes available and there was no way the machine could be operated in its present location and condition.

He made available for examination a Thermo Seal machine, Model H5K1, serial number 31355, which was stored in a building about one block from the laundry on the Delta State campus. The machine was covered with dust and surrounded by other miscellaneous pieces of equipment.

Mr. RICHARD DAVIS, Superintendent, Crescent Laundry, furnished the following information:

The Crescent Laundry is one of two laundries in Hattiesburg, Mississippi, to use the poly-mark system of laundry markings, the other being Southern Cleaners. The poly-mark machine, purchased from the South's main distributor, Pellerin Laundry Machine Company, New Orleans, Louisiana, prints a laundry mark on a piece of cloth tape and affixes this tape to the garment.

DAVIS advised that the cloth and tape for this machine comes in six colors plus stripes of white with these colors. He advised that the solid and striped colored tapes are varied weekly. DAVIS advised that no red tape is used, but that a shade of pink is a popular color. DAVIS related that this tape is bought from F. H. ROSS, Jackson, Mississippi.

DAVIS stated that all poly-mark machines print a laundry mark consisting of three segments, a number followed by a letter, followed by another number. He furnished the following key to the laundry mark used by Crescent Laundry:

First Number	1-99	Lot Number
Letter	A through Z (except I & O)	Week
Second Number	1-15	Customer Number

DAVIS advised that at the beginning of each week the lot number begins at one and continues as far as needed. He stated that lot numbers of less than ten use only this number and are not preceded by a zero in his system. He advised that some poly-mark machines may use a zero preceding a single digit, as he has seen such markings.

Thus, DAVIS advised the laundry mark 02B6 would not be made by his machines, for his machine would number this simply 2B6.

DAVIS stated that Crescent Laundry does work for nine other laundries in Hattiesburg, and that work for all these laundries bears these same markings. He stated that there is no way to tell what specific laundry has done a piece of work simply from looking at a laundry mark.

He stated that one other company, Southern Cleaners, uses the poly-mark method in this area. He advised that a competitive method, called thermo-seal, is of about the same popularity as poly-mark, and is used by one one laundry in Hattiesburg, Mississippi, this being the Phoenix Laundry. He stated that the tapes for these two systems are similar, but that the thermo-seal machine uses thinner tape which is harder to remove from the garment.

DAVIS stated that he had no knowledge of whether or not the Southern Cleaners used a zero in front of a single digit in their laundry mark. He made available samples of unused poly-mark tape and several printed samples from his machine.

Mr. BEARD stated that the first numerals appearing before the letter are numbered 1 to 100 which denotes the lot number. He stated the letter B would be the first hundred tickets in the lot number, and after 100, would appear a double letter; for example, BB. Mr. BEARD stated the last number, #1, would be the ticket number in the lot. Mr. BEARD stated that his above two colors are the only two colors used by his laundry, and that they do not use a red-colored marking tape.

Mr. BEARD could offer no information concerning the identity of the laundry using the code 02B 6 or D2B 6. He stated that each individual laundry uses their own code.

Mr. BEARD stated that inasmuch as his company was in the process of running full production on laundry,

Mrs. EDWARDS stated that she has never known WILLARD to be a radical individual; nor has she ever known him to carry any firearms.

Mrs. EDWARDS stated that she could not furnish any additional information concerning JOHN H. WILLARD, since she and Mrs. WILLARD are not in daily contact since BARBARA WILLARD is no longer employed at the Tupelo Credit Bureau.

DAVID MARLON BREWER, 1043 Pyle Street, Jackson, Mississippi, telephone number 352-6813, was interviewed at his place of employment, Hodges Engineering Company, 5175 Galaxie Street, Jackson, Mississippi. BREWER was advised of the identity of the interviewing Agent and the nature of the inquiry. He furnished the following voluntary information:

BREWER advised that he is the owner of a 1965 black Mustang convertible with a white top and the vehicle has 1968 Mississippi license HB-9317 on it. This tag was purchased for a 1962 Ford Falcon which was sold to a teenager in Jackson, Mississippi, and BREWER removed the tag and placed it on the Mustang when he purchased it, without advising anyone of the transfer of license plate. BREWER advised that he has not been in this Mustang recently since he was having trouble making the monthly payments and he let OSCAR WORD, an employee of the Briarwood Texaco Station, Interstate 55 North, Jackson, Mississippi, take over the vehicle and the monthly payments in February, 1968. BREWER advised that WORD has been having trouble with his wife recently and about a week ago, she took the Mustang and their children and left WORD, allegedly going to stay with her mother at Las Vegas, Nevada. About Wednesday, April 10, 1968, WORD found out where his wife was in Nevada and took a bus there immediately to either bring her back or bring the Mustang vehicle back.

BREWER advised he has not seen WORD for about a week but believes he will be back at work at the Briarwood Texaco Station as soon as he returns to Mississippi.

BREWER described OSCAR WORD as follows:
