RIGHT FOUR FINGERS TAKEN SIMULTANEOUSLY

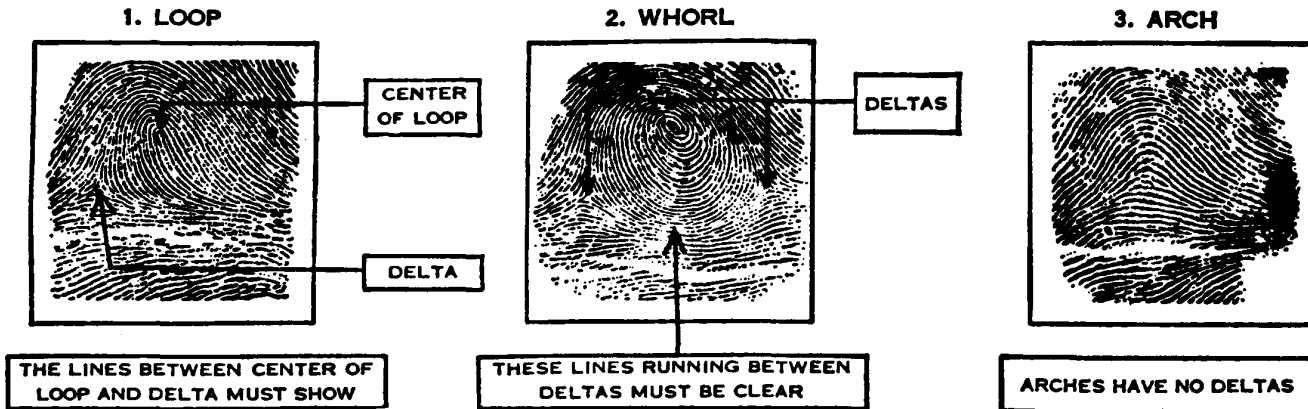

APPLICANT

To obtain classifiable fingerprints:

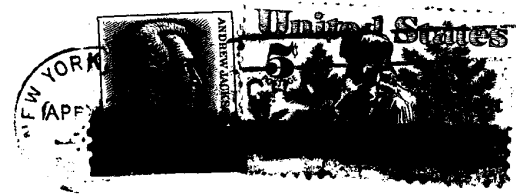
1. Use printer's ink.
2. Distribute ink evenly on inking slab.
3. Wash and dry fingers thoroughly.
4. Roll fingers from nail to nail, and avoid allowing fingers to slip.
5. Be sure impressions are recorded in correct order.
6. If an amputation or deformity makes it impossible to print a finger, make a notation to that effect in the individual finger block.
7. If some physical condition makes it impossible to obtain perfect impressions, submit the best that can be obtained with a memo stapled to the card explaining the circumstances.
8. Examine the completed prints to see if they can be classified, bearing in mind the following:
Most fingerprints fall into the patterns shown below (other patterns occur infrequently and are not shown here):



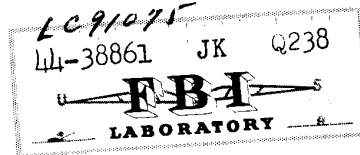
Law-enforcement agencies using this card for pistol permits, licenses, etc., should indicate type of permit or position in space "COMPANY AND ADDRESS."

Department of Defense activities and contractors initiating this card will make no entries in "CONTRIBUTOR AND ADDRESS" and "NUMBER." Such entries will be made by the Department of Defense investigative agencies concerned. Department of Defense activities using this card for military personnel or civilian employees will enter designation and address of requesting activity in "COMPANY AND ADDRESS." Department of Defense contractors will enter contractor's name and address in "COMPANY AND ADDRESS."

The space "NUMBER" should contain the number designated for the particular case or code designation. The number appearing in this space will be quoted on answers to the fingerprint search.

April, 1968.

TO WHOM IT MAY CONCERN:

Please pass on to all the authorities wherever possible - to
discontinue the search of a white man, as the killer of Martin
Lucifer King, because the smart killer is right now in his own
family. He is one of his own Civil Rights Urinators and a negro,
not a white. I was among them myself in 1965, there were many
young nuts, such as was I, and also many whites. However, God
opened my eyes in Alabama when I witnessed the behavior of our
marchers under King's leadership. He was a devil's minister, tak-
ing all the money he could from the jews, and doing his work un-
der their leadership and demand. Those were communist jews.

While marching in Alabama in 1965 - it was in spring - we were
instructed by King's advisers-red-rat-jews to do the following:

A group of our negroes forced their way into a nice restaurant;
on a given signal, all the negroes grabbed the sugar bowls off
the tables, stood up and urinated into them, amid laughter, re-
placed the bowls on the tables - MLK laughed approvingly.

This is the reason why I, and many others, turned against him,
and it was God's will that he was shot by one of his own discip-
les, a negro, not a white. Please stop all your sham broadcastings

and grateful homage for that killed Martin Lucifer King - He was
against our best President LBJ - for the nut hippie Bobby Kennedy,

him in Atlanta in the King's family.

You must understand that I cannot reveal my real name and
address, although I actually do live in Marion. Please do not
hesitate to use my information, because it is God's truth.

I am mailing 7 of these letters to various places - why 7?
Because yesterday was Good Thursday, the last Supper of Jesus
Christ, as a reminder of HIS seven words on the Cross:

"Into Your Hands I commend my soul!"
May your Easter be blessed!
