

V. D. LOCHARD, District Plant Manager, Southern Bell Telephone Co., advised that JAMES M. HALL worked for the Southern Bell Telephone Co. on 3/29 and 30 and 4/4/68, a full eight-hour shift on each day.

ROY ARMSTRONG, Manager of the Armstrong Plumbing Co., Montgomery, Ala., advised that LEROY LAMAR DUCKER worked on 3/29 and 30 as well as 4/4/68, for his company.

From the above investigation it would appear that the three suspects mentioned were all in the Montgomery area on the 29th and 30th of March with the exception of BELL, who did not work on the 30th, and all of these individuals reported to work and worked a full shift on 4/4/68, which would eliminate them as suspects in this case.



THE CRIMES: Ray escaped from the Missouri State Penitentiary, Jefferson City, Missouri, on April 23, 1967, while serving a 20-year sentence for armed robbery and operating a motor vehicle without the owner's permission. He subsequently allegedly conspired, under the alias Eric Starvo Galt, to violate the civil rights of Dr. Martin Luther King, Jr., shot to death on the balcony of a Memphis, Tennessee, motel on April 4, 1968.

THE CRIMINAL: A 40-year-old white native of Illinois, who is known as a "loner" and "drifter" and has taken elaborate steps to establish a false identity. Ray has an extensive criminal record, including convictions for burglary, robbery and forging U.S. Postal Money Orders. Outstanding characteristics include a straight narrow nose, straight and even teeth, a noticeably protruding left ear and a nervous habit of tugging at an ear lobe. He has taken dancing lessons, attended bartending school, enrolled in a correspondence course in locksmithing and traveled widely in a 1966 Mustang recovered in Atlanta, Georgia, a week after Dr. King's murder. Ray likes western and country music, drinks vodka and beer and has worked as a baker, laborer and color matcher.

PROCESS: A Federal warrant issued at Jefferson City, Missouri, on July 20, 1967, charges Ray with unlawful interstate flight to avoid confinement for robbery. Another Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, as Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a citizen.

He stated that now that FAULKNER's name has been brought to his attention, he is of the opinion that BILLY JOE FAULKNER resembled the photo of ERIC STARVO GALT and JAMES EARL RAY that have been in the newspapers.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray, who escaped on April 23, 1967, from the Missouri State Penitentiary, is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery.

Possessing an arrest record dating back to 1949, Ray has been convicted of burglary, armed robbery and forging United States Postal Money Orders.

A 40-year-old white male, reportedly born in Illinois on Ray is approximately 5'10" tall, weighs from 163 to 174 pounds, has blue eyes and short brown hair. He has a nervous habit of tugging at an ear lobe and his left ear protrudes noticeably.

Described as a "loner and "drifter," with a "rural" quality in his speech, Ray has worked as a baker, laborer and color matcher. He has taken dancing lessons and completed a course at a school of bartending.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray, who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year-old white male, reportedly born in Illinois on He is approximately 5'10" inches tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. He has a small scar on the center of his forehead and a scar on the palm of his right hand. He has been described as having a straight, narrow nose and straight and even teeth and to have a nervous habit of occasionally tugging at an ear lobe. His left ear protrudes noticeably.

Acquaintances describe him as a "loner" and "drifter" whose language and diction reflect a "rural" quality and indicate he has had limited education.

He is reportedly a fan of western and country music, drinks vodka and beer, dresses neatly and claims past employment as a merchant seaman and cook on Mississippi River vessels. He is known to have worked as a baker, laborer and color matcher.

He is known as an avid dancer who has taken dancing lessons. He also completed a course at a school of bartending in the Los Angeles area early in 1968.

Ray should be considered armed and extremely dangerous.

Bureau teletype, 4/24/68, has instructed contact be maintained with all mass communications media to insure that there is frequent reference to RAY and his connection with this case.

It is noted that Wanted Flyer 442, Wanted Flyer 442A and IO 4182 have been issued on subject and widely distributed. Leading newspapers and leading radio and TV stations have been furnished data concerning RAY, including photographs.

Each agent receiving this memorandum will contact all TV stations in his territory, leading newspapers, and leading radio stations, in order to insure particularly that the newspapers and TV stations run photographs of RAY periodically, at least weekly, if possible, and that radio stations periodically make reference to this case.

The Bureau also requested we make certain that all appropriate stops have been renewed on RAY under all of his known aliases as set out on the wanted flyers and IO. Stops have been placed in the past in Montgomery with the Drivers License Division and the Motor Vehicle Division, and SA ROBB or SA STEPHENS should make sure that these stops include all of the known aliases of the subject.

The Bureau also instructed in this teletype that appropriate investigation at all "hippie" rooming houses and similar establishments be made for any information whatsoever concerning RAY. SAS HEGSTETTER and SPONHOLTZ are handling contacts with different rooming houses in Mobile to alert them concerning subject, and each agent receiving this memorandum will see that appropriate rooming houses are contacted and alerted concerning the possible appearance of subject.
