

The writer telephonically contacted RITA REHKOPF, 6805 Veterans Highway, telephone 888-6708, and referred to her conversation during the early morning hours of \4/26/68 with SA KENNETH OERTEL in which Miss REHKOPF indicated that she would like to have protection by the FBI as a result of having received some crank telephone calls over the past few days.

Miss REHKOPF interrupted the writer to state that she found SA OERTEL to be a very fine gentleman and that he was most helpful in calming her emotional state.

Miss REHKOPF was advised that while the FBI did not offer protection to private citizens, this office would, if she so desired, notify the Jefferson Parish SO of the fact she had been receiving crank telephone calls. Miss REHKOPF stated that she would prefer that the FBI not contact any local law enforcement agency and if she felt she needed protection, she would handle this herself, or call this office back.

Miss REHKOPF stated she had just been in telephonic contact with her aunt in Oklahoma and that this aunt had indicated she would be willing to fly to New Orleans on this date and spend a week with RITA.

Miss REHKOPF then went into a long description of her physical ailments, which include malaria and a kidney malfunction. She stated that she knew that she was emotionally upset and that she could not bear to be along. She stated if the aunt could not spend the night with her, she would contact the Delta Airlines Stewardess Supervisor Miss QUILTER and request that she spend the night with her in her apartment.

Miss REHKOPF stated that she had received no further crank calls but that some fellow she barely knew had called her three times last night but she felt that this man was more of a nuisance than a crank.

Miss REHKOPF told Det. Crossen she was a stewardess for Delta Airlines, her age was 21, DOB at Washington, B.C., Social Security number, home phone 888-6708.

Miss REHKOPF stated the FBI agents told her she was the last person to see GALT.

Det. Crossen stated the reason she was contacted by the intelligence division of JPSO was when she contacted the JPSO she stated she was receiving threatening phone calls and she knew GALT.

Det. Crossen advised he was leaving Miss REHKOPF's apartment and was going home. He stated his home phone was 887-7243. Det. Crossen was advised that an agent would contact him at his home.
