



- DURING THE INTERVIEW, CURTIS DREW CRUDE MAPS SETTING LOUT HOW HE THOUGHT RAY WOULD STALK KING. THIS MAP SHOWED THE FOLLOWING TOWNS WHERE HE SAID KING MADE MOST OF HIS SPEECHES: ATLANTA, LITTLE ROCK, BIRMINGHAM, MOBILE, SELMA, JACKSON, VICKSBURGS, MISS., AND MARKS, MISS. HE FURTHER POINTED OUT THERE WAS A MAN LIVING ON A HOUSEBOAT IN VICKSBURG ON THE MISSISSIPPI RIVER (WHOSE FIRST NAME HE KNEW BUT WOULD NOT DIVULGE). THIS MAN WAS TO TAKE RAY DOWN THE RIVER ON HIS BOAT TO NEW ORLEANS AFTER THE KILLING. HE STATED IN THE PAST HE (CURTIS) HAD PULLED SEVERAL BURGLARY AND ARMED ROBBERIES (HE WOULD NOT COMMENT ON PARTICULARS) IN TOWNS ALONG THE MISSISSIPPI RIVER AND WHILE POLICE WERE LOCKING FOR HIM ON THE HIGHWAY HE WOULD BE ON A BOAT DOWN THE MISSISSIPPI. HE FURTHER STATED HE HAD WRITTEN A STORY CONCERNING THE KING KILLING WHICH WAS CURRENTLY OUT BEING TYPED AND IT WAS THE STORY HE MENTIONED IN THE LETTER TO EBONY AND INTENDED TO SELL TO EBONY.

SHERIFF G. T. MAULDIN, NA, WHO IS SHERIFF OF WHITFIELD CO., GA., AND OPERATES THE COUNTY JAIL, ADVISED CURTIS HAD SENT NO LETTERS OR COMMUNICATIONS FROM THE JAIL WHICH WENT GVER THE JAILERS DESK. HE SAID CURTIS WOULD PROBABLY SEND ALL MAIL OUT WITH VISITORS AND JAIL TRUSTEES AND WOULD PROBABLY NOT HAVE BEEN OBSERVED BY MEN OF HIS DEPT.

IT IS FURTHER POINTED OUT THAT CURTIS' ATTORNEY, ERWIN MITCHELL, FORMER U.S. CONGRESSMAN FOR THE SEVENTH DISTRICT OF GA., IS OF THE OPINION THAT MOST OF CURTIS' COMMENTS CONCERNING HIS KNOWLEDGE OF RAY'S ASSASSINATION OF KING ARE PURE FABRICATIONS ON THE PART OF CURTIS OR AS A RESULT OF SOMETHING CURTIS HAS READ IN LOCAL PAPERS.

NOW WANTED TO TELL THE ENTIRE TRUTH. CURTIS WAS AGAIN

INTERVIEWED BY SA THOMAS R. HENRY, JR., AND AGAIN FURNISHED

A RIGHTS FORM WHICH HE REFUSED TO SIGN. HE THEN STATED

THAT APPARENTLY IN HIS LETTER TO EBONY HE USED THE WORK

"WE" INDICATING THAT HE AND JAMES EARL RAY HAD PLANNED THE

KING WURDER WHICH WOULD INVOLVE HIM IN A CONSYLRACY AND FOR

THAT REASON HE DENIED THE STATEMENTS IN LETTER TO EBONY. THEN ADVISED HE HAD WRITTEN A STORY WHICH HE INTENDED TO SELL TO SOME MAGAZINE FOR THE PURPOSE OF OBTAINING MONEY FOR HIS NOTHER WHICH STORY WAS STILL IN HIS POSSESSION AND WHICH HE HAD NOT YET SENT OUT TO BE TYPED. HE ALLOWED SA HENRY TO READ THIS APPROXIMATELY TWENTY PAGE STORY, HANDWRITTEN, ONE PAGE AT A TIME. HE DECLARED THIS STORY WAS TRUE. THE FIRST FIVE OR SIX PAGES OF THIS STORY MERELY SET OUT HIS EARLY LIFE IN CRIME AND THE PRISON SENTENCES HE HAD SERVED AS A RESULT OF THESE CRIMES FROM THE AGE OF FIFTEEN. REMAINDER OF THE STORY IS THE SAME AS WAS SET FORTH IN THE ORIGINAL INTERVIEW WITH CURTIS IN APRIL, SIXTYEIGHT CONCERNING HIS KNOWLEDGE AND ASSOCIATION WITH RAY. THIS STORY DOES REFLECT THAT HE FIRST BECAME ASSOCIATED WITH RAY IN FIFTYFOUR WHEN THEY PULLED A PAYROLL HEIST IN QUINCY, ILL., WITH A THIRD INDIVIDUAL. SHORTLY THEREAFTER. THE STORY ALSO MENTIONED A MAN FROM NEW ORLEANS WHO COULD OBTAIN ANY KIND OF IDENTIFICATION AND CURTIS

Mr. WILLIE's bome and main plantation is located near Wabbaseka and had a mailing address of Wabbaseka, Arkansas. Mr. CHARLES WILLIE was formerly President of the Altheimer First National Bank. Mr. WILLIE died approximately three years ago. Mrs. CHARLES WILLIE was named NELL and they owned a houseboat which Mr. BARNETT believes was known as "Nell Willie" and which houseboat



BUNNETT of Monroe, Louisiana, and is now known as Mrs. J. BURACTT. Mrs. NELL BURNETT and Mr. J. BURNETT spend the majority of their time in the area of Monroe, Louisiana, but also reside some on the bayou farm at Wabbaseka, Arkansas, when they are in this area. Mr. J. BURNETT is believed to have been in the real estate business in Monroe, Louisiana. Mrs. NELL BURNETT and Mr. BURNETT are not in the area of Altheimer and Wabbaseka, Arkansas, at this time. Mr. H. J. CANNON, Cashier-Vice President, First National Bank of Altheimer, advised SA GEORGE A. BARRON, JR., on 7/9/68 that Mr. CHARLES WILLIE was a well-respected plantation owner and was formerly President of the Altheimer First National Bank, Altheimer, Arkansas, and has now been deceased about three years. He advised that the BURNETTS are not in the Altheimer-Wabbaseka area and he did not know when they would return to this aca. Mr. JOHN HENRY JOHNSON, Wabbaseka, Arkansas, furnished the following information to SA BARRON on 7/9/68: He checks on and takes care of the house and grounds at the bayou farm, Wabbaseka, Arkansas, for Mrs. J. BURNETT. Mrs. J. BURNETT and her husband are presently on a trip in Georgia and the Carolinas, and Mr. JOHNSON has no idea as to when they may return. He advised they may return to Monroe, Louisians, before returning to Wabbaseka, Arkansas. Mr. and Mrs. J. BURNETT reside as much in Monroe, Louisiana, as they do in Wabbaseka, Arkansas. Mr. JOHNSON furnished the telephone 2025 RELEASE UNDER E.O. 14176

LR 157-1215 number 387-0214, Area Code 318, as the telephone number in Monroe, Louisiana, where he reaches Mr. and Mrs. J. BURNETT when they are in Monroe, Louisiana. He further advised that Mrs. J. BURNETT had a cousin, JIM RHODES, and that JIE RHODES possibly could furnish information as to when Mr. and Mrs. BURNETT would be returning to either Monroe or Wabbaseks and could furnish information as how Mrs. BURNETT could be contacted. JIM RHODES's telephone number is Monroe telephone number 325-0429. LEADS: NEW ORLEANS DIVISION At Monroe, Louisiana. Will contact Mr. JIM RHONES, telephone 325-0429, a cousin of Mrs. J. BURNETT (NELD BURNETT, former widow of Mr. CHARLES WILLIE), and determine when Mrs. J. BURNETT will be returning either to Monroe, Louisiana, or Wabbaseka, Arkansas, and at which location she will first be available for interview by an FBI Agent. 2. Will attempt to locate Mrs. J. On July 8, 1968, Mr. J. W. Cromier, Manager, Memphis Yacht Club, Memphis, Tennessee, advised that the Hell Willey is a 55-feet, steel-hull, diesel-powered house boat that is owned by Mr. A. D. Cartwright, Jr., the owner of Cartwright Murmarisa, Colliseville, Tennessee. Mr. Crosier stated the Hell Willey was purchased by Mr. Cartwright several years ago, and that prior to being owned by Mr. Cartwright, this boat was docked at Greenville, Mississippi.

On July 12, 1968, Mr. Marion Looney, Secretary, Cartwright Hurseries, Collierville, Tennessee, advised that Mr. A. D. Cartwright, Jr., is out of the city and unavailable for interview. Mr. Looney said that Mr. Cartwright purchased the Nell Willey from Mrs. C. C. Milley, Altimer, Arkansas, about three years ago, and at the time of purchase this beat was docked at Mouroe, Louisiana. Mr. Looney said that for the past three years this boat has been docked at the Momphis Yacht Club and is used only to entertain customers. Me said there is no regular crew and that the best is operated by Mr. Cartwright and his sons. He also stated that this beat selden goes more than 10 miles in either direction from the Momphis Yacht Club and has not been used for lengthy trips on the Mississippi River.
