In addition were the words "Herbie" or possibly interpreted as "Shirley," with the last name possibly "Porich" or "Porick"; also the number "3619-Robert"; also a name interpreted as "Jane Penney" or "Fenney."

The following investigation was conducted by SA RICHARD K. BUTZ at Baton Rouge, Louisiana, on April 5, 1968:

At the Department of Public Safety, Louisiana Driver's License Division, File Room, a search was made of the purged driver's license applications, which are applications of persons who have not renewed their driver's license, under the name GALT, LOWMEYER, and WILLARD, as well as variations of the spellings of these names. The review of the driver's license applications by name as well as date of birth failed to show any driver's license application under these names or variations of the names.

ALTON MC KEE, Data Processing Unit, Louisiana Driver's License Division, Department of Public Safety, advised his office maintains punch cards of all persons who have not renewed their driver's license in the State of Louisiana and whose driver's license application would be purged from the files of the driver's license application. A search of these files failed to show that any person with the last name of GALT, LOWMEYER and WILLARD as having an expired Louisiana driver's license. He advised that these files would contain licenses which would have expired back to 1961.

Mr. MC KEE advised that the current files of the Louisiana Driver's License Division are maintained on magnetic tapes, which are used in conjunction with computers maintained by the Driver's License Division. He advised he could search the files with the computer using the date of birth
