Records of the Credit Bureau of Greater Shreveport reveal same name and address for Doctor. JOHN C. HARDIN, 129 Ardmore, wife SADIE, age approximately 74 and retired. Record in file since January, 1943. No derogatory information.

Dr. JOHN C. HARDIN, born [redacted] wife NANCY, dentist since 1956, no derogatory information.

Police Department and Sheriff's Office records checked for Doctors JOHN C. HARDIN and JOHN C. HARDIN, JR. negative.

Date September 9, 1968

Reverend MIKE MURDOCK telephonically advised from Lake Charles, Louisiana, that he understood the Federal Bureau of Investigation had made inquiries in Texas and in the Lake Charles area concerning him. He stated that he travels almost constantly and is extremely difficult to reach on a day-to-day basis.

When asked if he recalled anyone making a telephone call to him during the middle part of December, 1967, from any place in Texas, he stated that the only call he remembers which may have taken place during the month of December would have been a telephone call from another minister who advised him concerning a revival meeting to be conducted by him.

Reverend MURDOCK stated that he does not know JAMES EARL RAY and, to the best of his recollection, he never met or saw him.

Reverend MURDOCK said that for the next two weeks, commencing September 3, 1968, he could be reached in care of BOB BRANTLEY, 304 West Parkhurst, Bastrop, Louisiana.
