GERTRUDE FRITH, 102 Arlington Street, advised that her son, BILLY RAY KING, left the Lake Providence area on April 4, 1968, to return to his job with KGW Towing Co. The exact time of his departure is unknown inasmuch as his girlfriend MARJORIE KENNEDY drove him to Greenville, Mississippi, to catch a bus to Quincy, Illinois, where he was to board a riverboat. Mrs. FRITH has not heard from her son since he left Lake Providence on April 4, 1968.

FRITH stated that her son recently purchased a 1967 Mustang two-door, blue in color, from TRAVIS SHEFFIELD. She stated the 1967 Mustang is presently in the possession of MARJORIE KENNEDY who resides at 501 Davis Street, Lake Providence, Louisiana.

FRITH further advised that to the best of her knowledge her son BILLY RAY KING has never been associated with the Ku Klux Klan or any militant-type group. She stated KING works on a tow boat on the Mississippi River and is, therefore, not home much of the time.

MARJORIE KENNEDY, 501 Davis Street, advised that she drove her boyfriend, BILLY RAY KING, to Greenville, Mississippi, April 4, 1968, where he boarded a Trailways bus for Quincy, Illinois. They used KING's 1967 Mustang. To the best of her knowledge KING left Greenville, Mississippi, by Trailways bus at approximately 7:00 PM, April 4, 1968. KENNEDY stated that she returned to Lake Providence in the 1967 Mustang which she is keeping until KING returns in May. At about 10:00 PM, April 4, 1968, she received a call from KING who stated that he was in Clarksdale, Mississippi, at the Downtowner Motel. He stated that the bus could not go any further than Clarksdale and requested her to pick him up at the Downtowner Motel. She then drove to Clarksdale, Mississippi, where she picked up KING at about 1:00 AM, April 5, 1968, and they returned to Lake Providence. In the late morning hours on April 5, 1968, she drove KING to the KGW Towing Office, Greenville, Mississippi, where he was to obtain transportation to his tow boat. KENNEDY advised that she did not know how KING left Greenville, Mississippi, inasmuch as she returned to Lake Providence immediately after she dropped him off at the KGW Office.

KENNEDY advised that to the best of her knowledge KING is not associated with the Ku Klux Klan or any militant groups. She also stated that to the best of her knowledge KING only had a duffle bag containing his clothes when he left Lake Providence, and she does not know of any weapons in his possession.

KENNEDY pointed out the 1967 Mustang two-door, blue in color, parked in front of her residence as the one recently purchased by KING. The registration for this vehicle reflected that it has vehicle identification number 7T01T171813, bearing 1968-69 Louisiana License 86F948. The registration further reflected the owner as TRAVIS SHEFFIELD.

He stated he was driving the company's 1964 C600 tilt-cab Ford truck, which is twenty-seven feet long, bearing Louisiana license 292028. He advised he has no information whatsoever, concerning the killing of Dr. KING.

At 10:10 p.m., Central Standard Time, April 4, 1968, an anonymous telephone call was received by the New Orleans Office from a person believed to be a white male, who advised he was a resident of Memphis, Tennessee, and that he was calling from Alexandria, Louisiana. The caller steadfastly refused to identify himself, but furnished the following information:

About breakfast time Wednesday, April 3, 1968, he was in the restaurant at the Downtowner Motel, Memphis, Tennessee. ~~BERNARD LANSKY~~, LANSKY's brother and an unknown white male were seated about three feet away at the next table. LANSKY is the owner of Lansky's Clothing Store, Beale Street, Memphis. The caller described the unknown white male as 26 or 27 years old, 160 to 165 pounds, 5 feet 8 inches tall, straight black hair.

BERNARD LANSKY was heard to tell this unknown white male, "Let's get the black mother (obscene). If he comes back we are going to be bankrupt."

The unknown white male said, "I want half now."

BERNARD LANSKY was heard to say that the unknown white male was to get the other half after the job was done.

The anonymous caller stated he saw money change hands, and heard the amount \$1000 mentioned. The caller also overheard arrangements made for the unknown white male to leave town after the job. The caller furnished no other details concerning this event.

The caller stated that Lansky's Clothing Store is on the verge of bankruptcy, was fire bombed last week, and this "was final blow."

RONALD BARDIN SIMPSON was interviewed at the ~~the~~ Jefferson Davis Sheriff's Office in the presence of Deputy Sheriff **GEORGE SPEIGHT**. He was advised as to his rights and advised that he understood his rights but was very nervous and did not desire to sign any document.

SIMPSON stated that he was born on [redacted] in Halifax County, North Carolina, and that prior to December 24 or 25, 1967, he was at the Veterans Administration Hospital in Durham, North Carolina, where he was being treated for a nervous disorder. He advised that he was granted Christmas leave and in December hitchhiked to the West Coast where he remained until approximately March 15, 1967. He then traveled to Texas where he worked for Mr. **AL WEBB**, 4010 West Highway 80, Big Spring, Texas. On April 4, 1968, he recalls that he spent the entire day at the "Honey Hut," a Negro bar located in Houston, Texas, address unknown. He recalls being in this bar from the early morning hours until approximately 6:00 or 6:30 PM, April 4, 1968. On or about April 5, 1968, he then began hitchhiking from Houston via Interstate 10 east with the intentions of returning to Durham and to the Veterans Administration Hospital as his nervous disorder has become worse in the past few months. He denied being in Memphis, Tennessee, April 4, or March 28, 1968 and advises the last time he was in Memphis was approximately two years ago and he was merely passing through the city at that time. He stated he has no relatives or friends in Memphis, Tennessee.

Deputy Sheriff GEORGE SPEIGHT, Jefferson Davis Sheriff's Office, advised that on the morning of April 6, 1968, at approximately 8:30 AM, he received a call from officials at the Southern Pacific Railroad, advising that a white male was sleeping near the railroad tracks just east of the main section of Jennings. He advised he arrested this individual who furnished the name and had identification in the name of RONALD BARDIN SIMPSON, white male, born [redacted] Halifax County, North Carolina.

Deputy SPEIGHT advised that he had observed the penciled sketch of the subject wanted for the assassination of MARTIN LUTHER KING carried in the "Beaumont Enterprise," a Beaumont, Texas, morning newspaper and that this sketch resembled SIMPSON except for the well dressed appearance and hair of the subject as depicted in the sketch.

He stated that SIMPSON told him he had been hitchhiking from California to his home in Roanoke Rapids, North Carolina, at the time he was arrested, and on March 28, 1968, and April 4, 1968, he was in the Texas area. He arrested SIMPSON on vagrancy charges, and he advised that it was quite obvious that SIMPSON was extremely nervous and needed mental care.

On April 8, 1968, the following information was received from the Dallas Office of the FBI:

NANCY SAUVIER, 302 Louisiana, Abilene, Texas, advised that she had seen what was an alleged artist conception in an Abilene newspaper, of a suspect in the shooting of MARTIN LUTHER KING, JR.

She informed that on the evening of March 28, 1968, she met an individual by the first name of MARK (LAST NAME UNKNOWN), at the Ramanda Inn, located in a town about thirty miles east of Shreveport, Louisiana. This person was supposedly a salesman for the Top Value Trading Stamp Company, from Alexandria, Louisiana. This individual sat near her at dinner and, subsequently, visited with her in her room.

She described MARK (LNU) as about six feet tall, receding hairline, and last saw him leaving the motel on the following morning in a red car, possibly a Porsche. She did not know in what direction he went. She has no basis other than the apparent feeling that MARK's (LNU) physical description is similar to that of the artist conception.
