On April 17, 1968, information was received from the FBI laboratory, Washington, D.C., that an examination of the Provincial Motel registration card dated December 17, 1967, at New Orleans, and signed "Eric S. Galt," had been conducted. It was determined that there were no latent impressions of value on this registration card, that the handwriting appearing on this registration card does not sufficiently augment previous writings of GALT to permit a satisfactory comparison of the "Harvey Lowmyer" signature with writings attributable to GALT.

The Laboratory further advised that no latent impressions of value were developed on the two sets of stationery which had previously been obtained from Room 126 of the Provincial Motel at New Orleans, Louisiana.
