The following investigation was conducted by
SA WILLIAM F. KUSCH, at New Orleans, Louisiana:

WILLIAM HARNEN, who resides at 4532 South Tonti,
New Orleans, and is a practicing attorney in the City of
New Orleans, furnished the following information to SA KUSCH
on April 19, 1968:

HARNEN stated that he had handled some legal details
in connection with the Continental Dance Studios owned
by Mrs. LOUELLA M. LUTZ. HARNEN furnished the following
information from his available records and his memory concerning
LUTZ and her associates:

LUTZ, when in New Orleans, resided at the Claiborne
Towers, but since June, 1966, has been residing in Apartment 7,
5515 Ash Street, Los Angeles, California. He stated that LUTZ
was a widow who had come into quite a tidy sum of money at
the time of her husband's death. HARNEN stated that LUTZ was
about years of age at the time and in his words, "a real pigeon."
He advised MARLIN CARL MYERS came along and promoted the
Continental Dance Studios. HARNEN stated MYERS ran the
Continental Dance Studios and that LUTZ took no active part
in this operation. HARNEN expressed the opinion that MYERS
was taking care of LUTZ in the love department and at the
same time was bilking her to the tune of \$40,000 or \$50,000
with the Continental Dance Studio operation. HARNEN stated
MYERS installed his girl friend as the secretary and between
the two of them they got the books in such a state that no
one could figure out what was what.

HARNEN stated that most of the male dance instructors
in this area, as well as other areas, are "gay," but he
did not feel that the female instructors were "gay."

He stated that one (FIRST NAME UNKNOWN) SNYDER,
associated with Drackett and Drackett, an accounting firm
located on Veterans Highway, Metairie, handled the Continental
bookkeeping accounts.

HARNEN furnished the proper corporate name of
Continental as the Continental Dance Club Studio, Inc., having
been incorporated on February 26, 1964.

Mrs. GALIANO advised that she took lessons at the Continental Dance Studios, 729 Common Street, New Orleans, Louisiana, during the late part of 1964 and the early part of 1965. Mrs. GALIANO stated that the names ERIC S. GALT and HARVEY LOWMEYER mean nothing to her, but that she associates the name WILLARD with one of the instructors at the Continental Dance Studios. Mrs. GALIANO said that Mr. WILLARD was not her instructor and therefore she could not describe him in any way, but did associate the name WILLARD with one of the instructors. Mrs. GALIANO was then shown the two photographs of ERIC S. GALT and she advised that neither picture meant anything to her and that as far as she could tell, she had never seen this individual before.

Mrs. GALIANO furnished the following names as those individuals being instructors while she took dancing lessons:

Mrs. GALIANO advised that she had a photograph of herself and Mr. MARCAUS dancing together which she exhibited to this Agent but she stated she had no other photographs of any of the instructors or students.

Mrs. GALIANO said that one student that she could remember was a CECILE ROBERTS, who has the married name of VERETTE now, and lives at 400 Avenue C, Westwego. Mrs. GALIANO stated that ROBERTS continued the dancing lessons after she (GALIANO) left and Mrs. GALIANO advised that ROBERTS had signed up for some of the higher dancing instructions. Mrs. GALIANO said that a Mrs. LUTZ was also a student there but that she knew of no other connection of Mrs. LUTZ with the school. Mrs. GALIANO said that a Mrs. BOBBIE JACKSON was another student that she remembered who supposedly lived in the city of New Orleans and was separated. Mrs. GALIANO said that she did not know JACKSON'S maiden name nor did she know where she actually lived in the city.

Mrs. GALIANO said that Mr. MYERS was part-owner of the dance studio when she took lessons along with another fellow whose name is unknown to her.

Mrs. GALIANO advised that she had remarried and that her married name is now FAIGOUT. Mrs. GALIANO stated that her home phone is 341-4515 and that she works at the High Style Beauty Salon, Westwego, corner of Fourth Street and Avenue B, telephone number 347-3995.

MARCUS FELOS, 1018 Delachase, telephone number 899-5067, advised he was employed as a dance instructor at the Continental Dance Studio, 729 Common Street, from October or November of 1963, to June of 1964. He stated that he was drafted into the U.S. Army, in June, 1964, and did not return to the New Orleans area until July, 1966, at which time the Continental Dance Studio was closed.

FELOS advised that the names ERIC S. GALT, JOHN WILLARD, and HARVEY LOWMEYER, were not familiar to him.

The photographs of ERIC S. GALT were exhibited to FELOS and FELOS stated that he had seen this individual before, but he could not associate the photographs with the name GALT. He stated he associated this photograph with night-life in New Orleans, and some type of dancing, but he could not positively state that this individual in the photograph had any connection with the Continental Dance Studio. He stated that he associates the name JOHNNY with this photograph, and recalls JOHNNY as a "country or rural type individual". He could not elaborate on this description of country or rural, but stated JOHNNY had an air about him that led one to believe he was not one from the city.

He stated the Continental Dance Club held parties at the Boom Boom Room, which was formerly located on South Claiborne Avenue, across from Tulane dormitories, and this establishment is now known as Whiskey-a-go-go. He also stated that he had heard the dance studio held parties at the Fontainebleau Hotel, and the Macombo Club after he left.

He advised that Mr. MYERS, the co-owner of the Continental Dance Studio, had informed him that BOB STERLING was now in Alabama, and CHARLES HART was now in Chicago, Illinois, and was connected in some way with the dancing business. He stated FRANK D. and JANET KAISER were married, but he did not know their present location. He stated in 1966, JANET KAISER's telephone number was 887-9431. He stated YVONNE BENOIT was from Houma, Louisiana, and her father ran either an auto shop or a machine shop.

He stated the following individuals were students at the Continental Dance Club, during his employment:

(FIRST NAME UNKNOWN) JONES, a white female in her late 50's

He advised that just before he went into the Army, he sold (FIRST NAME UNKNOWN) JONES a life-time membership in the Continental Dance Studio, and further advised that JONES appeared to be a close friend of Mrs. LUTZ, former financial backer of the Continental Dance Studio. He also advised that JONES frequents the Macombo Club on Canal Street, and is believed to be living with a young dance instructor.

During the interview of a FRANK DESIMONE by SA CHARLES W. DRAPER, Mr. DRAPER advised that SAM CALON had been a dance

instructor at the Continental Dance Studios in New Orleans sometime in 1964. He stated he did not know CALON's present whereabouts but recalled someone having told him that CALON had worked at the Michaud Plant in New Orleans.

Mr. JOHN ALLAN, Security Officer, Boeing Aircraft Co., NASA Complex, New Orleans, La., caused a record check to be made of present and former employees of Boeing Aircraft Co., Crysler Corp., and other companies servicing the NASA Complex, and no record was located for a SAMUEL CALON, SAMUEL KALIN, or variations of that name. Mr. ALLAN stated it was possible that for a period in the mid 1960's there were numerous sub-contractors working on the NASA Complex construction, and Mr. ALLAN's record check would not include employees of these sub-contractors.

Mr. JAMES BAKER, Manager, Arthur Murray School of Dancing, 820 Gravier St., New Orleans, La., advised he recalls that a SAMUEL CALON (phonetic) had been an instructor at the Continental Dance Studios on Common St., up to the time it went defunct, in about 1964. He recalls hearing from a now unrecalled source that CALON had left town shortly after Continental Dance Studios closed, because he owed numerous people money in New Orleans, and supposedly had gone to Chicago, Ill., where he went to work for the Fred Astaire Dance Studio operation. Mr. BAKER said that he had not heard of CALON being in the New Orleans area since that time.

It is noted that during interviews of RAY E. FAIRRISS by SA PHILLIP M. KING, and of MARCUS FILOS by SA THOMAS E. DuHADWAY, these individuals could not recall SAMUEL CALON.

It should be noted that, although, SAMUEL CALON allegedly departed the New Orleans area owing money to various individuals the name SAMUEL CALON or variations, could not be located in the New Orleans Credit Bureau records, and therefore, it is possible that CALON may not be the correct spelling of this individual's name.

JAMES BAKER, Co-owner, Arthur Murray Dance Studios, 820 Gravier Street, advised that a search of his records pertaining to former students from the year 1953 to the present failed to locate any reference to the following names:

ERIC STARVO GALT

JOHN WILLARD

HARVY LOWMYER

BAKER stated that SAMUEL KALIN (Phonetic) was formerly the front man for the Continental Dance Studios, which operation folded a few years previous. BAKER stated that he was formerly acquainted with KALIN (Phonetic) and that KALIN had left the New Orleans area some time ago, mainly on account of the fact that KALIN owed everyone in town.

BAKER also stated that the Continental Dance Studios was owned by Mr. LON LUTZ who formerly lived in the Claiborne Towers, but whom he now believed lived in the state of California. BAKER stated that WILLIAM HARNAN, a New Orleans attorney, handled the legal details in connection with the Continental Dance Studios going out of business.

BAKER stated that the photographs of ERIC STARVO GALT did not resemble anyone that he could immediately recall.

BAKER stated that Mrs. JOHN ANDREWS, also known as Dixie, of 3317 Colorado Avenue, Kenner, Louisiana, was a current student of his at the Arthur Murray Dance Studios. BAKER stated

that Mrs. ANDREWS was a perennial dance student at his and other studios, and in this capacity as a perennial student she attended almost all the parties and functions held under the auspices of the dance studios. BAKER stated that Mrs. ANDREWS always enjoyed dancing with young males who were also taking lessons and he felt that she would be the person whom he thought would be most likely to remember former dance students in the New Orleans area.

At the outset of the interview, she advised she wanted her name kept in strict confidence as she did not want the following information to be disclosed to anyone:

She advised she was employed as a dance instructor at the Continental Dance Studios which was located at 725 Common, New Orleans. She stated she has also been employed at the Maison De Danse located on St. Claude Avenue, New Orleans. She advised she was employed with the Continental Dance Studios around April or March of 1964 and terminated her employment with the studio approximately one year later which she believed to be October or November, 1965.

She advised it was common procedure at the Dance Studios for women instructors to teach men students and vice versa. She advised the turnover rate for both instructors and students was very high.

She stated that she has not heard of anyone by the name of ERIC STARVO GALT, HARVEY LOWMEYER, or JOHN WILLARD or any variations of those names.

She was exhibited photographs of ERIC STARVO GALT at which time she stated the photograph of GALT, eyes open, resembles an individual by the name of BILL (LAST NAME UNKNOWN), who was employed at the Dance Studios for three or four days during the beginning of the Summer of 1964. She advised BILL (LAST NAME UNKNOWN) was hired by MARLIN MEYERS as a dance instructor. She stated BILL (LAST NAME UNKNOWN) was a heavy drinker and for that reason was personally fired by MEYERS. She stated she believed BILL (LAST NAME UNKNOWN) was from Florida or Alabama. She stated an individual by the name of DON WILSON, who also used the name of DON ARTHURS, would possibly know more information concerning BILL (LAST NAME UNKNOWN). She stated

She stated that she did not know BILL (LAST NAME UNKNOWN) personally and was only associated with him at the Dance Studios. She advised that the photograph resembles BILL (LAST NAME UNKNOWN) in that the shape of the face from the nose down resembles that of BILL's face. She stated the photograph shows a long face; and she advised BILL, in her opinion, also had a long face.

The following investigation was conducted by
SA THOMAS E. DUHADWAY and SA WILLIAM F. KUSCH at New

CHARLES CIFELLI, Assistant Manager, Court of Two
Sisters Restaurant, advised that he knew an individual
named SCOTT NORDAL and that NORDAL had been employed under
his supervision at the restaurant for several weeks. He
advised that NORDAL claimed to be a pre-med student, but
during conversations with NORDAL, NORDAL failed to exhibit
a very great knowledge of medical matters.

He advised that he had held very long conversation
with NORDAL during an unrecalled evening and from this
conversation he believed that NORDAL was possibly running
from something, but he did not know what and he classified
NORDAL as a "strange individual."

He advised that NORDAL's left eye pointed inward
toward his nose. He stated that NORDAL did not resemble
the photographs of JAMES EARL RAY to any great degree. He
estimated NORDAL's age to be 30 with a tops of 35.

He advised that it would be impossible for someone
else to punch NORDAL's time card if NORDAL were absent and
that all times reflected on NORDAL's time card would be
accurate. He advised that the time cards could be obtained
from the payroll department of the restaurant.

Mrs. MARY MURPHY, maid, 623 Royal Street, advised as follows:

On Friday, March 29, 1968, her employer, Mrs. GEORGE FRIERSON, had a room for rent on display at the front of the building. About 4:00 p.m., this date, an individual came to the door and inquired about the room. He was brought to the second floor to talk to Mrs. FRIERSON, who is over 90 years of age. He was wearing a white shirt without tie and the collar open. He was carrying a sports jacket of some type and wore trousers of a contrasting pattern, color not recalled. He did not have a hat and carried no luggage.

After looking at the room, he agreed to take it at a price of \$15.00 per week. He made out the receipt himself in the name of SCOTT NORDAL, showing that it was for the period of April 1-8, and had the maid sign it. He gave her a \$20.00 bill in payment and was given \$5.00 change. He then gave her a \$2.00 tip.

He said he had an apartment elsewhere where there had been a misunderstanding. He said he liked privacy in his room inasmuch as he took flights often in business and indicated his previous residence did not suit his purposes. He further stated he was employed as an entertainer at the Court of Two Sisters and was making \$189 per week.

On Monday, April 1, 1968, between 3:00 and 4:00 p.m., he arrived at the Royal Street address, traveling via Ed's Cab Company. She did not see the driver, but caught sight of the cab. When he arrived, he had a black shiny footlocker with a padlock on it, plus a set of three matched suitcases in a blue plaid pattern, apparently a cloth material.

She saw him only a few more times after April 1. On April 9, 1968, he again paid his rent for the period April 9-15.

On this occasion he paid with two \$10.00 bills, received \$5.00 in change and again gave her a \$2.00 tip.

On Wednesday, April 10, possibly early in the day, he saw her and asked if she wanted to use his portable radio and listen to the news about MARTIN LUTHER KING. She told him she had seen the funeral on television the day before and did not need the radio.

On another occasion, probably during his second week at this address, she saw him going out about 2:00 or 2:30 p.m., apparently on the way to work. Concerning his work, he mentioned that he usually went to a friend's place to sleep after finishing up at the Court. He also mentioned that something had recently happened to his car and he was now without one.

On Wednesday, April 17, 1968, about 4:00 p.m., he saw her in the yard of the residence and said he had not forgotten the rent was now due. He said he had just "got back from the Coast" and had the money up in his room. He did not hear from him and at about 7:00 p.m., she went to the room and found everything gone.

She recalls two occasions when she was admitted to his room to clean. One one occasion when he was present, she started making the bed and when she turned back some of the bedding, she saw a strapped pack of currency with a \$100 dollar bill showing on top. This was a sizable pack of money similar to those seen in bank tellers' windows. He immediately stopped her from going on with the cleaning and asked her to leave.

On another occasion, the only time she ever found the room unlocked, she entered the room and saw a quantity of writing paper around. She observed some form of papers which she thought might show his name, and the name appearing thereon was a three part name, not recalled, but not SCOTT NORDAL. It was her impression it might have been a French name.

After finding the room deserted on April 17, 1968, she cleaned the trash can and placed the papers from it in the
