ROLAND PFISTER, 124 North Broad Street, advised that he purchased two-thirds of the Club Mocombo in November of 1965. He stated the other owner of this Club is HUMBERTO VALLADARES, a dental surgeon, whose office is located in the Maison Blanche Building.

He advised that he could not state that the Continental Dance Studio held parties at the Club Mocombo, but did state that many of the students did frequent the Club.

He stated that he can only recall one individual that he knew that had worked for the Continental Dance Studio and this individual is named JACKIE (last name unknown), who currently lives in Miami, Florida.

He stated the former manager of the Club Mocombo, PAUL CRUZ, would be very knowledgeable concerning all aspects of the Club Mocombo and should know many people from the Continental Dance Studio. He stated that CRUZ is now employed by the Playboy Club and is believed to be working in Wisconsin. He further stated that TONY FELLOS, an employee of the Playboy Club in New Orleans might possibly have some information concerning the Continental Dance Studio and would be knowledgeable concerning the patrons of the Club Mocombo.

Photographs of suspect GALT were exhibited to PFISTER, but he was unable to effect an identification and advised that he had not seen this individual before and further stated that the names ERIC S. GALT, JOHN WILLARD and HARVEY LOWMYER did not mean anything to him.

RUSSINO stated she cannot remember exactly the period of time that she taught dancing at the Continental Dance Club. RUSSINO advised that she started teaching a few months after the studio had opened but was only there approximately 3 months, which was during the summer months of 1964. RUSSINO stated that after she had quit the teaching position she was not employed for a few months until December, 1964, when she took a position with the Duty Free Store at the New Orleans International Airport. RUSSINO was exhibited photographs of ERIC STARVO GALT and she advised that as well as she can remember the photographs of GALT are not familiar at all to her. She advised that neither were the names HARVEY LOWMEYER or JOHN WILLARD familiar to her. RUSSINO advised that the studio usually would open between the hours of 1:00 PM and 10:00 PM, except on Fridays. On Fridays, they usually would have a dance held until 11:00 PM which was for all the students and instructors. RUSSINO advised that MARLIN MYERS managed the Continental Dance Studio but received his financial backing from a LOUELLA LOITS (PH). The Assistant Manager was FNU HART (PH) who came to the position after RUSSINO started working at the studio. RUSSINO advised their immediate supervisor was a DON (LNU) and that he was responsible to an FNU (also possibly JIM) WILLIAMS, who acted as a supervisor over all the instructors. RUSSINO advised that the past or present whereabouts of the above-mentioned persons are not known to her. RUSSINO advised that the following are the names of instructors and students that she can recall during the period she was employed there.

Captain JENNINGS advised that in some cases where a tow involves the transportation of gasoline or explosive materials, some of the bargemen, such as tankermen and the like, are required to have seamen's papers through the United States Coast Guard. Captain JENNINGS stated that the most logical places to check nationwide for an individual having Coast Guard seamen's papers of any type would be through contact of the United States Coast Guard Merchant Vessels Personnel Division, 1300 East Street Northwest, Washington, D. C.

Captain JENNINGS said that probably the majority of individuals working on tow barges on the Mississippi or coastwise are probably non-union. These individuals obtain a job by merely going to a barge towing company or a Captain of one of the barges giving his name, address, and two or three references as to previous employment. The company of the Captain will verify this employment and the individual would be hired.

Captain JENNINGS stated that the only towing barges or vessels that sign articles with the Maritime Commission are inter-coastal voyages in such as a trip from the east coast to the west coast of the United States or overseas.
