Mr. SHARPE stated that inasmuch as he had to wait until evening for his plane to New Orleans, he sat in the lobby and approximately 30 minutes later, noted that this man whom he had thought to be DARDEN was still talking to the same Delta Seat Reservation Agent. He assumed that the man had been there all of this time and for this reason felt that the Delta agent would probably remember this man.

Mr. SHARPE advised that he did not see this man again and does not know whether the man was on the Delta flight to New Orleans which he, SHARPE, took later that evening. He explained that his flight left Chicago for New Orleans at approximately 6:00 P.M. on that date, April 9, 1968.

Mr. SHARPE advised that he recently observed a picture of JAMES EARL RAY being sought by the Federal Bureau of Investigation, which picture was different from the first photograph published of a man called ERIC STARVO GALT. He continued that upon seeing this picture of RAY, he realized how much this photograph looked like ARTHUR DARDEN of New Orleans and, therefore, believes that the man whom he observed at the Delta ticket counter of O'Hare Airport in Chicago, Illinois, on April 9, 1968, was, in fact, JAMES EARL RAY.

Mr. SHARPE explained that he has known ARTHUR DARDEN for 15 years and knows that DARDEN is not identical with RAY.

The following investigation was conducted by SA WILLIAM B. WOOD on April 24, 1968, at New Orleans, Louisiana:

JOHNNY POLK JOYNER, ticket agent, Continental Trailways Bus Station, advised that he recalls selling a large amount of money orders to an unknown individual on April 17, 1968, at approximately 8:30 P.M. JOYNER advised that this individual wanted to purchase \$4,000. worth of money orders; however, JOYNER only had ten blank money orders left and these money orders can only be made out for \$100. apiece. JOYNER stated that this individual purchased all ten of his remaining money orders and each was for \$100.

JOYNER described this individual as approximately 5'11"-6'; about 175 pounds; appearance grubby; hair brown, wearing sports clothing.

JOYNER stated that he recommended to this individual that he try to obtain more money orders at the Greyhound Bus Station; however, this individual told him that he had already tried the Greyhound Bus Station and had been unable to obtain any money orders there.

JOYNER was unable to recall this individual's name, to whom the money orders were sent, or to what city they were sent.

JOYNER further advised that the money orders numbers, which this individual purchased, were AT 671,560,370 through 379. JOYNER stated that they do not keep a receipt with the destination of the money order or the sender's name.

JOYNER advised that the only information contained on the receipt kept by him is the amount of the money order and the amount charged for the purchase of the money order. JOYNER stated that these are American Express money orders and their receipts are forwarded to American Express in Atlanta, Georgia.

He advised that BILLINGS and his companion stayed in this apartment for about three months, then they left the New Orleans area for a short time and returned to the apartment, staying a very short time. He advised that BILLINGS and his companion then left and remained away from the apartment for about one year. BILLINGS returned by himself about a year later and dropped in the nightclub and said hello.

CAMERDELLE advised that neither BILLINGS nor his companion were known to him before they entered his nightclub and rented an apartment from him. He advised that BILLINGS drove a maroon vehicle but he was unable to recall either the make or model of this vehicle.

CAMERDELLE described BILLINGS' companion as a white male, shorter than BILLINGS and fairly good looking. He further described this individual as a troublemaker who was prone to violence when drinking.

He described BILLINGS and his companion as "drifters" and stated the reason he specifically recalls BILLINGS and his companion is that BILLINGS gave him a \$165 worthless check drawn on the Guaranty Bank and Trust Company of Westwego, Louisiana, which was returned to him marked "no account."

CAMERDELLE stated he knew nothing concerning a stolen machine gun that was to be delivered to the owner of the Canal Bank Inn and added that he did not consider himself to be a friend of either BILLINGS or his companion. He stated that he recalled BILLINGS telling him that he

was from either North or South Carolina, but he could not recall any additional information about BILLINGS, his companion or any friends they might have had while residing in New Orleans.

CAMERDELLE advised that he would search through his rental records and attempt to find the bogus check given to him by BILLINGS in order to pinpoint the exact date of BILLINGS' stay in the apartment in Westwego, Louisiana.

SYLVESTER JOHNSON, Negro male, born [redacted] 5'11", 167 pounds, was contacted at 519 Fannin Alley, Shreveport, Louisiana. After being advised of the identity of the interviewing Agent, JOHNSON furnished the following information:

JOHNSON advised that on, or about Saturday, May 18, 1968, he had occasion to be in the Continental Trailways Bus Depot, 408 Fannin Alley, where he had gone to order some french fries. He advised that he went into the depot at approximately 9:30 PM.

While in the depot, and before placing his order, he conversed with another Negro male who worked at the depot, and while conversing with this individual, he (JOHNSON) overheard a conversation between two white males who were sitting on the bench directly behind him in the main lobby of the depot.

JOHNSON stated that one of these white males was overheard to say, "If he could keep JAMES RAY STARVO hid at C. A. W. CLARK's house in Dallas, Texas, for awhile, they could get things arranged for him."

JOHNSON advised that he has never seen these two individuals before, and has not seen them since. He described the white males as follows:

First White Male:

Over six feet, weight about 190 pounds, dark brown hair, dark blue suit; clean shaven, no scars; wearing a ring with an eagle with wings spread insignia on ring finger of right hand.

Second White Male:

Over six feet, approximately 165 pounds, sandy hair, light grey suit, brown necktie, and black shoes.

JOHNSON indicated that the second white male was the individual who made the conversation which he overheard.

JOHNSON indicated that he has been arrested for burglary, non-support, and has spent ten months in the Louisiana State Penitentiary at Angola, Louisiana.

The following investigation was conducted at New Orleans, Louisiana, on May 10, 1968, by SA PATRICK J. DENTE:

Mr. J. HUBER, Manager, Baggage Room, Union Terminal, advised that Southern Pacific number 2 departs Los Angeles, California, at 8:15 PM and arrives New Orleans, Louisiana, two days later at 7:45 AM. Mr. HUBER stated that the Southern Pacific train which departed Los Angeles, California, on April 4, 1968, arrived at New Orleans, Louisiana, at 7:45 AM, April 6, 1968. He further advised that one train arrives each day at this time from Los Angeles. Mr. HUBER stated that Mr. JOSEPH FOOTE is an employee at the terminal and resides at 2123 Iberville Street, New Orleans, Louisiana.

On the same date, Mr. JOSEPH FOOTE was interviewed at his place of employment, Union Terminal, who advised that on Saturday, April 6, 1968, he boarded Southern Pacific Train number 2 at Lafayette, Louisiana, and recalls briefly chatting with an individual whom resembled the subject. Mr. FOOTE stated, however, that his contact with this individual was for a brief moment and he could not furnish any specific information regarding him.

Mr. FOOTE was shown several photographs of the subject, JAMES EARL RAY, whom he could not identify as the individual that he observed on Southern Pacific number 2. Mr. FOOTE further advised that he was certain the date was April 6, 1968, inasmuch as it was this particular Saturday, the first Saturday of April, that he visited his relatives at Lafayette, Louisiana, and there boarded the train for his return to New Orleans.

On May 16, 1968, Miss DIANE SHAW was interviewed at her place of employment, The Place, 1931 St. Claude Avenue and advised that she had been employed at the Music Box Bar for approximately three years and terminated her employment there about three months ago. Miss SHAW stated that she did not recall the subject ever being employed at the Music Box nor to the best of her knowledge did she ever observe the subject in that particular establishment. MONTI, A & M Amusement Company, 1025 Baronne Street, advised that he formerly serviced the pinball machines at the Music Box and recalled a bartender by the name of BILL MILLER. Mr. MONTI stated that he last saw MILLER approximately several weeks ago at which time he indicated he was seeking employment at Mary's Tavern located on Magazine Street. Mr. MONTI stated he could not furnish any specific information regarding MILLER's present location.

On May 17, 1968, Mr. J. SCOVOTTO, Owner, Mary's Tavern, 1926 Magazine Street, advised that a BILL MILLER is not employed at his establishment nor to the best of his recollection did he ever meet an individual by this name.

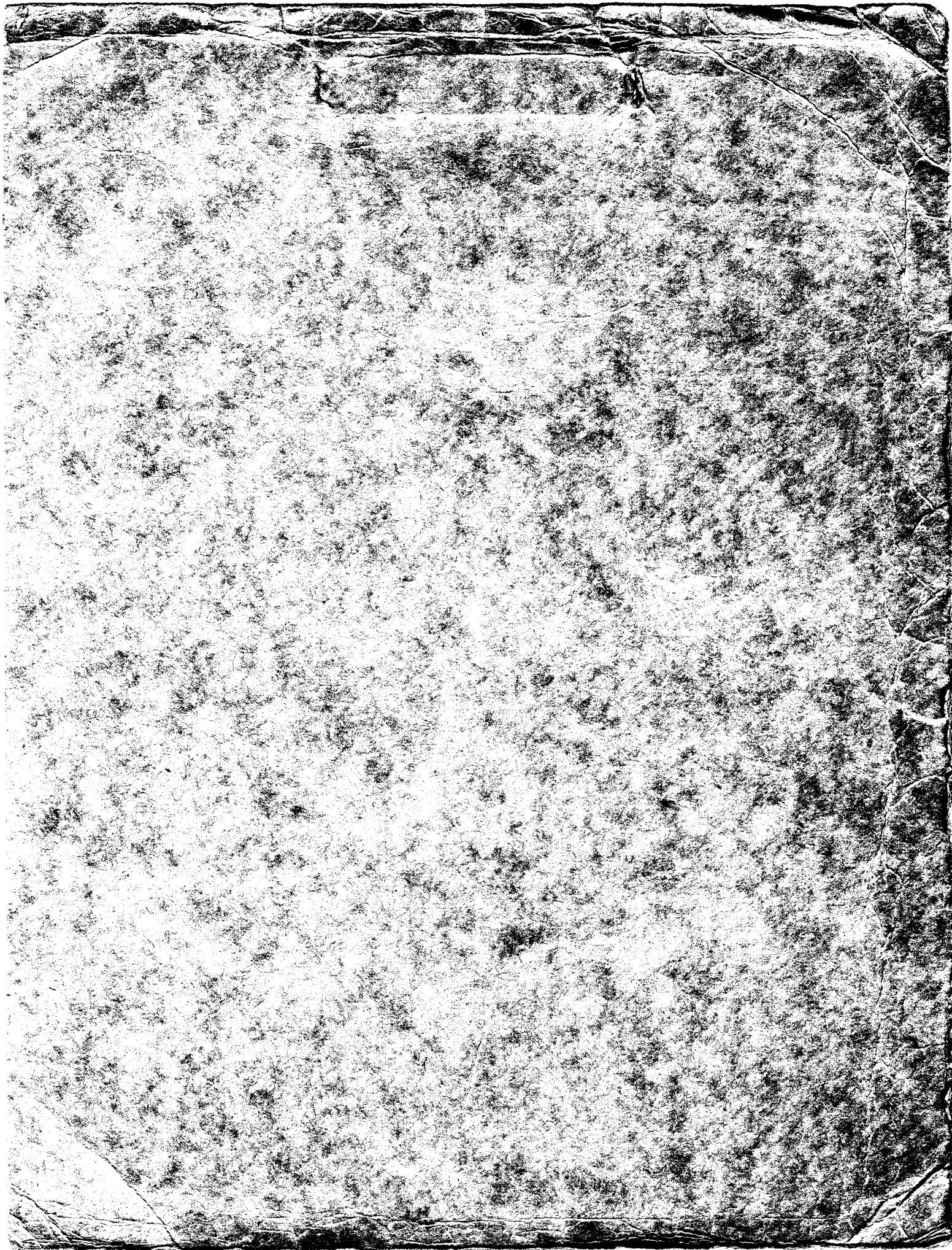
