MEMPHIS (AP) — The mysterious Eric Starvo Galt has been charged with conspiracy and murder in the assassination of Dr. Martin Luther King Jr.

THE FBI, replying on witnesses apparently, said the fugitive had been described as a white man, 5-8 to 5-11, weighing 160 to 175 pounds, with brown hair in a brush cut, blue eyes, straight nose.

Persons who have met Galt, the FBI reported, described him as a loner with a "rural" speech and little schooling, fond of vodka, beer and hillbilly music.

The FBI statement also said, "The fugitive is said to have a nervous habit of occasionally pulling at an ear lobe with his left hand. His left ear protrudes further from his head than his right ear."

"GALT SHOULD be considered armed and dangerous," the FBI release warned.

Galt has used the names of John Willard and Harvey Lowmeyer, the FBI said. The assassin registered at the Memphis rooming house under the name of John Willard.

Details of the alleged conspiracy were missing from the FBI release, as were vital statistics, such as Galt's birthplace, formal schooling, conployment. The statement

GALT, THE FBI said, is the owner of a 1966 white Mustang with Alabama license plates abandoned in Atlanta the day after King was shot to death. The vehicle was left in the parking lot of an apartment project near the Georgia Capitol.

Two white Mustangs were parked near the rooming house shortly before the shooting, witnesses have said, and both disappeared minutes later. Some witnesses told of a man in a black business suit, neatly dressed, walking down the steps to the street, dropping a rifle and getting into a Mustang with either Alabama or Arkansas tags.

A BUSINESSMAN said last night he was certain the Mustang parked farthest from the shooting scene had an Arkansas tag. "I'm clear in my own mind." he said.

The FBI said Galt's car traveled more than 19,000 miles between Aug. 30, 1967, when he bought it in Birmingham and its abandonment last week in Atlanta. There were trips to Los Angeles, New Orleans and Mexico, the FBI said.

While in the Los Angeles area early this year, Galt took a course in bartending and graduated March 2, the FBI said. In Hollywood, director Tomas Reyes Lau of the International School of Bartending said Galt took a four-week course but refused a job.

LAU SAID GALT turned down the job because he wanted to visit his brother. "He never said anything about Negroes," Lau said. Similarly, residents of the Birmingham boarding house did not recall Galt talking about racial issues.

Calt. told his landlord in Birmingham he was on vacation and had worked at Ingalls Shipyards in Pascagoula, Miss. The company had no record of him.

Likewise, Galt put "merchant seaman, unemployed," on his application for an Alabama driver's license last year, but no record has been found of his name on maritime union rolls.

# Galt Described As Quiet Loner

LOS ANGELES (AP)—Two men say they told the FBI that a man identified as Eric Starvo Galt was a shy, quiet man who spent \$700 in three months on dancing and bartending lessons.

The managers of a dancing school and a bartending school told newsmen yesterday they identified a former pupil to the FBI as Galt, who is wanted in the slaying of Dr. Martin Luther King Jr., April 4 in Memphis, Tenn.

ROD ARVIDSON, 46, general manager of National Dance Studios, said he notified the FBI Saturday after recognizing Galt from a composite drawing in a newspaper.

"He's certainly no mixer," Arvidson said, "He had

trouble coordinating one foot with another."

A photograph of Galt circulated by the FBI was obtained Tuesday from the International School of Bastending the school's director said. The director, Tomas Reyes Lau, said a man called Eric S. Galt was graduated from the

Hollywood school March 2 after an excellent record in a \$225 four-week course; which he attended Saturday mornings and Sunday afternoons.

GALT'S APPLICATION LISTED his address as Hollywood and his birthday as and stated he was single. The FBI in Washington, D. C., said the wanted man was 36.

As a student of bartending and dancing, not only Lau and Arvidson but two dance instructors agreed Galt was withdrawn and a loner.

"He just didn't show anything but a crooked smile and a fidgety manner," said an instructor, Kathy Nolan, 21.

Another instructor, Andreas Jergensen, 46, also talked

with newsmen.

Arvidson said that a man who signed enrollment records as Eric S. Galt took "50 or 60" lessons in social dancing over a 21/2-month period ending in mid-February and that the lessons cost him about \$500.

### Man Differs From Photo, Cabbie Says

ATLANTA, Ga. (AP) — An Atlanta taxi cab driver said Wednesday night that an FBI picture he identified as a man he hauled two blocks the night after Dr. Martin Luther King Jr. was assassinated was different from the picture of Eric Starvo Galt released by the FBI Wednesday.

"The one the FBI showed me was much younger. The face was much thinner. The cheeks weren't as fleshy," said the driver, who has asked that he not be identified.

Looking at an Associated Press wirephoto copy of the picture released by the FBI in 'Vashington, he said, "That is definitely not the man I picked up and not the one they showed me. The only time I've ever seen that was on television tonight."

He said the FBI agent showed him three photographs. "He may have shown me that one, but that wasn't the one I recognized," the driver said.

The driver said he had recognized one of the FBI photographs as that of a patron he carried two blocks in Atlanta's "hippie" section on Friday night April 5. He said he remembered the man because he was rude and threw the money on the seat, causing it to fall on the floorboard.

Describing the FBI print shown to him, he said, "It had a necktie, not a bow tie. The tie was on crooked... It had been pulled over to the side. The hair was the same color but it was flatter on top. This man looks older. The other was about 28 to 30, no older than 35."

# Eye Witness Says Photo Not Of Killer

MEMPHIS, Tenn. (AP) — An FBI photograph of Eric Starvo Galt, charged with conspiracy in the slaying of Dr. Martin Luther King, does not resemble the man seen leaving the scene shortly after the slaying, a witness said Wednesday.

"Unless he was wearing a wig or had had a face lift or something, it's not the man I saw," said Charles Q. Stevens, who lives in the second floor rooming house from which the fatal bullet is thought to have been fixed

"The hair is too full and the face is too young," Stevens said after viewing the picture.

Stevens, who said he got only a side view of the killer, had contributed to the description used in composite drawings of the alleged assassin.

Bessie Brewer, operator of the rooming house, said she was unable to tell if the picture was of the man who registered under the name of John Willard the afternoon of April 4, three hours before King was killed, and left immediately after the shooting.

"I don't know," she said. "I couldn't tell you to save my soul."

The FBI did not indicate when the picture of Galt it released was taken, or under what circumstances the photograph was obtained. (Indicate page, name of newspaper, city and state.)

# Mystery Man' Is Charged *lurderina*

MEMPHIS (AP)-The mys- him. terious Eric Starvo Galt has been charged with conspiracy and murder in the assassination of Dr. Martin Luther King Jr.

The FBI said in a fugitive warrant issued last night in Birmingham, Ala., that Gait, 36, conspired with a man "whom he alleged to be his brother" to violate King's civil rights.

The state charge of firstdegree murder was filed against Galt in Memphis, where King, 39, Nobel Prizewinning civil rights leader, was shot to death on a motel balcony April 4 by a rifle. sniper who fled from a nearby rooming house.

FIRST-DEGREE murder in Tennessee carries the death penalty, although the electric chair has not been used in the state since 1960.

The maximum penalty un der the federal charge of conspiracy to violate a person's civil rights is a \$5,000 line and 10-year prison sentence.

FBI Director J. Edgar Hoover announced in Washington that the conspiracy to "injure, oppress, threaten or intimidate" King began "on or about March 30" in Birmingham.

THE FEI statement said a .30.06 rifle equipped with a telescopic sight found near the rooming house shortly after King was slain was purchased March 30 in Birmingham.

The FBI released a photograph of Galt and solicited public aid in finding him. Whether this appeal meant the trail had become cold was unclear, but U.S. Atty. Gen. Ramsey Clark told a reporter in Washington that he felt this was not the situation.

THE FBI started hunting Galt a week ago. Agents even contacted persons named Galt in several states in an attempt to find him.

The picture-which had to have the eyes "opened" by an artist-brought uncertain responses from witnesses who were acquainted with Galt or saw the fleeing sniper.

"Unless he was wearing a wig or had had a face lift or something, it's not the man I saw," said Charles Q. Steyens, who lives at the Main st. rooming house from which the fatal shot apparently was fired.

"THE HAIR is too full and the face is too young," he said. But Stevens said he only got a side view of the fleeing figure.

A source in Birmingham said the photograph was taken within the past three months, although the FBI did not specify when it was made. The photo has sharp contrast, making hair and features very dark.

"It's very near, but I'm not sure," was the reaction of Peter Cherpes, owner of a Birmingham boarding house where an Eric Galt stayed from Aug. 26 to Oct. 7 last

"I don't really know," Cherpes said. "It's so hard to tell. His hair seemed to be lighter."

THE FBI, replying on witnesses apparently, said the fugitive had been described as a white man, 5-8 to 5-11, weighing 160 to 175 pounds, with brown hair in a brush cut, blue eyes, straight nose.

Persons who have met Galt, the FBI reported, described him as a loner with a "rural" speech and little schooling, fond of vodka, beer and hillbilly music.

The FBI statement also said, "The fugitive is said to have a nervous habit of occasionally pulling at an ear lobe with his left hand. His left ear protrudes further from his head than his right ear."

"GALT SHOULD be considered armed and dangerous," the FBI release warned. Galt has used the names of

John Willard and Harvey Lowmsyst, the FBI said. The assassin registered at the Memphis rooming house under the name of John Willard.

Details of the alleged conspiracy were missing from the FBI release, as were vital statistics, such as Galt's birthplace, formal schooling, employment. The statement said Galt claimed to have been a cook on Mississippi riverbosis, a merchant seaman and "is said to be an avid dancer."

GALT, THE FBI said, is the owner of a 1966 white Mustang with Alabama license plates abandoned in Atlanta the day after King was shot to death. The vehiclewas left in the parking lot of an apartment project near the Georgia Capitol.

Two white Mustangs were parked near the rooming house shortly before the shooting, witnesses have said, and both disappeared minutes later. Some witnesses told of a man in a black business suit, neatly dressed, walking down the steps to the street, dropping a rifle and getting into a Mustang with either Alabama or Arkansas tags.

A BUSINESSMAN said last night he was certain the Mustang parked farthest from the shooting scene had an Arkansas tag. "I'm clear in my own mind," he said.

The FBI said Galt's car traveled more than 19,000 miles between Aug. 30, 1967, when he bought it in Birmingham and its abandonment last week in Atlanta. There were trips to Los Angeles, New Orleans and Mexico, the FBI said.

While in the Los Angeles, area early this year, Galt took a course in bartending and graduated March 2, the FBI said. In Hollywood, director Tomas Reyes Lau of the International School of Bartending said Galt took a four-week course but refused

down the job because he wanted to visit his brother.

"He never said anything about Negroes," Lau said. Similarly, residents of the Birmingham boarding house did not recall Galt talking about racial issues.

Galt told his landlord in Birmingham he was on vacation and had worked at Ingalls Shipyards in Pascagoula, Miss. The company had no record of him.

Likewise, Galt put "merchant seaman, unemployed," on his application for an Alabama driver's license last year, but no record has been found of his name on maritime union rolls.



The FBI said Galt's real identity was traced through "a systematic and exhaustive search of latent fingerprints" developed in the King case against the fingerprints of more than 53,000 persons for whom wauted notices are on file in the bureau's identification division.

Galt is only one of the names Ray has used in brushes with the law which began, according to the FBI dossier, when he was 21.

The FBI said he has used the names of James McBride, James Walton, W. O. Herron and James O'Connor.

### DESCRIPTION GIVEN

He was described as about 5 feet 10, weighing 163 to 174 pounds, with blue eyes and brown hair and two scars: a small scar in the center of the forehead and another on the palm of his right hand.

At the time King was shot and killed by a sniper in Memphis, Tenn., April 4, Ray was being sought on a jail breaking charge.

The FBI said he escaped on April 23, 1967, from the Missouri State Penitentiary at Jefferson City, where he was serving a 20-year sentence for armed roobery in St. Louis.

The FBI has said Eric Starvo Galt purchased a 30.06 rifle in Birmingham five days-before the assassination. That rifle, with a telescopic sight intact, was recovered outside the rooming house just after the assassination.

THE FBI did not make clear where it got the fingerprints which it matched against its files to show Galt is actually Ray.

But speculation was the prints may have been left in the rooming house, on the rifle or on a 1956 white Mustangsince impounded in Atlantathat witnesses reported seeing leaving the vicinity of the shooting.

This was the way Ray explained his mission to the girl in question. The FBI's search for the girl still continues and there is no indication that the agency is aware of the girl's whereabouts.

Ray (Galt) kept this quiet and, on the whole, remained to himself. However, "Jerri" was in his apartment on several protracted occasions and the conviction is that she may well have information about the various contacts Ray was known to have made in the South, particularly in New Orleans.

As important as "Jerri" is to the stalled investigation, she is overshadowed by additional information uncovered by this reporter about Ray's New Orleans contacts. These are the fac's that can now be published:

On Dec. 16, 1967, Ray was in telephone contact with a major New-Orleans industrialist, a man who is considered the economic and political "killer" of the community.

—On Dec. 17, 1967, Ray met in person with this New Orleans industrialist. On the day of the meeting, Ray was registered in a motel in New Orleans. The contact between Ray and the industrialist was made from this motel and the meeting with held in "downtown" New Orleans.

Investigators are attempting to zero in on the "industrialist" in the light of a disclosure from an inmate out of Missouri Prison, where Ray once served time and where Ray expressed interest in an offer of \$100,000 put up by "Southern businessmen" for anyone who would kill Dr. King, This reporter has also been able to establish a timetable for Ray that leads up to a few days to Dr. King's assassination:

—On Valentine's Day, Ray, who was then living in Room 408 of the St. Francis Hotel along Hollywood Blvd., visited another girl friend — not the blonde — and offered his console TV set for her portable. The girl accepted the swap. Ray loaded her portable

set in his car and told the girl he was leaving town.

Although they are tightlipped about it, the FBI has found the portable TV set, probably in a Birmingham, Ala. roominghouse.

—Ray was seen on this same day in the parking lot of the Los Angeles Sears, Roebuck store on Pico Blvd.

Three days later, Ray called upon a New Orleans family and delivered to them a package sent by their daughter in Los Angeles. The already published record shows that Ray then drove into Alabama, finally, into Memphis.

The FBI is having major difficulty tracing both the elusive blonde and the New Orleans industrialist because the trail leads through denizens of the underworld and semi-underworld who flatly refused to cooperate with law enforcement officials. The name of the New Orleans industrialist is not known.

However, this reporter is aware of how the telephone contact between the industrialist and Ray was established. A search is now on to locate records which will reveal both the industrialist's name and telephone number.

Other information developed by this reporter indicated that "Jerri" spoke with a foreign accent and is probably from one of the Scandinavian countries.

Willing to Try for Bounty on King, Says Convict

DALTON, Ga. (AP) — A convicted murderer who was in prison with the mysterious James Earl Ray, now hunted in the slaying of Dr. Martin Luther King Jr., said Tuesday he heard Ray say he would be willing to try to collect \$1 million for killing the civil rights leader.

Raymond Curtis, 40, the same age as Ray, is in the Whitfield County jail awaiting action on appeal of a murder conviction. Curtis said he and Ray were prisoners at the Missouri State Penitentiary when John F. Kennedy was assassinated Nov. 22, 1963, in Dallas, Tex.

"Another boy said, 'Well, there's a million-dollar bounty to get King.' King was running his mouth pretty good then. Ray said, 'If there is a million-dollar bounty on King, I believe I can collect it,' " Curtis said in an interview.

Curtis said he met Ray in 1955 when both were prisoners in Jackson County jail at Kansas City, Mo. He said they shared a cell for seven months.

Then, Curis said, Ray was transferred to the Leavenworth federal prison to serve a term for forging postal money orders. Curtis said that two weeks later he also was sent to Leavenworth.

Curtis said he and Ray were in the same 281-cell building at Leavenworth and at one point were in adjoining cells.

He said after about six months he was transferred to the Atlanta prison and did not see Ray again until late 1961 or early 1962, when Curtis went to the Missouri State Penitentiary on a 10-year armed robbery sentence.

Ray was there, Curtis said, serving a 20-year armed robbery sentence. Prison records confirm that Curtis and Ray were inmates at the same time.

The two saw each other "al-

The two saw each other 'most daily" Curtis said.

It was in the prison yard, Curtis said, that he and Ray saw television news reports of Kennedy's assassination. A few days later, he said, a new prisoner came in and said that a \$1 million bounty had been put on King by a "K-K businessman's association."

Curtis said Ray did not associate freely with other inmates. "You could pick him out of a crowd of 2,000 men in the prison yard. He would be off to himself walking and his mind would be somewhere else."

"The only thing he would make a long conversation out of was when he was planning something and you were a part of it," Curtis said. "Anything he did was thoroughly planned. He never went off half-cocked."

Curtis said he heard Ray mention a King bounty several times. At one point, Curtis said, Ray referred to the Kennedy assassination by saying, "Boy, probably somebody made a nice little penny off of that. I sure wish it was me."

Curtis, who was born in Dalton, said Ray had a soft southern Illinois accent, not a southern drawl.

Curtis, who was convicted in January 1967, of a nobbery murder, is awaiting a decision on a new trial motion. FBI agents questioned Curtis Sunday and Monday.

To his knowledge, Curtis said, only one person visited Ray during their prison time together.

Curtis talked to reporters from his individual 4- by 10-foot cell at the Whitfield County jail. A bare light bulb illuminated the cell. He wore a torn white T-shirt, and raspherry colored paiama trousers.

Čurtis said Ray made the statements about King to Curtis personally and not in a group.

The FBI said the man they are hunting has a liking for beer and vodka and water. "He liked beer, I know that, because he talked about it," Curtis said.

Curtis said Ray talked a great deal in prison about New Zealand, Brazil and Argentina and Curtis speculated that he would have left the United States for one of those countries within hours after the slaying if he were responsible.



Galt drove Stein to her apartment and she was introduced to him as "Eric.'

"He just kinda hung his head. He just stood there and didn't say anything."

MRS. LEE SAID he was "skinny, with light hair. I'm positive he had light hair and I think his eyes were light."

Her brother told her that getting a ride from California with Ray was "a Godsend," adding that Ray was "a swell guy. He wouldn't let me pay for-enything. I left with \$20 and I got here with \$20," Mrs. Lee said her brother told

Ray stayed at the Provincial Motel, 1024 Chartres, while Stein stayed with Mrs. Lee on Burgundy.

Ray had planned to leave the next day, Dec. 18, but Stein told his sister that Ray was going to "have to stay another day on business."

# Galt Contradictions Played Down by FBI

WASHINGTON (AP) - FBI officials are quietly trying to play down contradictory descriptions of the appearance and habits of James Earl Ray, alias Eric Starvo Galt, the elusive escaped convict charged with the murder of Dr. Martin Luther King Jr.

The discrepancies have fueled speculation that perhaps Ray and Galt actually are two persons, or that two or more persons used the name Galt.

No official statement has been issued to rebut this theory. However, as the massive search for King's killer entered its fourth week, FBI sources who had refused to discuss any aspect of the investigation insisted though not for attribution, that Ray and Galt are the same per-

THE FBI REPORTS indi-1966 white Mustang driv- cate that cigarette butts and ashes were found in the ash tray and on the floor of the white Mustang when it was found in Atlanta. I have been on the road with Stein, Ray's December driving companion, for two days and he distinctly recalls that Ray did not smoke.

The FBI reports indicate that Ray was in Los Angeles until March 27; he is reported to have bought the murder weapon in Birmingham on March 30. This reporter disclosed last week that Ray, delivered a package to the New Orleans family of one of his Hollywood girl friends during his last week there.

THE SEQUENCE of events, then, is clearly impossible. The FBI interviewed the family following my disclosure of the incident and confirmed that Ray had delivered the package. The trip from Los Angeles to Birmingham via New Orleans is in excess of 2,500 miles. Ray could not have driven that route, particularly in a Mustang, in the short period between March 27 and March 30.

There is an outside chance that the trip could have been accomplished if Ray had a driving companion as he did in December. There have been no indications that he did have a companion.

These contradictions and confusions are compounded by others that have occurred during the investigation into the slaying of Dr. King. The FBI issued a report that Ray

> THE FBI HAS been forced to admit that the fingerprints, circulated during the early days of the manhunt, were not those of Ray. The blame for this, according to the FBI, must be assumed by the warden of the Missouri State Penitentiary. The warden, the FBI claimed, issued mistaken fingerprints on Ray when the convict escaped from prison in April, 1967.

> This means two things: (1) Had Ray been arrested after his escape from prison, he would not have been held by the local arresting officers as a fugitive; (2) had Ray been arrested immediately after the slaying of Dr. King the mistaken fingerprints would have confused the investigation and possibly would have led to his release.

THE SIGNIFICANT fact is that the Georgia Bureau of Investigation had mistaken fingerprints of Ray up until last Wednesday. Had Ray been arrested in Atlanta, then, on the day he parked the white Mustang, the Georgia authorities would have been attempting to identify him by matching his fingerprints against a set of

prints that belong to somebody else.

There there are the incredible omissions that have been discovered during this reporter's trip back into the life and activities of Ray. Apparently it never occured to the FBI to retrace Ray's trip with Stein as this reporter is doing in search of the phone booth from which Ray made hasty calls to someone in New Orleans.

Apparently it also did not occur to the FBI to investigate the possibility that Rav was in telephone contact with New Orleans while he was still in Los Angeles. This reporter iocated the phone booth used by Ray in the lobby of the St.

THE FATAL oversight was the FBI's failure to uncover the console television set Ray gave to a Hollywood girl friend in return for her portable TV set. The swap occurred around Valentine's Day-February 14 -and Ray told the girl he was leaving town.

This reporter found both the girl friend and the television set. The back of the television set contained handwriting believed to be that of Ray and can be matched against the graffiti on the walls of the telephone booth.

A clear reading of this makes it all but certain that Ray took three trips to New Orleans between Dec. 15 and the end of March. There was the trip of Dec. 15, which Stein and I are now retracing; there was a second trip that began on Valentine's Day. Finally there was the trip that began a few days before the end of March and culminated in the death of Dr. King.
THE VALENTINE'S DAY

# Phone Booth Pinpointed in

SAN ANTONIO - The station phone booth fi which James Earl Ray, leged slayer of Martin Lut King, talked long distant with his New Orleans con on the night of Dec. 16, 1 has been located.

The call was one of two telephone contacts Ray made that night with the New Orleans man who is believed to e the "cashman" behind Ray, then known as Eric Starvo Gault.

CHARLES STEIN, the Hollywood songwriter who made the Dec. 15 trip with Ray, and this reporter located the gas station at about 1 a.m. Identification of the phone booth climaxed a 24-pour search in the area.

Telephone company officials in Texas are now attempting to locate records that will show precisely whom Ray was calling. From conversations between Ray and Stein as they drove from Los Angeles to New Orleans, it has been established that Ray said his contact was a New Orleans industrialist.

The exact location of the anti-vielephone compress officials can locate the records.

Before leaving Los Angeles, Stein gave me a detailed description of the gas stations where the two phone calls were made. The firm

The first 24 hours of the search proved fruitless be-cause of the manner in which Stein's memory works. He never wears a watch and has great difficulty recalling if an event occurred in the morning or in the afternoon. He knew, for example, that he left Los Angeles on Friday, Dec. 15, and arrived in New Orleans on Sunday, the but he could not recall approximate departure or rival times.

Cross checks with Stein's family in Los Angeles establish that he and Ray departed at about noon on Dec. 15. A check with Stein's mother in New Orleans disclosed that he and Ray arrived at her home shortly after noon on Sunday.

After having plotted the trip as carried out with the two men taking turns at the wheel, we determined approximately where they would have been at 9 p. m. Dec. 16, the night the two calls were placed.

THIS TIMETABLE pointed to the Houston area. Only

to locate the gas stations in volved did Stein begin to completely relive the trip. He remembered that after the last phone call, he, Stein, took over the driving and immediately hit a road under construction.

After three hours of driving and covering more than 125 miles, we found the stretch of highway. The location of the "bump road" suggested that our original calculations were off by 500 miles.

Then Stein's memory produced these facts: he and Ray drove through a snowstorm on eir first night out, Dec. 15. deeper into New Mexico to get out of the storm.

The two men ate breakfast at Las Cruces, N. M., early on the morning of Dec. 16. They then drove into El Paso, Tex., 30 miles, where Ray bought a new tire for the white Mustang. The tire was not put on the car there. Ray drove on into San Antonio and skidded off the icy road. Stein took the wheel and drove to the next small town, where they pulled into a small gas station. Ray had the new tire put on, reasoning that his skid had been caused by a smooth tire.

A CHECK WITH the weather bureau confirmed the snowroads. and the weather facfors, it became clear that the phone calls were made somewhere after El Paso rather than between San Antonio and Houston as first thought.

Stein, struggling to recall details of a five-month-old trip that meant nothing to him at the time, remembered that Ray was short on gas as he drove through a small town. As they passed the last gas station in the town, Ray remarked that the station was across the road, which had a divider, and that he would get gas at the next station, which he guessed would be a few des down the highway. Ray er a search of that are failed drove about three miles without coming on a gas station.

cause once they returned to the inghway they indeed did come upon a gas station about a mile from where Ray made the U-turn back to the small town.

STEIN AND I found the town. The road divider is there and we bought our gas at the same Phillips 66 station where Ray bought his.

From these fixed points it was just a matter of time before Stein, who was driving my rented car at the time, slammed on the brakes and then pulled into a gas station. "This," he shouted, "is it. Thank you, Jesus!"

The station has the jutted roof. The lights are continuous. And as I sat in the car, as Stein had done with Ray in December, and watched Stein race around the left side of the station to the hidden place booth, I became convinced that indeed this was the place.

The location of the booth is so uncommon and an abutment which makes it all but invisible even from the front of the gas station are so unique, even in Texas, the odds are a million to one against the existence of two such phone booths.

But only Stein's identification of the booth matters. A citizen of the semi-underworld, Stein is a ruthlessly honest man when he wishes to be. Stein's only reward, or payment, for taking the trip along with me would be to help provide critical information that Lead to those involved in the death of Martin Luther King.
