King's Assassin May Have Left False Clues To Confuse Police

MEMPHIS — The killer of the Rev. Dr. Martin Luther King Jr. may have left a trail of false clues to confuse his pursuers.

Shortly after the murder, the police said they had never seen a case where there was so much evidence left behind.

The assassin not only left fingerprints and hand prints in his room and in the toilet from which he shot Dr. King, but he also left a blue piece of luggage and a rifle on the sidewalk outside.

Tuesday, agents of the Federal Bureau of Investigations were reported to be looking in such widely diverse areas as Birmingham, Ala., Memphis, Chicago, and Mexico for the young, long-nosed man believed to have shot the Civil Rights leader.

In Birmingham, at the request of the F.B.I. airline agents shuffled through passenger lists at Delta and Southern airlines for last week, checking several names.

F.B.I. agents in Birmingham were also reported to be checking the records of gun shops.

Within minutes after Dr. King's slaying, the Memphis police had confiscated the Remington 30.06-caliber rifle

that the assassin dropped outside the rooming house from which he fired the fatal shot. The rifle was new.

A new weapon can almost always be traced from the manufacturer to the retailer by its serial number.

Copies of a sketch made from the descriptions furnished to the police at Memphis were distributed to officers at the United States-Mexico border and inside Mexico.

The investigation apparently spread to Mexico after the Mexican consul at Memphis, Rolando Veloz Canales, reported to the police that a yung man resembling the police sketch, which he had seen in a Memphis newspaper, had got a Mexican travel card on the day before Dr. King was

killed.

"I remembered him because of his long nose," Veloz said. A long sharp nose was the one thing most witnesses remembered about the young man who checked into the shabby rooming house about three hours before Dr. King was shot to death on the balcony of a nearby motel.

The address and telephone number given by the man on his application for the Mexican travel permit were improper.

The address given for a Chicago Street needed either a north or a south to make it complete. The telephone number given was for Antioch, Wis.

The age given by the young man on his application was 21 years.

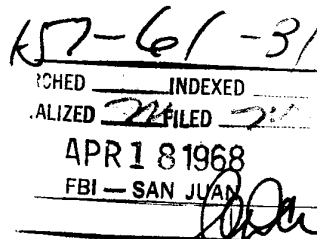

The night of 4/12/68, Assistant Commissioner CHARLES GRONEVELDT, Department of Public Safety, St. Croix, Virgin Islands, advised SA ROBERT L. MOORE that one DONALD CHURCHILL had left personal belongings at the Club Comanche Hotel, St. Croix, Virgin Islands, and mysteriously disappeared. According to GRONEVELDT, CHURCHILL fits the description of ERIC STARVOS GALT and those who have seen him say he bears a striking resemblance to a UPI telephoto sketch of a police drawing for the MURKIN suspect that appeared in the 4/8/68, issue of the "New York Daily News".

On 4/13/68, the following investigation was conducted by SAS ROBERT L. MOORE and JOE C. SPARKS, at St. Croix, Virgin Islands:

ROBERT PETERSON, Manager, Club Comanche, St. Croix, Virgin Islands, advised CHURCHILL entered the Club Comanche on 4/6/68, without a reservation and asked for a room. They told him Room 5 would be available for four days and he registered for it. He left the hotel and returned shortly thereafter with four or five bags and some boxes. In the registration book, he had given the address of 75 Willow St., Brooklyn, New York. He printed his name and address. PETERSON saw nothing more of CHURCHILL until the following morning, when he appeared in the lobby saying that he intended to go to St. Thomas for the day. He had a small box with him. PETERSON mentioned the fact that it was customary for a deposit to be made, CHURCHILL left a \$100.00 American Express Check, Number RA34-962-243, which he told PETERSON he would countersign when he returned. PETERSON described him as a white American male, in his late 30s or early 40s, 6', medium to thin build, brown hair, with no distinguishing physical features. He did appear to be somewhat "wild-eyed" and nervous. CHURCHILL has not been seen or heard of since and

his personal belongings, some of which were strewn about the room, have been collected and are being maintained by the hotel.

CATHERINE GOLDEN, Desk Clerk, Club Comanche Hotel, advised that she was present in the lobby the morning that the subject departed, saying he was going to St. Thomas for the day. She found his conversation somewhat peculiar, although she did not state exactly why and described him as a "kook". She feels he made too big an issue of the fact that there should be no worry about his ability to pay for his room. She described him as a white American male, about 5'9" tall, light complexion but slightly tanned, light brown hair combed straight back, possibly brown eyes, but no glasses, 36-37 years of age, wearing a brown knit shirt and slacks, has a somewhat thin face with a prominent nose.

CHURCHILL's personal effects were examined and in addition to the information set out in our teletype sent 4/13/68, the following was observed:

CHURCHILL was estranged from his wife, FAITH DENNIS, and appears to be in a controversy over the custody of the children. He seems to be a man of some means and may be the recipient of several hundred thousand of dollars left by his father, ARTHUR. Among other things, he had in his belongings the 4/3/68 late City Edition of the "New York Times". He had marked an article about MC CARTHY winning the Wisconsin election and President JOHNSON polling 40 per cent of the votes. He marked another article captioned "Soviet Believe Testing Rockets, Able to Guide Bombs From Orbit". He also had the 4/5/68, issue of the "Washington Post", Section A, the bulk of which was devoted to the assassination of Dr. Rev. MARTIN LUTHER KING. He had written on page one in ink the following: "Dearest Bob. I am addressing you in a way that could be misunderstood but in my opinion, you are a Prince of Peace - I hope we may meet someday. Thank you". A copy of employment resume is being placed in the 1-A Section of the file, which shows among other things the fact that he was employed for five years as a Pan American Airways Navigator. He has kept many scribbled notes concerning his marital problem, including dates that his wife has indicated she was going to obtain a divorce. There is no indication among any of these notes that he has any racial preoccupation. He has expired US ordinary Passport [REDACTED] issued in 1959, at London, England. A photograph of the subject was obtained from his personal belongings and forwarded to the Bureau by Airline Pilot 4/13/68.

A review of Antilles Air Boat's manifest established that DONALD CHURCHILL flew at 11:01, 4/8/68, from St. Croix, to St. Thomas, Virgin Islands, aboard Antilles Air Boat using one way ticket, #05601. ELIZABETH WILSON, Antilles Air Boat, advised when he departed, he was dressed in Bermuda shorts, a tan shirt and necktie and carrying a heavy winter overcoat.

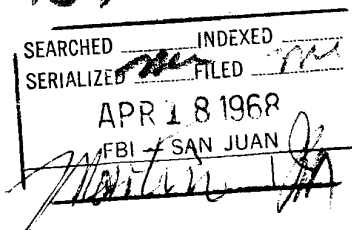

Attorney General Ramsey Clark announced today that Eric Starvo Galt is being sought by the Federal Bureau of Investigation (FBI) as a fugitive on a Federal charge arising from the fatal shooting of the Reverend Dr. Martin Luther King, Jr., in Memphis, Tennessee, on April 4, 1968.

Director J. Edgar Hoover stated that a Federal complaint was filed by the FBI in Birmingham, Alabama, today charging Galt with conspiring to violate the civil rights of Dr. King in violation of Title 18, Section 241, of the United States Code.

The FBI complaint charges that "on or about March 29, 1968, at Birmingham, Alabama, ... Eric Starvo Galt and an individual whom he alleged to be his brother, entered into a conspiracy which continued until on or about April 5, 1968, to injure, oppress, threaten, or intimidate Martin Luther King, Jr., ... in the free exercise or enjoyment of a right secured to him by the constitution or laws of the United States; namely, the right to freely travel from state to state. of this conspiracy, Eric Starvo Galt did, on or about March 30, 1968, purchase a rifle at Birmingham, Alabama...."

According to Mr. Hoover, a 30.06 rifle equipped with a telescopic sight was found near a rooming house on South Main Street in Memphis immediately after the fatal shooting of Dr. King occurred. The rooming house overlooks the Lorraine Hotel and Motel where Dr. King was staying.

Mr. Hoover said that FBI Agents determined that the 30.06 rifle had been purchased from a gun dealer in Birmingham, Alabama, on March 30, 1968. The telescopic sight also was purchased from this dealer.

The FBI Director said that Galt, who has used the names of John Willard and Harvey Lowmyer in the past, is the owner of a 1966 white Mustang bearing Alabama license plates which was located abandoned in Atlanta, Georgia, on April 11, 1968. Investigation disclosed that Galt purchased this car from a private citizen in Birmingham on August 30, 1967. The Mustang's odometer showed that it had been driven more than 19,000 miles between late August, 1967, and early April, 1968.

According to Mr. Hoover, Galt's travels in the Mustang included trips to Los Angeles, California; New Orleans, Louisiana; Birmingham, Alabama; and Mexico, as well as to Memphis, Tennessee, and Atlanta, Georgia. Galt was reported to have been in Memphis on April 3 and 4, 1968, and to have departed from there for Atlanta.

Intensive investigation by the FBI has disclosed that Galt has claimed to have been employed as a cook on Mississippi River vessels and as a Merchant Seaman. He is said to be an avid dancer and took dancing lessons in New Orleans in 1964 and 1965; in Birmingham during September and October, 1967; and in Long Beach, California, from December, 1967, to February, 1968.

Galt left Los Angeles on December 15, 1967, and drove his white Mustang to New Orleans, where he claimed he contacted either an engineering or a contracting firm. He left New Orleans on December 19th and arrived back in Los Angeles on December 21, 1967.

While in the Los Angeles area early this year, Galt took a course at a school of bartending and was graduated on March 2, 1968.

The fugitive is described as a white male. He is approximately 5 feet 8 inches to 5 feet 11 inches tall and weighs between 160 and 175 pounds. He is said to be a neat dresser and has a medium build.

Galt has brown hair, which he wears in a "brush" cut. He reportedly has blue eyes; his nose is straight and narrow; his teeth are straight and clean; and he has given his date of birth as .

The fugitive is said to have a nervous habit of occasionally pulling at an ear lobe with his hand. His left ear protrudes farther from his head than his right ear.

According to Mr. Hoover, persons who have met Galt describe him as a "loner" and state his language and dictation have a "rural" quality and suggest that he probably does not have a high degree of education. He is said to drink alcoholic beverages and has a preference for vodka and beer. He is a fan of western and country music.

Galt should be considered armed and dangerous. Any information concerning him should be furnished immediately to the nearest FBI office.

CONSPIRACY CHARGED IN KING SLAYING

BIRMINGHAM, Ala. (AP) — The FBI charged Eric Starvo Galt Wednesday with conspiracy in the murder of Dr. Martin Luther King Jr.

Joe Gamble, special agent in charge of the FBI office at Birmingham, said he issued the complaint Wednesday.

Gamble declined to comment on whether the FBI considered itself closer to an arrest than before Galt was officially named in the case.

The FBI had named Galt in a lookout bulletin for Galt last week in Florida but withdrew the bulletin four hours later, saying it had been released in

error.

The charging of Galt was first announced Wednesday by the FBI in Washington.

In the first official mention of a conspiracy in connection with the April 4 assassination of Dr. King in Memphis, the FBI said the alleged plot involved also a man Galt described as his brother.

It was the first time that any conspiracy had been officially mentioned in connection with the April 4 assassination of King, in Memphis.

And the FBI issued a photograph which it identified as being one of Galt, and John Wil-

lard."

The FBI said a warrant was issued in Birmingham, Ala., on the basis of an FBI complaint which charged that Galt "and an individual whom he alleged to be his brother, entered into a conspiracy" which began around March 29 at Birmingham and ended about April 5 to "injure, oppress, threaten, or intimidate Martin Luther King Jr."

Galt was charged with conspiring to violate King's civil rights.

The FBI statement said that Galt, on or about March 30, bought a rifle at Birmingham. The bureau did not say specifically that this was the rifle that killed King.

But the statement said, "a 30.06 rifle equipped with a telescopic sight was found near a rooming house on South Main Street in Memphis immediately after the fatal shooting of Dr. King occurred." The rooming house overlooks the Lorraine Hotel and Motel where King was staying.

FBI agents have determined that the rifle was purchased from a Birmingham gun dealer March 30. The sight also was said to have been bought from the same dealer, whom the FBI did not identify.

The car's odometer showed it had been driven more than 19,000 miles between late August 1967 and early April 1968.

The FBI said "Galt's travel in the Mustang included trips to Los Angeles, Calif., New Orleans, La., Birmingham, Ala., and Mexico as well as to Memphis, Tenn., and Atlanta, Ga. Galt was reported to have been in Memphis on April 3 and 4, 1968 and to have departed from

there for Atlanta."

The FBI said also its investigation had disclosed these facts:

—Galt has claimed to have been employed as a cook on Mississippi river vessels and as a merchant seaman.

—He is said to be an avid dancer and took dancing lessons in New Orleans in 1964 and 1965, in Birmingham during September and October 1967 and in Long Beach, Calif., from December 1967 to February 1968.

—Galt left Los Angeles last Dec. 15 and drove his Mustang to New Orleans where he claimed he contacted either an engineering or a contracting firm. He left there Dec. 19 and arrived in Los Angeles Dec. 21.

—While in the Los Angeles area early this year, Galt took a course at a bartending school and was graduated March 2.

An FBI description of Galt said persons who have met him "describe him as a loner and state his language and diction have a rural quality and suggest that he probably does not have a high degree of education. He is said to drink alcoholic beverages and has a preference for vodka and beer. He is a fan of Western and country music."

The bureau warned that "Galt should be considered armed and dangerous," and any information concerning him should be furnished immediately to the FBI.

The FBI gave no further identification of the man Galt has alleged to be his brother, would not say where it obtained the photograph, and would not disclose in what connection Galt used the Lowmyer alias.

Acusado en Caso King

FBI Ordena Captura de Eric Starvo Galt

WASHINGTON (UPI)— El Negociado Federal de Investigaciones (FBI) emitió ayer orden de captura contra Eric Starvo Galt acusándolo de asociación ilícita en el caso del asesinato del líder negro Martin Luther King.

Es la primera confirmación oficial de haber existido una conspiración para el asesinato de King en Memphis, el 4 de abril.

El secretario de justicia, Ramsey Clark, anunció que las autoridades federales han entrado en acción para aprehender a Galt bajo el cargo de haberse asociado ilícitamente con otras personas para privar a King del ejercicio de sus derechos constitucionales. Este sería el único cargo que podría dar jurisdicción al FBI y a las autoridades en el asunto, ya que los cargos por el delito de asesinato podrían ser presentados únicamente por el estado de Tennessee donde ocurrió el crimen, dentro de su propia jurisdicción.

El FBI ha dado a conocer dos fotografías de un individuo identificado como el propio Galt, y conocido también por los nombres de Harvey Lowmyer y John Willard.

En la demanda presentada en Birmingham (Alabama), el FBI señala que Galt y un individuo que éste decía ser su hermano,

"se asociaron ilícitamente, asociación que continuó hasta el 5 de abril de 1968, para dañar, oprimir, amenazar o intimidar a Martin Luther King. El FBI dijo también que la asociación

ilícita comenzó en Birmingham a partir del 29 de marzo de 1968, y que Galt compró en Birmingham un fusil, alrededor de la fecha del 30 de marzo.

El Director del FBI, J. Edgar Hoover, dijo que un fusil calibre 30.06 equipado con mira telescópica fue encontrado inmediatamente en una calle cercana poco después del asesinato de King, en Memphis. El fusil, según informó el FBI fue comprado en Birmingham el 30 de marzo.

El FBI identificó a Galt como el propietario del automóvil blanco, un Mustang Ford con placas del estado de Alabama, que fue encontrado abandonado en Atlanta, el 11 de abril.

El FBI dijo que Galt compró el automóvil a un ciudadano particular en Birmingham, el 30 de agosto del año pasado y que había recorrido 19,000 millas (30,000 kilómetros) entre esa fecha y principios de abril de este año, en que fue abandonado.

Hoover indicó que Galt había llevado el automóvil a Los Angeles, Nueva Orleans, Birmingham y Méjico, así como a Memphis y Atlanta. En Memphis permaneció dos días, el 3 y el 4 de abril, y luego salió con destino a Atlanta.

El FBI dijo también que sus investigaciones habían revelado que Galt dijo haber trabajado en una ocasión como cocinero en un vapor fluvial del Río Mississippi. Le gustaba bailar mucho y en 1964 y 1965 tomó lecciones de baile en Nueva Orleans, así como en Birmingham, durante septiembre y octubre de 1967, y en Long Beach (California), desde diciembre de 1967 hasta febrero pasado.

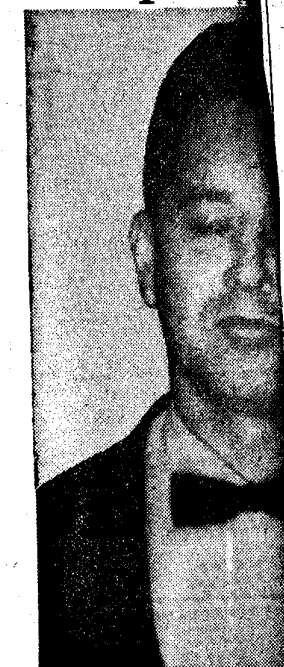
WASHINGTON (UPI)— El Negociado Federal de Investigaciones (FBI) emitió ayer orden de captura contra Eric Starvo Galt acusándolo de asociación ilícita en el caso del asesinato del líder negro Martin Luther King.

Es la primera confirmación oficial de haber existido una conspiración para el asesinato de King en Memphis, el 4 de abril.

El secretario de justicia, Ramsey Clark, anunció que las autoridades federales han entrado en acción para aprehender a Galt bajo el cargo de haberse asociado ilícitamente con otras personas para privar a King del ejercicio de sus derechos constitucionales. 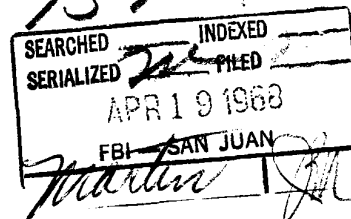

FBI Presses — Massive Hunt For Eric Galt

MEMPHIS, Tenn. (AP) — The FBI pressed one of the most massive manhunts in its history Thursday for shadowy Eric Starvo Galt, charged in the sniper slaying of Dr. Martin Luther King Jr.

But little more was known publicly about the alleged assassin of the civil rights leader than when his name first arose a week ago. It was learned, however, that a man registered as Eric S. Galt in a Memphis motel a day before King was killed.

Police agencies continued their "no comment" handling of queries—including questions about a newspaper report that the search had spread outside the country, to Mexico or Cuba. And they were silent on any de-

tails at all about a man with whom Galt may have conspired in the slaying.

A murder warrant was issued here Wednesday night for the 36-year-old Galt, five hours after the FBI charged him with conspiracy to violate the civil rights of King. The FBI warrant charged him with conspiring with a man "whom he alleged to be his brother."

King was killed by a single bullet the night of April 4 as he leaned over the second-floor railing of a Memphis motel. Police have said the shot was fired from the common bathroom of a low-cost hotel across the street.

The FBI said Galt had used the names of Harvey Lowmyer and John Willard. A man registered as "John Willard" checked into the hotel just three hours before King was killed.

Ivan B. Webb, night desk clerk at the Rebel Motel here, said a man registered there under the name of Eric S. Galt on April 3. Webb said a white mustang bearing Alabama license plates and Mexican tourist

stickers was parked near the room occupied by Galt. A similar car has been impounded in Atlanta, Ga., and the FBI said that car belonged to Galt. A white mustang is believed to have been the getaway car after the slaying.

The FBI declined comment on the possibility that a man who had checked into another motel April 3 might have been Galt's brother.

In Washington, Atty. Gen. Ramsey Clark described Galt Wednesday night as white, a neat dresser, of apparently limited education and a man with a taste for vodka and beer.

He also was described as an avid dancer with a liking for country and western music.

Police recovered a 30.06 Remington rifle with telescopic sight soon after King was killed. The weapon had been abandoned in a doorway near the scene of the shooting.

The Birmingham News said in a copyrighted story Thursday that a gun which the FBI said had been purchased in that city had been identified in ballistics tests as the 30.06 rifle which killed King.

The newspaper also said the

search for Galt has spread outside the United States and that it is believed the man has fled to Mexico or Cuba.

"There's no positive trace. He just vanished," the newspaper quoted its source as saying.

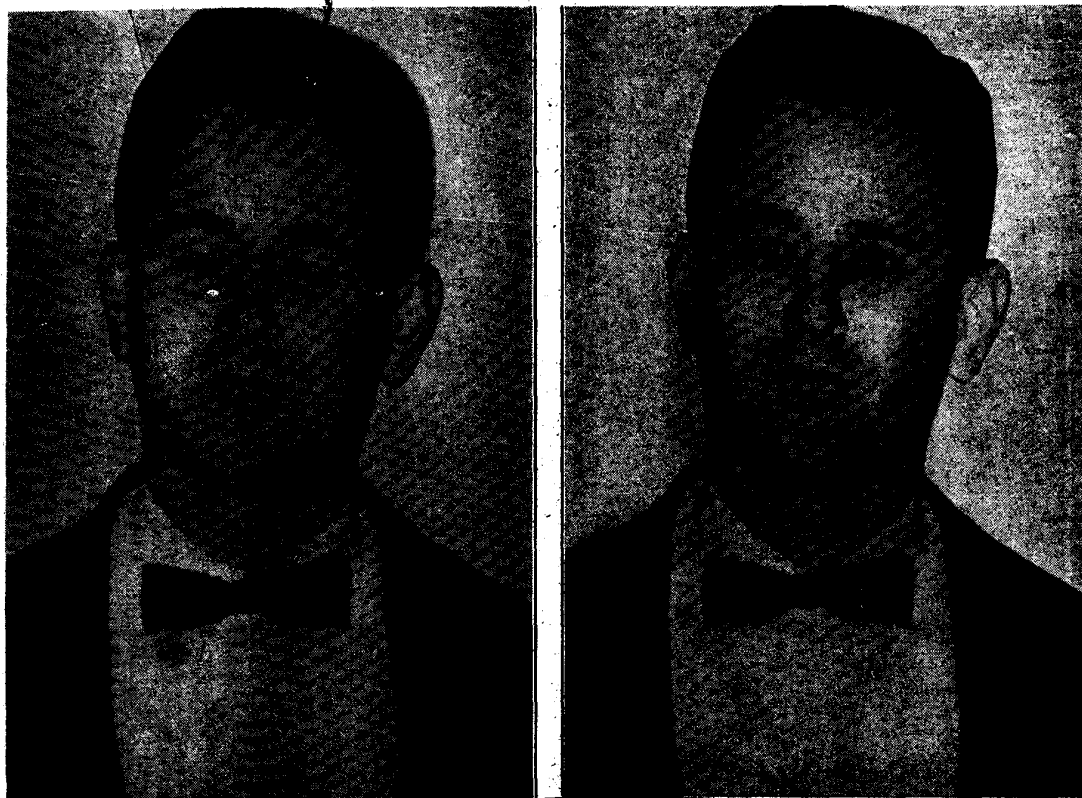
The photograph released by the FBI was obtained from the International School of Bartending in Hollywood, Calif., where Galt was graduated March 2 after a four-week course.

The FBI report said Galt took dancing lessons in New Orleans, Birmingham and Los Angeles. Rod Arvidson, general manager of the National Dance Studios in Los Angeles, said he recognized Galt from a composite drawing in a newspaper and called the FBI.

Arvidson described Galt as shy and quiet. "He's certainly no mixer," he said. "He had trouble coordinating one foot with another."

Arvidson said the man who enrolled as Eric S. Galt took 50 to 60 lessons in social dancing at a cost of about \$500. The lessons ended in mid-February.

Arvidson said Galt told him he operated a restaurant-bar in Mexico but that Galt failed to respond when Arvidson put questions to him in Spanish.

Attorney General Ramsey Clark announced today that the Federal Bureau of Investigation (FBI) has identified James Earl Ray, an escapee from the Missouri State Penitentiary, as Eric Starvo Galt, against whom a Federal complaint was filed last Wednesday in connection with the fatal shooting of the Reverend Dr. Martin Luther King, Jr.

Director J. Edgar Hoover said that a systematic and exhaustive search of latent fingerprints uncovered in the Dr. King case against the fingerprints of the over 53,000 persons for whom "Wanted Notices" have been posted in the files of the FBI's Identification Division led to the determination that Galt and Ray are identical.

Mr. Hoover said that Ray, who is 40 years of age, was reported missing from the Missouri State Penitentiary at Jefferson City, Missouri, since April 23, 1967. He had been received at that institution on March 17, 1960, to serve a 20-

year sentence following conviction in St. Louis for armed robbery and for operating a motor vehicle without permission of the owner.

In September, 1966, while serving this sentence, he was confined for a time in the maximum security ward at the State Hospital at Fulton, Missouri.

According to Mr. Hoover, Ray has a known arrest record dating back to 1949. Prior to the 1960 conviction for which he received the 20-year term, Ray had been convicted of burglary in Los Angeles, California, in 1949; armed robbery in Chicago, Illinois, in 1952; and forging United States postal money orders in Missouri in 1955.

He has served terms in the Los Angeles County Jail in 1949; in state prisons at Joliet and Pontiac, Illinois, in 1952-54; and in the Federal Penitentiary at Leavenworth, Kansas, in 1955-58.

Ray was an enlisted man in the United States Army from February, 1946, to December, 1948, at which time he was given a general discharge due to ineptness and lack of adaptability for military service. While in the army, he received a three-month sentence at hard labor for being drunk and breaking arrest.

Mr. Hoover said that during his criminal career, Ray has also used the names of James McBride, James Walton, W.C. Herron and James O'Conner. He is a white male; claims to have been born [] in Illinois; is approximately 5 feet 10 inches tall and weighs about 163 to 174 pounds. He has blue eyes and brown hair. There is a small scar on the center of his forehead and a scar on the palm of his right hand.

Ray has claimed that he attended school through the 10th grade in Alton, Illinois. He has had the reputation of being a "drifter" since leaving school. His vocational experience includes working as a baker, laborer and color matcher.

In connection with his escape from the Missouri State Penitentiary, an FBI complaint was filed in Jefferson City, Missouri, on July 20, 1967, charging Ray with unlawfully fleeing from the State of Missouri to avoid confinement. He has been a Federal fugitive since then.

Ray should be considered armed and extremely dangerous.

Anyone having information concerning him should immediately contact FBI Headquarters in Washington, D.C., or the nearest FBI office.
