★ Gun Reported To Be One Used To Kill Dr. King

BIRMINGHAM Alabama (A) — The Birmingham, Alabama News said yesterday in a copyright story that a gun which the FBI said was purchased in Birmingham has been determined by ballistics tests to be the weapon used in the slaying of Dr. Martin Luther King.

The story said also that the search for Eric Starvo Galt, who is charged with conspiracy in King's death, has spread outside the United States.

Quoting an unidentified source, described only as an investigator, the News said it is believed that Galt has fled to Mexico or Cuba.

The FBI has said previously that Galt, on or about March 30, bought a rifle in Birmingham.

The statement also said that a .30-06 rifle equipped with a telescopic sight, was found near the motel in Memphis, Tennessee where King was slain.

Galt resided in a Birmingham rooming house from Aug. 26 to Oct. 7, 1967.

The FBI said he took dance lessons in Birmingham from Sept.

Hunt Pressed For King Murder Figure

April 18 (AP) — The nationwide hunt continues today for Eric Starvo Galt, identified by the FBI as one of the men involved in the assassination of Martin Luther King.

The FBI has charged Galt with conspiracy to violate the civil rights of King. And the state of Tennessee has charged Galt with first de-

gree murder in the April 4 Memphis killing.

The FBI says Galt and a man Galt said was his brother entered into the conspiracy against King six

days before the assassination. No charge has been filed against the alleged brother.

Meanwhile, authorities refuse to say whether still others are suspected of taking part in the murder plot.

The FBI says the plot was laid in Birmingham, Alabama where Galt bought a rifle on or about March 30.

Earlier this year, Galt took a bartending course in the Los Angeles area. But the director of the school, Tomas Lau, says Galt never said anything about Negroes. And residents of the Birmingham boarding house where Galt had lived did not recall Galt talking about racial issues.

Accused Slayer Of King Described As Quiet Man

LOS ANGELES (AP)—The FBI has been told that Eric Starvo Galt is a shy, quiet man who spent \$700 in three months for dancing and bartending lessons. Galt is sought in the assassination of civil rights leader Martin Luther King in Memphis April 4.

The managers of a dancing school and a bartending school told newsmen in Los Angeles they positively identified their former pupil to the FBI as the man charged with the King killing.

The general manager of National Dance Studios, 46-year-old Rob Arvidson, says he notified the FBI Saturday after recognizing Galt from a composite drawing in a newspaper. Arvidson says of Galt: "He's certainly no mixer. He had trouble coordinating one foot with another."

A photograph of Galt circulated

by the FBI was obtained Tuesday from the International School of Bartending. The school's director, Tomas Lau, says Galt was graduated March 2 from the Hollywood school after an "excellent" record in a \$225 four-week course which Galt attended Saturday mornings and Sunday afternoons.

Galt's application listed his address as Hollywood and his birth-date as [redacted] and stated he was single.

Two dance instructors agree Galt was withdrawn and a loner. But they describe him as clean-cut and without any expressed

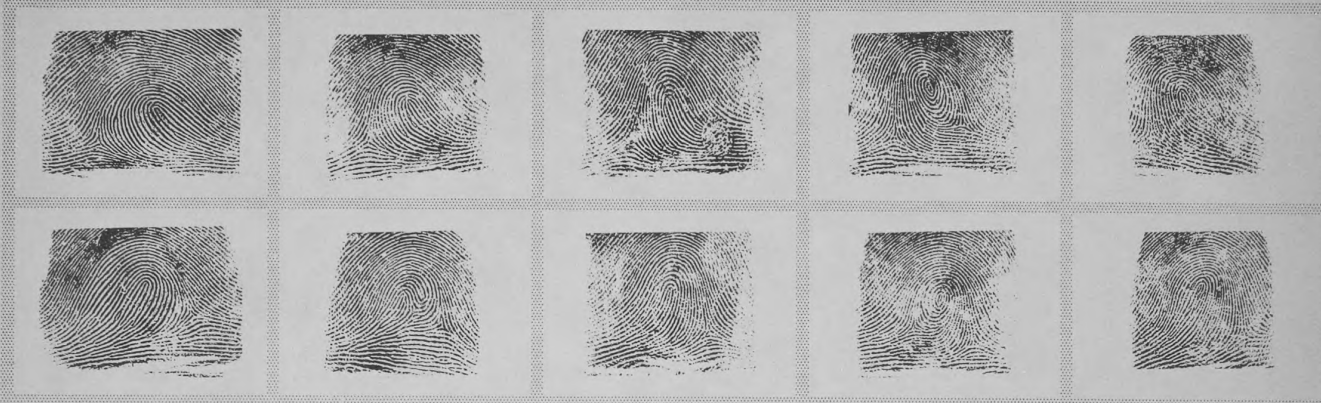

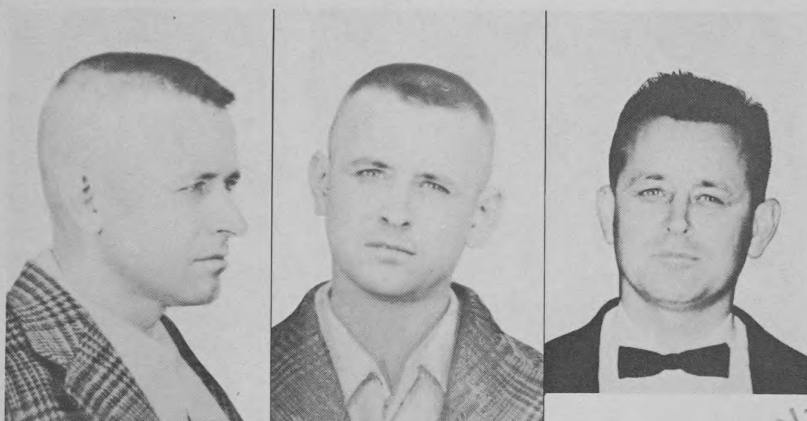

Penado Afirma Ofrecieron Un Millón por Muerte King

DALTON, Georgia, Abril 24 (UPI) — Un penado amigo de James Earl Ray dijo que cuando éste se enteró que se ofrecía un millón de dólares por el asesinato de Martin Luther King, sonrió y dijo: "aquí está quien los cobrará". Ray, un fugitivo de la cárcel del estado de Missouri, es buscado por el Ne-

gociado Federal de Investigaciones (FBI) por asesinato de King en Memphis, el 4 de abril.

En la cárcel de Dalton, Raymond Curtis, quien ha sido condenado por homicidio, declaró que fue amigo de Ray en las penitenciarías de Kansas City, Leavenworth, Kansas, y Jefferson City, Missouri.

Curtis dijo que Ray era un hombre simpático, aunque toxicómano y muy interesado en el dinero.

Agregó que el día en que fue asesinado el presidente John F. Kennedy, el 23 de noviembre de 1963, se encontraba en el

patio de ejercicios con Ray y otros 150 penados cuando tuvieron conocimiento de la noticia. Afirmó que el prófugo observó: "Seguro que alguien ganó bastante dinero con eso" y que alrededor de una semana más tarde, cuando él y Ray estaban en el mismo patio, "un hombre nuevo, que acababa de llegar de la calle", dijo que una "asociación de comerciantes ofreció una bonificación de un millón de dólares por Martin Luther King".

Ray, según expresa Curtis, sonrió y declaró: "Si hay un millón de dólares ofrecido por

King creo que aquí está quien los cobrará, si alguna vez quedo en libertad".

Curtis precisó que no recuerda quién era el "hombre nuevo" y que nunca supo qué quería decir con la "Asociación de Comerciantes, pero observó que en "la cárcel se oyen muchas cosas raras".

Explicó Curtis que Ray comentó que si algún día decidiese dar muerte a alguien, compraría el arma bajo un nombre falso y tendría todo preparado.

"Hablaba mucho de escapar a Nueva Zelandia, Brasil o Argentina", comentó.

CABORCA (Méjico) (UPI)
—La Policía detuvo a un individuo bajo sospechas de que pudiera ser el presunto asesino del dirigente negro norteamericano Martin Luther King, Hijo, según anunciaron hoy las propias autoridades.

Los agentes del orden arrestaron ayer por la tarde al sospechoso en un café de esta localidad, situada en el estado de Sonora, y lo sometieron a interrogatorio durante 12 horas en su habitación del Hotel San Carlos. Según informó el propietario de dicho Hotel, Carlos Valencia Beltrán, al cabo de el interrogatorio, el detenido fue llevado por la Policía en automóvil a Hermosillo, capital de Sonora.

Valencia Beltrán afirmó a la United Press International que él había avisado ayer a la Policía para que comprobaran la identidad de un norteamericano que se había alojado en su hotel en la noche del martes. Explicó que el individuo se parecía mucho a las fotografías que han circulado del supuesto asesino de King, James Earl Ray, quien está reclamado por la Oficina Federal de Investigaciones (FBI) de Estados Unidos.

El huésped dijo llamarse Daniel David Kennedy y tener 42 años. Aseguró que su domicilio está en Baltimore (Maryland) y que había venido a Méjico como turista con el propósito de dirigirse al Desierto de Altar, en Sonora. Añadió Kennedy que tiene una hija en Baltimore y que está divorciado, de acuerdo con Valencia Beltrán.

El teniente Roberto Fletcher, perteneciente al Departamento de Investigaciones de la Policía de Caborca, declaró por su parte que había observado al sospechoso antes de entablar conversación con él. Hecho esto, lo llevó a la habitación que ocupaba en el Hotel citado y allí lo mantuvo en calidad de detenido. El Hotel fue rodeado simultáneamente por varios agentes. No se hallaron armas en la habitación aludida.

Informó la Policía que se ocupó al detenido el pasaporte número 8527475. No se sabe si han sido formulados

Valencia Beltrán dijo que Kennedy manifestó que había venido a pie desde Sarich de Nogales (Sonora), por donde entró en Méjico, y que llevaba en la espalda una mochila militar. Vestía ~~paño~~ camisa azul, con botas, y tenía barba.

Agregó que sospechó de

Kennedy cuando éste trató de comunicarse por teléfono con una persona no identificada en Baltimore, por razón de su parecido con las fotos de Ray. Siguió diciendo que el huésped detenido tenía un tatuaje en el brazo izquierdo que parecía ser la figura de un mono.

(Entre tanto, en Baltimore la madre de Kennedy llamada Pearl, se sorprendió ante la noticia de la detención y exclamó: "Eso es imposible, eso es imposible".

(Aclaró que su hijo es delgado y que sólo un ciego podría confundirlo con el hombre que busca la FBI.

Agregó que Kennedy había sido herido en la Segunda Guerra Mundial y que lo condecoraron con el Corazón de Púrpura.

(Es incapaz de hacer daño a una mosca", comentó.

(Apuntó la señora Kennedy que su hijo tiene simpatía por la gente de color y que opina que no se les dan oportunidades equitativas. "Esa fue una de las razones que lo llevó a Méjico", sentenció.

(Explicó que Kennedy salió de Baltimore el 24 de marzo último luego de responder al anuncio de una persona que quería le guiara un automóvil hasta Tucson (Arizona), compartiendo

los gastos. Según este relato, el hijo de Pearl, la que tiene 68 años, fue de Tucson a Caborca pidiendo a los automovilistas que lo llevaran gratis por el camino y la llamó por teléfono el martes por la noche.

("Le mandé por telégrafo 30 dólares ayer", afirmó. Expuso que su hijo carece de empleo permanente debido a que no tiene oficio y a las heridas recibidas en la guerra. Le envían un cheque de veterano del Gobierno).

Por otro lado, en Atlanta, el reverendo Ralph Abernathy dijo el miércoles que quizás el asesino del doctor Martin Luther King, Jr., pudo haber creído que cumplía

con una "misión divina". Especuló que tal vez exista una conspiración para matar a los líderes de los derechos civiles.

Abernathy, sucesor de King como director de la Conferencia Sureña de Liderato Cristiano, manifestó que no estaba tan preocupado por el asesino "como lo estoy del ambiente de esta nación que lo produjo (al asesino).

"Rezaré por él y pediré que sea perdonado porque no sabe lo que hace", dijo Abernathy. "Pero es otro incontable número de personas que sienten de la misma manera que sintió este hombre?"

On 4/26/68, FREDERICK WUERTH, Casa Meyer, Old San Juan, telephonically contacted the writer at the San Juan office and advised he thought he had seen an individual answering the description of JAMES EARL RAY. WUERTH stated he was calling from the Excelsior Theater, Calle Parque, Stop 23, Santurce and that he would wait at the theater for an FBI agent to contact him.

SA Mosher
The writer and SA H. LAMAR MEYER went immediately to the theater and contacted WUERTH. Photographs of RAY, and his physical description were furnished to WUERTH. He stated the individual to whom he was referring, who had left the theater, definitely did not answer RAY's description, and did not look at all like the photographs of RAY which were exhibited to him. He advised this individual had a receding hairline to the point of being almost bald, what hair he did have was in a crew cut. WUERTH took a close look at this individual and is positive that his eyes were green, not blue as are RAY's. He stated he was also heavier than the weight given for RAY, he estimated the man to be approximately 180 to 190 lbs. He is also positive the individual to whom he is referring did not have a protruding left ear.

The manager, and employees of the theater were exhibited photographs of RAY and stated they ~~had~~ had definitely not seen anyone answering RAY's description in the theater, and that only two or three "Continental's" had entered the theater for the matinee, and that none looked anything like RAY.

The writer and SA MEYER personally observed all patrons of the theater and could find none resembling RAY.

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., has been added to the FBI's list of "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his earliest possible location.

Ray has been the subject of a massive and intensive search since the brutal gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel. One rifle bullet, believed fired from the window of a nearby rooming house, felled the victim.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against fingerprints of over 53,000 persons on whom wanted notices have been posted in the FBI's Identification Division, succeeded in determining that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray, who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year-old white male, reportedly born in Illinois on He is approximately 5'10" inches tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. He has a small scar on the center of his forehead and a scar on the palm of his right hand. He has been described as having a straight, narrow nose and straight and even teeth and to have a nervous habit of occasionally tugging at an ear lobe. His left ear protrudes noticeably.

Acquaintances describe him as a "loner" and "drifter" whose language and diction reflect a "rural" quality and indicate he has had limited education.

He is reportedly a fan of western and country music, drinks vodka and beer, dresses neatly and claims past employment as a merchant seaman and cook on Mississippi River vessels. He is known to have worked as a baker, laborer and color matcher.

He is known as an avid dancer who has taken dancing lessons. He also completed a course at a school of bartending in the Los Angeles area early in 1968.

Ray should be considered armed and extremely dangerous. Anyone with information concerning this fugitive is requested to immediately contact the nearest office of the FBI, the telephone number of which may be found on the first page of local telephone directories.

THE CRIMES: Ray escaped from the Missouri State Penitentiary, Jefferson City, Missouri, on April 23, 1967, while serving a 20-year sentence for armed robbery and operating a motor vehicle without the owner's permission. He subsequently allegedly conspired, under the alias Eric Starvo Galt, to violate the civil rights of Dr. Martin Luther King, Jr., shot to death on the balcony of a Memphis, Tennessee, motel on April 4, 1968.

THE CRIMINAL: A 40-year-old white native of Illinois, who is known as a "loner" and "drifter" and has taken elaborate steps to establish a false identity, Ray has an extensive criminal record, including convictions for burglary, robbery and forging U. S. Postal Money Orders. Outstanding characteristics include a straight narrow nose, straight and even teeth, a noticeably protruding left ear and a nervous habit of tugging at an ear lobe. He has taken dancing lessons, attended bartending school, enrolled in a correspondence course in lock-smithing and traveled widely in a 1966 Mustang recovered in Atlanta, Georgia, a week after Dr. King's murder. Ray likes western and country music, drinks vodka and beer and has worked as a baker, laborer and color matcher.

PROCESS: A Federal warrant issued at Jefferson City, Missouri, on July 20, 1967, charges Ray with unlawful interstate flight to avoid confinement for robbery. Another Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, as Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a citizen.

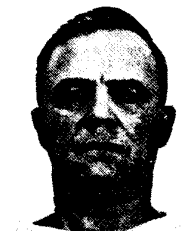

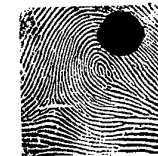

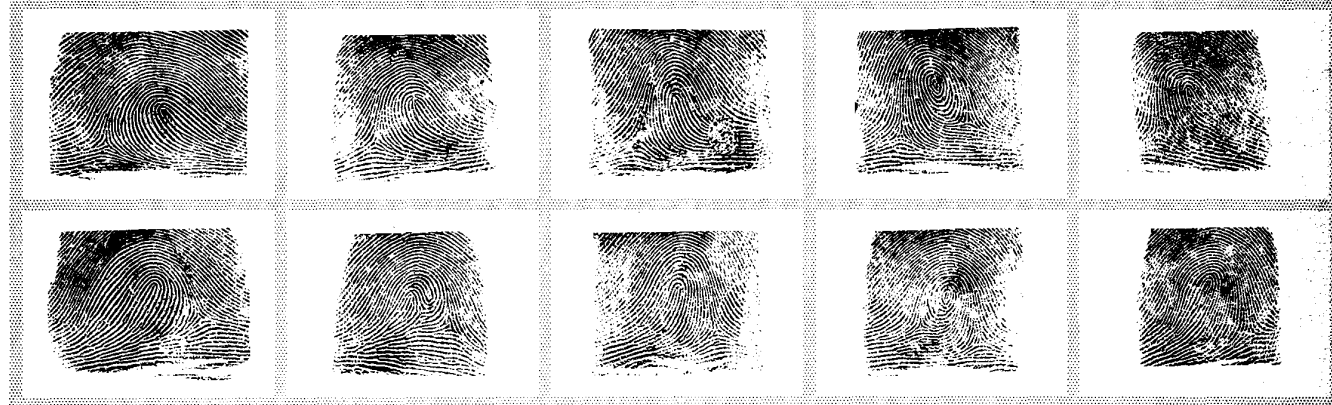
