3. Source furnished ten copies of issue #24 of "Pueblo", March, 1968. These copies are all being destroyed as this issue has previously been received and translated.

Source could not report any positive information concerning the recent assassination of Dr. MARTIN LUTHER KING, JR.

Source advised that no discussions had been held at the PCP meetings concerning recent bombings and incendiary activities in San Juan, Puerto Rico. He was directed to take every opportunity to converse with friends and acquaintances in an effort to develop information concerning these incendiary activities.

4. The following is lead information, not reduced to writing:

ALBERTO RODRIGUEZ MERCADO DELGADO was introduced to the PCP during the spring of 1967 by PCP member JOSE ANDUJAR. He attended a few PCP meetings during the spring of 1967, but then stopped attending PCP meetings. Source could furnish no information concerning any organization that RODRIGUEZ might have joined after quitting the PCP.

TORRES and KENTISH are both veterans and ROMERO, KENTISH, and MOHLER belong to unions.

JUAN SANTOS, GERTRUDIS MELENDEZ, PASCUAL OTERO, JOSE CHEVERE, ENAMORADO CUESTA, and FELIX OJEDA are all unemployed. SERGIO KENTISH is the only negro who is presently a PCP member.

The PCP covers the entire island of Puerto Rico but there are no appreciable activities outside the metropolitan area of San Juan, Puerto Rico. Marxism classes have been discontinued and the PCP is now holding historical conferences on Sundays instead of the Marxism classes.

PCP Headquarters is located at 13 Venecia Street, Stop 27, Hato Rey, Puerto Rico, in a residence owned by JUAN SANTOS RIVERA.

An individual named RAMON CRUZ recently wrote a letter to JUAN SANTOS RIVERA advising him that he wished to join the PCP but no action has been taken on this request.

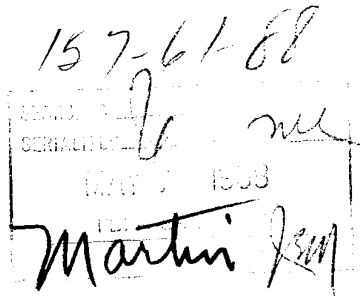

On 4/28/68, 9:30 pm, I received an anonymous telephone call at my home. The caller advised that one week ago at approximately 10:30 am he was at Red Hook, St. Thomas, Virgin Islands, and overheard a conversation between a 40 year old white male and one of the employees of the Dohm Water Taxi Service. The 40 year old white male fit the description of the individual sought in the MURKIN case and looked similar to the caller to a picture he saw in the 4/20/68, issue of the New York Times. He said this unknown individual inquired as to places to stay in Cruz Bay, St. John, and Mead's was recommended to him as a comfortable spot that was not too expensive.

I conducted the following investigation on 4/29/68.

Per Dohm, Operator of the Dohm Water Taxi, at Red Hook, St. Thomas, advised that he recalled having spoken to an individual approximately a week ago who was inquiring about a place to stay in Cruz Bay, St. John, Virgin Islands. He explained that the incident stood out in his memory since almost without exception anyone going to St. John has reservations there for a place to stay. Since Dohm transports so many people to and from St. John from Red Hook, he was unable to furnish a description of the individual in question. He viewed photographs of RAY, aka Galt, and advised that he could not state that the individual in question looked like these photographs. After transporting the individual in question to Cruz Bay, Dohm saw him sometime later possibly the following day and inquired if he had found a place to stay. The individual told him that he was staying at Ellingtons Guest House.

Mr. and Mrs. RICHARD ELLINGTON, Ellingtons Guest House, advised that the only unaccompanied male guest they had had was VICTOR VILLEMAIN who stayed with them 2 days beginning 4/23/68. He gave as his home address 31 Union Square, New York City, 10003. He had a bar bill of \$4.55 and paid \$20 a night for the 2 nights. Both Mr. and Mrs. ELLINGTON advised that VILLEMAIN was over 50 years of age, had long hair and walked with a cane. His manner was effeminate and they suspect that he is a homosexual. After examining photographs of RAY, aka "Galt" they advised there was no question in their mind but what this VILLEMAIN could not be identical with RAY.

With the assistance of Patrolman V. SPRAUVE, St. John Police Department, the following individuals were contacted concerning the possibility of RAY having been in the area or been a guest at their establishments. No positive information was developed. Mrs. MEADA, MEAD's Guest House, Cruz Bay, St. John, Virgin Islands; Mr. and Mrs. JOHN R. WOODSIDE, Cinnamon Bay, St. John, Virgin Islands; DAVID BREWER, Manager Cameel Bay Plantation, St. John, Virgin Islands.

Photographs of RAY were left with Captain LEANDER R. JURGEN, St. Thomas Police Department, who was made aware of the circumstances of the anonymous telephone call he advised that he would realert the 9 men on his force in St. John to be doubly alert for any individual who might fit the description of RAY and immediately notify the contacting agent.

On 4/23/68 PHILLIP S. ARENSBERG, General Manager, Caddillac Uniform and Linen Supply, corner of A and C Streets, Minillas Industrial Center, Bayamon, Puerto Rico, advised his company uses a National Markmaster machine which applies a one inch cloth tape to rental uniforms and prints in all capital letters that measure 1/3 inch; the ink is red. This machine was viewed in operation. ARENSBERG advised that the above mentioned machine was the only marking machine used by his company. He viewed the color photo of the shirt and shorts that have the number 02B-6 and stated that his equipment would not prepare such a mark.

On 4/23/68 an attempt was made to contact Mrs. MARIA FERRER BALCELLS at 1B-32 Royal Palm, Bayamon, P.R. to no avail.

On 4/24/68 Mrs. FERRER was contacted at the above address and she furnished the following information:

~~She advised~~ On Monday, 4/15/68, at about 5:00 p.m. she caught a airport bound bus at stop #19 on Fernandez Juncos. She advised that this bus was crowded and that one of the male passengers who was standing in the bus when she boarded was later seen by her in the airport terminal. FERRER stated that she had gone to the airport to recover a piece of luggage and did not notice any person or place contacted by the above mentioned passenger during the period of approximately one hour that she was in the Airport terminal.

FERRER stated that she boarded a bus marked "Airport via Condado" upon leaving the Airport Terminal with her piece of luggage and took a seat next to a window on the right side in the middle of the bus. She advised that moments later the above mentioned individual entered the bus; walked to the rear portion and then returned and set in the seat immediately to her left. She advised that she did not get a good look at this individual's face from the front inasmuch as he never turned his head while sitting next to her even though he talked to her in English and did not know Spanish. She furnished the following description of the above individual:

Mrs. FERRER advised that while returning from the airport the above described man mentioned that he was from Connecticut and was looking at a folded map (origin unk.) and he asked her if the bus would pass close to Punta Las Marias. She said that she told him that the bus would pass very close to that area and he then told the bus driver to remember to stop in that area. FERRER then stated that the above Unknown Male wanted to know the frequency of the busses that ran between Punta Las Marias area and the airport. She advised that they operated frequently and told him so. She stated that he got off the bus at Llorens Torres near a small triangular park and walked ~~xxx~~ towards the beach. She stated that he turned and waved to her from the sidewalk and she caught a glimpse of his face from the front.

FERRER advised that on 4/20/68 she saw a photo of ERIC STARVO GALT in the local paper, EL MUNDO, and that the photo displayed bore a very strong resemblance to the man that she described above as having been on the bus with her. When asked as to why she remembered this man she stated that she thought it very strange that the man on the bus would never turn and face her even though they conversed during their trip together.

JAMES EARL RAY

■ Mrs. FERRER viewed several photos and selected the photos on I.O. 4182 (the 2 photos on the left) as being very close to the person she saw on 4/15/68. She stated that the man she saw had longer (medium length) hair and she was not sure of the straight-on face photo of JAMES EARL RAY, aka, but noted that the profile shot was very close ~~to~~ to the man she described above. *However she stated she could not state the individual she saw was identical with James Earl Ray.*

On 4/²⁵~~28~~/68 an examination was made of the area along Baldorioty Avenue which Mrs. FERRER described as the point of departure from the bus by the above described unknown male. It was determined that ^{the} individual had apparently departed the bus on 4/15/68 at the corner of Jupiter St. and Baldorioty Ave.

The following guest houses in this area ~~was~~ were contacted with negative results:

Same date HENRY MARQUE RODRIGUEZ, White Castle Guest House, 106 Doncella St., advised that several days prior a young man had inquired about a room, but desired something cheaper than ~~XXXXX~~ \$25.00 per week. This young man was described as follows:

185 lbs.
sandy hairs

RODRIGUEZ stated that the above person bore a slight resemblance to the 1960 photos of JAMES EARL RAY on I.O. #4182, but that this person was definitely not RAY based on age.

On 4/25/68 Mr. and Mrs. O.S.E. PERKINS, the owners of the Villa Mar Guest House, 4 Caoba St., advised that on 4/15/68 one ROBERT C. WHELAN registered at their guest house and ~~XXXXX~~ gave his address as 1773 Central Avenue, Bridgeport, Conn. They advised that WHELAN left to return to Conn. on 4/22/68 with some money which was cabled to him by his father. They described ~~XXXXXXXXXX~~ WHELAN as follows: White/male, age 20s, 6 ft., 175-180 lbs., Brown hair, blue eyes, no scars or marks recalled. The PERKINS observed I.O.#4182 and advised that WHELAN was not identical with JAMES EARL RAY, but noted that the profile photo of RAY bore some resemblance to the profile of WHELAN..

In view of the above information regarding WHELAN it is felt that WHELAN is identical with the person seen on 4/15/68 by Mrs. FERRER.

FBI Admite Posibilidad Acusado Asesinato King Huyó Australia

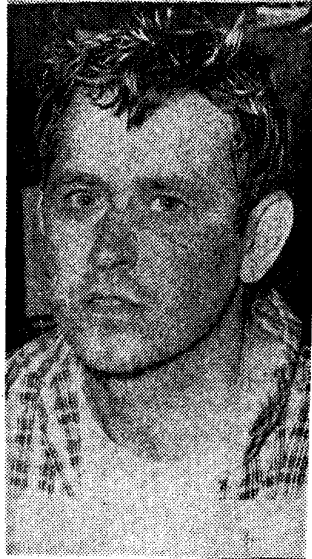
WASHINGTON — (UPI) — Un funcionario de la Embajada de Australia informó ayer que el FBI le pidió al gobierno australiano que realizara una "investigación de rutina" para ver si James Earl Ray, a quien se busca por el asesinato del doctor Martin Luther King, solicitó una visa para viajar a ese país.

El funcionario enfatizó, sin embargo, que "las autoridades australianas no tiene evidencia de que la persona interesada (Ray) esté en Australia."

Las fuentes estadounidenses también subrayaron la naturaleza rutinaria del pedido. Estos dijeron que sería lógico asumir que pedidos similares tiene o deben de ser hechos a otras naciones en las cuales Ray podría buscar refugio. El FBI no comentó sobre las declaraciones del funcionario de la Embajada.

Ray, también conocido por el alias de Eric Starvo Galt, ha sido objeto de una búsqueda incesante desde que el doctor King fue muerto mientras estaba parado en el balcón de un hotel en Memphis, Tenesí.

Ray, quien ha sido acusado de asesinato por las autoridades de Memphis, fue añadido a la lista de los más buscados por el FBI después de una investigación de más de 53,000 hue-

llas digitales que dieron a conocer que las huellas encontradas en el baño de una casa de hospedajes eran idénticas a las del hombre buscado. Este también encara una acusación federal por conspiración.

Ray se escapó de una penitenciaría estatal en Missouri en abril del 1967, mientras cumplía una sentencia de 20 años por robo armado y robo de autos.

El funcionario de la Embajada de Australia dijo:

"A pedido del FBI, las autoridades australianas están realizando una investigación de rutina para ver si ha habido una solicitud de visa para Australia por la persona acusada del asesinato del doctor Martin Luther King, hijo."

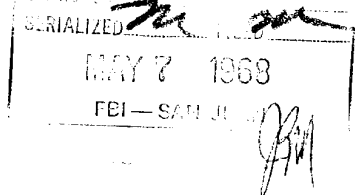

WASHINGTON (AP) -- A man sought in connection with the slaying of Dr. Martin Luther King has been identified by the Federal Bureau of Investigation as an es-

capee from the Missouri State Penitentiary.

noon that Eric Starvo Galt actually is 40-year-old James Earl Ray.

The G-Men said Ray, who used the alias Galt, was identified through an exhaustive check of latent fingerprints uncovered in the King case.

The F.B.I. said it went through the fingerprints of the more than 53,000 persons for whom wanted notices are on file in the Bureau's identification division.

Ray has been reported missing from the Missouri State Penitentiary since April 23, 1968. He was serving a 20-year sentence for armed robbery in St. Louis.

CRIMINAL ACCUSED OF KING DEATH MAKES F.B.I.'s 'MOST WANTED' LIST

WASHINGTON (AP)—What may be the nation's most intensive manhunt gained fresh pressure when the F.B.I. placed on its "most wanted" list a fugitive convict accused of murder in the assassination of Dr. Martin Luther King.

James Earl Ray, 40-year-old armed and extremely dangerous. habitual criminal, is being hunted by police from border to border and beyond for the April 4 sniper-slaying in Memphis of the Negro civil rights leader from Atlanta.

The F.B.I. always has limited its list of most wanted criminals to ten names. But it has lengthened this roll of dishonor to eleven by adding Ray, a white loner known also by the name of Eric Starvo Galt and by six other aliases.

In addition to a state first-degree murder warrant issued in Memphis, Ray is wanted on Federal charges of conspiracy to deny Dr. King his civil rights and of flight to escape confinement. The latter charge stems from his April 1967 escape from Missouri Prison at Jefferson City where he was starting a 20-year sentence for armed robbery.

In announcing the unprecedented step of adding an eleventh name to the "ten most wanted" list, F.B.I. Director J. Edgar Hoover announced it was done "to insure the widest possible dissemination of Ray's photograph and description to help effect his earliest possible location."

The official language puts it this way:

"Ray should be considered anyone with information concern-

ing this fugitive is requested to immediately contact the nearest office of the F.B.I. the telephone number of which may be found on the first page of local telephone directories."

Reportedly a native of Illinois, Ray is described as about five feet ten inches tall, weighing from 163 to 174 pounds. He has blue eyes and brown hair usually worn short. Forehead and right palm bear small scars. His nose is narrow and straight, teeth even. And he has a noticeable protruding left ear, the lobe of which he reportedly tugs at when nervous.

FBI Falla en Búsqueda Asesino de Luther King

Por ENRIQUE ROJAS-VELA

NUEVA YORK, Mayo 6 (UPD) — El 4 de abril Martin Luther King, el líder del Movimiento para el Avance de los Negros por Medios Pacíficos, fue asesinado en Memphis. El FBI que ha divulgado la identidad del presunto asesino, no ha podido dar con él y nada parece indicar que se esté cerca del éxito en la búsqueda de James Earl Ray, alias "Eric Starvo Galt", sindicado como autor del crimen.

Según las autoridades, Ray, fugitivo de la Penitenciaría del estado de Missouri, trabajó un año en la preparación de la identidad de Galt, de quien por supuesto, se carece de adecuada información estadística. La FBI tiene señalado que Ray dejó sus impresiones digitales en el fusil con que se ultimó al Dr. King.

Truman Capote, el autor de "In Cold Blood", extensa y dramática narración del asesinato de la familia Clutter (esposos e hijo e hija) en 1959, manifestó que en su opinión, las impresiones digitales de Ray en el fusil del asesinato no significan que Ray fuera quien apretó el gatillo que segó la vida de King.

Causando sensación con la teoría, que expuso con su habitual claridad y pausadamente, Capote expresó el convencimiento de que Ray pasó a mejor vida y que era ya cadáver semanas antes del asesinato del Dr. King. En cuanto a las huellas dactiloscópicas que aparecen en el fusil, dijo que efectivamente serían las del presidiario, como parte corroborante en una muy perspicaz conjura para terminar con el popular dirigente negro, ganador del Premio Nobel de la Paz. La conjetura es que el movimiento de reivindicación de los negros por medios ajenos a la violencia no convenía a los virulentos inspiradores del "poder negro", que no hace un secreto de su favoritismo por las medidas de fuerza y aun el terrorismo.

No formuló acusación alguna sino que meramente expuso su punto de vista en el progra-

ma de Johnie Carson en la red de televisión NBC. Dio a conocer asimismo interesantes aspectos del crimen en general y de los delincuentes. Por algo consagró cinco años a la preparación de "In Cold Blood", a partir de 1960. Tuvo oportunidad de familiarizarse con el

pensamiento íntimo de los dos asesinos de la familia Clutter, que fueron ajusticiados en abril de 1965, y estudió a fondo todos los aspectos de la criminalidad para formarse impresiones bien definidas de lo que puede hacer una "mente homicida".

HAROLD GLENDENNING, Manager, Base Exchange Laundry, Naval Station Annex, San Juan, Puerto Rico, advised that he has four (4) Thermo-Seal marking machines, made by the Textile Marking Machine Company.

He advised that they have never used a series of marking numbers starting with the letter O in marking laundry.

He stated that the Thermo-Seal tape is used by the laundry only on laundry and not dry cleaning and the red tape is used on "Super Specials," which is laundry with same day service. He advised that the Base Laundry uses the first letter of W on the red tape specials.

GLENDENNING viewed the photograph of the laundry mark "O2B-6" and stated that this does not appear to have been made by his machines. He noted that the first letter, O, was cut and the tape appeared to be shorter than the tape from his machines.

GLENDENNING furnished samples of the tape from each of his machines. These samples were taken in the presence of SA JAMES R. MARTIN from the following Textile Marking machines:

- 1) Serial Number 34064
- 2) Serial Number 34063
- 3) Serial Number 33520
- 4) Serial Number 33521

GLENDENNING advised that there is a distributor of Thermo-Seal tape in Puerto Rico and his name is MANUEL GOMEZ ESTEVES, Quisqueya and Haiti Streets, Hato Rey, Puerto Rico.

He stated that the laundry mark W2B-6 was used by the Base Laundry on 1/23/68, however, a search of all of the laundry files, both special and regular, failed to locate the laundry mark of W2B-6.

FBI Acusa a Prófugo Por Asesinar a King

WASHINGTON, (UPI) — El FBI identificó ayer a Eric Starvo Galt, buscado con relación al asesinato del doctor Martin Luther King, como James Earl Ray, escapado de la penitenciaría estatal de Missouri.

El miércoles se emitió una orden de arresto contra un hombre identificado como Galt, con relación al asesinato de King el 4 de abril en Memphis, Tennessee.

El director del FBI, J. Edgar Hoover dijo que un estudio sistemático de las huellas digitales latentes descubiertas en el caso, comparándolas con las huellas de más de 53,000 personas condujo a determinar "que Galt y Ray son idénticos".

Hoover dijo que Ray, de 40 años, fue reportado desaparecido de la penitenciaría estatal de Missouri en Jefferson City el 23 de abril de 1967. Estaba cumpliendo una sentencia de 20 años por robo armado.

Bajo el nombre de Galt, Ray ha sido objeto de una búsqueda por todo el país que se extendió también hasta Méjico. Hoover explicó que el historial de arresto de Ray data del 1949. Antes de su acusación de 1960 en St. Louis, Ray fue convicto por robo en Los Angeles, en 1949, robo armado en Chicago en 1952, y por falsificación de giros postales en Missouri en 1955.

El FBI añadió que en septiembre de 1966, mientras cumplía su sentencia en la penitenciaría estatal de Missouri, Ray fue puesto por un tiempo en la celda de seguridad máxima en Fulton.

Cumplió sentencia también en la cárcel de condado de Los Angeles en 1949; las prisiones estatales en Joliet y Pontiac, Illinois, desde 1952 hasta 1954; y la penitenciaría federal en Leavenworth, Kansas, desde 1955 hasta 1958.

Se añadió que Ray sirvió en el Ejército desde febrero de 1946 hasta diciembre de 1948, cuando recibió un licenciamiento general por causa de inhabilidad y falta de adaptabilidad al servicio militar.

Durante su tiempo en el Ejército, Ray recibió una sentencia de tres meses con trabajos fuertes por estar borracho y romper un arresto.

Ray fue descrito como varón de la raza blanca, de aproximadamente 5 pies 10 pulgadas de estatura, entre 163 y 174 libras de peso, de ojos azules y pelo castaño. El FBI informó que tiene una pequeña cicatriz en el centro de su frente y una en la palma de su mano derecha.

El FBI informó que Ray alegó haber nacido el 10 de marzo de 1928 en Illinois; que asistió hasta el décimo grado escolar en Alton, Illinois.

El FBI dio a publicidad dos fotografías, de frente y costado, de Ray, aparentemente tomadas en la prisión de Misuri, donde estuvo recluso desde 1960, año en que, según el anuncio se tomó la foto.

La fotografía ha sido identificada como correspondiente a James Earl Ray, también conocido como Eric Starvo Galt, Harvey Lowmyer, John Willard, James McBride, James Walton, W. C. Herron y James O'Conner.

John Willard fue el nombre utilizado por el hombre que se alojó en el hotel desde el cual se hizo el disparo que mató al doctor Martin Luther King.

Hoover explicó que Ray tiene antecedentes que datan de 1949, antes de ser enviado a prisión en 1960 en San Luis, Ray fue condenado por violación de domicilio en Los Angeles en 1949; asalto a mano armada en Chicago en 1950 y falsificación de giros postales en Misuri, en 1955.

FBI ISSUES NEW PHOTOS OF JAMES RAY: TOTAL NOW 5

WASHINGTON (AP) — The FBI issued today two more photographs of James Earl Ray, who is being sought in connection with the murder of Dr. Martin Luther King Jr.,

An FBI spokesman said one of the latest photos is "considered to be the best possible likeness of Ray."

So far the FBI now has issued five photos of Ray.

The one the FBI considers the best was taken in late January or early February of this year somewhere in California. It shows Ray wearing a dark checked jacket, striped tie and button-down collar shirt. There is a curtain directly in back of him and a lamp nearby.

The FBI would not say where it obtained the picture, or where

precisely it was taken, or by whom.

The other new photo, which the FBI said was taken last November at an undisclosed location in Mexico, shows Ray wearing dark glasses and a light colored shirt open at the collar.

The California photo appears to have been taken without the use of flash, and with side lighting. The Mexico photo appears to have been made with the use of a flash camera.

The two new photos confirm what FBI descriptions say—that his weight has been known to vary widely. The Mexican picture discloses a man with a thin face and pointed chin, much as he appeared in 1960 photos.

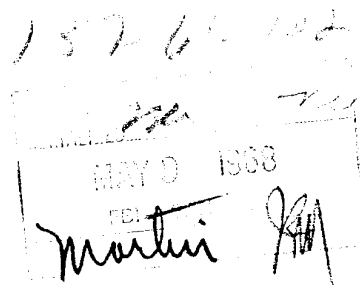

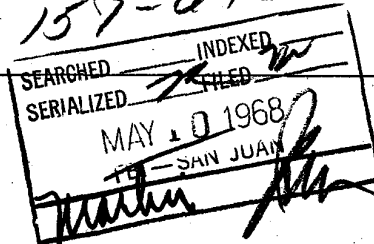

SNIDER, Dependent wife to Air Force Sgt., Ramey Air Force Base, Puerto Rico, *San Juan/H Greene* residence, 313 B-7th Street, in person advised that on 4/25/68, she was at the Island of Curacao on a vacation tour. Sometime between 12 noon and 1:00 PM, 4/25/68, she was eating lunch in the Lido Restaurant, Curacao, and observed two men in the restaurant, one of whom she says strikingly resembles newspaper photo of JAMES EARL RAY.

She said this individual who resembled subject was seated, with his back to the wall, at the second table on the right from the entrance into the restaurant section of the Lido.

~~Mr.~~ SNIDER said that because she of the Negro race she contemplated in her mind for the past several days that she might have been prejudiced in thinking this individual resembled RAY or that he actually did. She is of the opinion after making honest memory study, that unknown person in the restaurant could very well have been the subject.

Unknown person was overheard to order something to eat, the last part of his order consisting of "rice and iced tea". Unknown person has a very definite Southern accent.

This person was wearing slacks, color unknown, and a rumpled white shirt. He appeared to be about 37 years of age, approximately 6 feet, 180 - 185 pounds, sandy colored hair, very dry, complexion ruddy around the cheeks and nose. The only distinguishing feature of unknown person was a definite cleft in center of chin such as appears in the pictures of subject. Unknown person appeared to have a somewhat fleshier face than that of photo of subject she has observed.

She advised she had not seen this individual prior to this encounter nor since. Mrs. SNIDER stated she could furnish no further detailed info concerning unknown person and as far as she knows this person did not alert the attention of anyone she knows.

In connection with the captioned case there has been speculation that James Earl Ray concocted the alias of Eric Starvo Galt by combining the names of characters from books by Ian Fleming and from a book "Atlas Shrugged" by Ayn Rand. This speculation is based on the fact that in the James Bond books by Ian Fleming there is a character named Ernst Stavro Blofield and in "Atlas Shrugged" there is a character named John Galt, as well as one named Eric Starnes. Ernst Stavro Blofield is a formidable person, John Galt is a "social drop out" and Eric Starnes is described in the book as a "whiner" from a low-class family.

In view of the above and in order that Agents handling this investigation can be alert to the possibility of Ray's utilizing an alias based on characters in Fleming's books, there is set out as an attachment to this airtel a list of various characters in those books for your assistance.

FBI Admite Posibilidad Acusado Asesinato King Huyó Australia

WASHINGTON — (UPI) — Un funcionario de la Embajada de Australia informó ayer que el FBI le pidió al gobierno australiano que realizara una "investigación de rutina" para ver si James Earl Ray, a quien se busca por el asesinato del doctor Martin Luther King, solicitó una visa para viajar a ese país.

El funcionario enfatizó, sin embargo, que "las autoridades australianas no tiene evidencia de que la persona interesada (Ray) esté en Australia."

Las fuentes estadounidenses también subrayaron la naturaleza rutinaria del pedido. Estos dijeron que sería lógico asumir que pedidos similares tiene o deben de ser hechos a otras naciones en las cuales Ray podría buscar refugio. El FBI no comentó sobre las declaraciones del funcionario de la Embajada.

Ray, también conocido por el alias de Eric Starvo Galt, ha sido objeto de una búsqueda incesante desde que el doctor King fue muerto mientras estaba parado en el balcón de un hotel en Memphis, Tenesí.

Ray, quien ha sido acusado de asesinato por las autoridades de Memphis, fue añadido a la lista de los más buscados por el FBI después de una investigación de más de 53,000 hue-

llas digitales que dieron a conocer que las huellas encontradas en el baño de una casa de hospedajes eran idénticas a las del hombre buscado. Este también encara una acusación federal por conspiración.

Ray se escapó de una penitenciaría estatal en Missouri en abril del 1967, mientras cumplía una sentencia de 20 años por robo armado y robo de autos.

El funcionario de la Embajada de Australia dijo:

"A pedido del FBI, las autoridades australianas están realizando una investigación de rutina para ver si ha habido una solicitud de visa para Australia por la persona acusada del asesinato del doctor Martin Luther King, hijo."
