

Dept. Constable Dunkin advised SA BROOKE D. ROBERTS that he had received a call from ALBERT POWELL, 203 Ave. I, S.E. Winter Haven, Fla. who operates a Sinclair Station on Snively Ave. in Eliose, Fla., who advised that he had seen an individual; in a 1959 or 1960 white Chevrolet, with an Alabama license tag; who resembled the sketch in the newspapers of the killer of MARTIN LUTHER KING.

Mr POWELL WAS CONTACTED by SA ROBERTS and advised that on the afternoon of April 6, 1968 a white male ;30 to 35 years of age, 6 feet, 160 to 170 lbs, thick lips, long sharp nose, curly hair cut close to the head and parted in the middle, dark complected wearing a dark shirt and large sunglasses; drove into his station in a white 59 or 60 Chevrolet with an Alabama tag and asked if he could get his car washed. POWELL advised that he advised the man that he did not wash cars on weekends and he left heading in the direction from which he arrived, which was toward the intersection of Snively Blvd. and US highway 17. He stated that the individual acted very nervous during the period of five minutes that he was in the station.

Per instructions of Supervision # 4 the above information was furnished to HORACE NANCE dispatcher Polk Co., Sheriff's Office who advised that this information would be given by radio to all Polk Co. Police Depts. With the instructions that if the car was observed the FBI would be immediately advised however the driver would not be detained or arrested and that the FBI only wanted the location where the vehicle was observed.


