Shortly after receipt of retel, I received a telephone call from RICHARD COX, WESH TV, Orlando (phone 644-8898). He advised he had received a wire story concerning RAY and had also received a photograph of RAY and that a visual comparison of the photographs of RAY and GALT would indicate that both persons are not identical. He wanted to know which photograph the station should use. I told him I would call him back.

I then contacted CLEM MC GOWAN, Chief of the Civil Rights Section, SOG, and he referred me to Inspector in Charge, TOM BISHOP, Crime Records Division. BISHOP advised that both photos were of the same individual, however, the photo of RAY was taken in 1960 and his appearance and looks have changed considerably in the past eight years and the 1968 photo of GALT is the photo that should be shown inasmuch as this is the current likeness of subject RAY. He said there would be no objection if the TV station wanted to show both photographs, but it would not be desirous to show only the 1960 photo.

I then advised Mr. COX of the above and he said that they would show the $1968\ \mathrm{photo}$.
